<sup>1.</sup> A non-refundable Enrollment Fee of \$75 and \$100 Material Fee is due annually at the time of enrollment. 2. The Toddler community has a \$30 monthly snack fee that is figured into tuition costs. 3. There are no reductions in tuition or make-up days for: Non-attendance, holidays/inclement weather closures, and/or scheduled closures. 4. We offer a tiered discount for families AND optional parent job tuition adjustments. ALL discounts combined will not exceed 50% of tuition. 5. Tuition is due on the 15th of each month and beginning in July and is 10 monthly payments.



## **Family Discount**

#### **Tiered Family Discount**

Family discounts are available to single payers who have two or more children attending Wildwood Montessori School. This discount is applied to the tuition fees of the child with the lowest tuition rate. Discount structure is as follows:

-First Child: Full Tuition Fees

-Second Child: 10% discount on tuition fees

-Third Child: 15% discount on tuition fees

-Fourth Child and beyond: 20% discount on tuition fees

#### Appointed and Volunteer

In an effort to strengthen our school-family partnership, parents have the option to apply their skill-sets and time to specific school jobs that we would otherwise need to outsource.
