

Privacy Policy

Mukti Monin Bandi("we" or "us") is committed to managing personal information lawfully and handling it with the highest standards of responsibility. We provide the following information to help you understand how we collect, use and disclose personal information, and how you can exercise choices and rights regarding your personal information when using Idle Brick Explosion(the "App" or "Service").

Updates

The latest version of this Privacy Policy applies to our processing of your information. We may revise this Privacy Policy from time to time as needed. If we revise this Privacy Policy, we will post the revised Privacy Policy on this website.

Information Collected

We may collect account information for your transactions, such as payment method and payment account.

We also automatically collect certain information about your interactions with the App, which may include information about your device (model, manufacturer, language, IDFA, IDFA, GAID, screen resolution, etc.), information about your network connection (mac address, network type), and other information about your interactions with the App.

Sharing of Information

We may work with certain service providers to achieve the purposes described in this Policy. Examples of these services include analyzing data, IT and related services, and providing customer support and security fraud detection services. These agents and service providers may have access to your personal information when performing services for us and are contractually obligated to maintain the confidentiality and security of your personal information. We also require them to use information only on our behalf and for purposes consistent with this Policy.

Use of Information

- 1.We process your information in connection with providing the App and to run, maintain and develop the App.
- 2.We may process personal information for the purpose of contacting you regarding the App and to inform you of changes in the App as well as to market the App.
- 3.We may process information regarding the use of the App or Services to improve the quality of the App e.g., by analyzing any trends in the use of the App or Service. When possible, we will do this using only aggregated information.
- 4.We process certain information to comply with our legal obligations. We may also process information for responding to legal claims in similar situations.

Protection of Minors

We do not knowingly collect personal information about children under the age of 13 (in EEA is under the age of 16). If a parent or guardian becomes aware that his or her child has provided us with information without their consent, he or she should promptly contact us and we take reasonable steps to ensure that such information is deleted.

Privacy rights

You have the following rights and choices regarding your use of the App and how we process your personal information:

- 1.The right to confirm whether your personal information is being processed and to know what personal information we have about you.
- 2.The right to correct any inaccurate personal information about you.
- 3.The right to delete the personal information we collected from you.
- 4.In certain circumstances required by law, the right to request that we stop processing your personal information.
- 5.You can withdraw your authorization for us to process your personal information at any time (but it will not affect the legality of our processing of your personal information before your withdrawal).

Storage of information

We will process your information for the time necessary to achieve the stated purposes and, where applicable, to the extent of your consent. We will then delete your information without undue delay. We will permanently destroy any personal information held in an electronic format to render it irrecoverable and unrecoverable. However, as stated above, we are obliged to retain certain users' personal information as required by applicable law.

Security of Information

The security of your information is important to us. We use appropriate physical, management, and technical measures to protect your information from unauthorized access, disclosure, use, modification, damage, or loss. For example, we use cryptographic technologies for data confidentiality, protection mechanisms to prevent attacks, and access control mechanisms to permit only authorized access to your information. We also provide training on security and privacy protection for employees to raise their awareness of personal information protection. We are committed to protecting your information; however, please note that no security measure is perfect.
