What is the Beautiful Day Supermarket-Sweep Raffle?

The Super-Market-Sweep Raffle raises funds to support Beautiful Day's two initiatives Kindred Community and the Birthday program. The funding raised will continue the efforts to support and promote the Beautiful Day Foundation's mission. Our mission is to serve our community by loving on our neighbors, encouraging their potential, and cultivating a spirit of service. This funding will go directly back to the two initiatives of Beautiful Day. One is to provide free birthday celebrations to the students enrolled at the schools who are partnered with the Beautiful Day Foundation, and two is to provide a free dinner/event for widows who attend Kindred Community of Stephens County.

The winners of the Raffle will receive a one-of-a-kind opportunity to participate in a "timed" supermarket race to fill their basket with food and non-alcoholic beverages up to \$1,000.

Who can donate in exchange for a raffle ticket?

Any person 18 years of age or older who is eligible may enter and win the Raffle. No Beautiful Day Board members or employees will be allowed to participate in the raffle.

When does the Raffle start and when does it end?

Entries will be accepted starting on June 20th, 2024, and ending Thursday, July 11th, 2024 at 4:00 p.m. Drawing will be viewable via facebook live July 12th

What are my odds of winning the Raffle?

The odds of winning the Prize depend on the number of eligible entries received.

How is the Winning Ticket Selected?

The winner of the Raffle will be selected in a random drawing under the supervision of a Board member of the Beautiful Day Foundation on July 12th, 2024 Live on the official Beautiful Day Foundation Facebook page.

Do I have to be present to win?

No. If you win and are not present, you will be notified by phone and/or email based on the contact information provided at the time of submission of your entry. The winning name(s) will also be posted on Beautiful Day's social media shortly after the drawing.

Are Raffle tickets tax-deductible?

No. The IRS does not allow raffle tickets to be a tax-deductible contribution.

Are there legal rules and regulations and Is this Raffle Legal?

Yes. Beautiful Day is a designated non-profit organization pursuant to 25 U.S.C. § 501(c)(3) and is a qualified organization pursuant to Oklahoma's lottery laws, 21 O.S. § 1051, et. seq., and is legally allowed to conduct this charitable raffle.

How much do the raffle tickets cost?

A single entry for the Raffle will be issued in exchange for a \$20 voluntary donation or 6 tickets for \$100 voluntary donation. There is no limit to how many tickets an entrant may purchase.

How do I obtain a raffle ticket? There is 3 ways to obtain a ticket.

Beautiful Day has received several requests to provide an online option for ticket purchases for individuals who do not use Venmo. Here is the webaddress to access the Supermarket Sweeps Raffle Fundraising page:

For online entries, a team member of Beautiful Day will remove a stub that has a corresponding number on a physical ticket and send a photo text message to the entrant providing the corresponding number on the purchased ticket stub. If the contributor does not denote a chapter to support, the funds will be directed to the highest need area, as the discretion of the Beautiful Day Board of Directors.

- In-Person-

In-person raffle ticket be obtained 2 ways,

1. At any Golden Cart Location or 2. From any Beautiful Day volunteer.

For in-person entries, a member of Beautiful Day will immediately remove a stub that has a corresponding number to the ticket that will be provided to the entrant. Each ticket will be individually numbered. Each stub will be stored under supervision until the random drawing when the winner is selected.
