It is enacted as follows:

CMHoC Meta Constitution

1 The Meta Constitution is amended by striking section 9 and replacing it with the following:

Presentation of Petitions

- **9** Any member of the simulation may present a meta petition on r/CMHoCMeta or on a Discord channel designated for the purposes of meta on the CMHoC Discord server.
 - (a) Political Parties may not officially recommend that members sign, or refuse to sign, such a petition.
 - (b) Political parties may not influence the status of meta petitions in any capacity.
 - (c) The Executive unanimously may reject any petition they deem harmful for the simulation or biased against any members or political groups.

2 The Meta Constitution is amended by striking section 10 and replacing it with the following:

Seconders

10 Any petition that has been seconded by at least 5 other members or been seconded by a member of the Executive on r/CMHoCMeta or on a Discord channel designated for the purposes of meta on the CMHoC Discord server shall be deemed valid.

3 The Meta Constitution is amended by striking section 16 and replacing it with the following:

Nominations and Q&A

16 When a Meta Election is called for any office,

- (a) there shall be a post made on r/CMHoCMeta and on a Discord channel designated for the purposes of petitions on the CMHoC Discord server, and there shall be a 72-hour period for prospective candidates to announce their candidacy.
- **(b)** at the conclusion of the 72-hour period, any prospective candidates with at least two other members seconding their prospective candidacy shall be deemed Candidates for the Meta Election.
- (c) Upon the confirmation of candidates under paragraph (b), there shall be a post made on r/CMHoCMeta and on a Discord channel designated for the purposes of meta on the CMHoC Discord server providing a 72-hour period for any member to pose questions to the Candidates for the Meta Election, either individually or as a group.

4 The Meta Constitution is amended by striking section 25 and replacing it with the following:

Nominations and Q&A

25 An officeholder loses their office when.

- (a) they are pinged in a Reddit or Discord post alleging their inactivity and do not reply to that post within two weeks:
- **(b)** their Reddit and Discord accounts are deleted and there is no contact between the officeholder and any member of the Executive for one week;
- (c) they resign;
- (d) a petition calling for their removal from office passes; or
- (e) the Executive decides unanimously to remove them from their office.

5 The Meta Constitution is amended by striking section 36 and replacing it with the following:

Intention of Resignation

36 A Moderator may, in writing on r/CMHoCMeta or in a Discord channel designated for the purposes of meta, declare an intention to resign their place, which will automatically trigger a meta election, the outgoing moderator will vacate office automatically upon the completion of the meta-election, and the incoming moderator will automatically assume the office.

CMHoC Parliament Rules

6 The CMHoC Parliament Rules are amended by striking the definition of "the bells to be rung" in section 1 and replacing it with the following:

"the bells to be rung" means pinging all Members of Parliament, or Members of a Provincial legislature, on discord.

7 The CMHoC Parliament Rules are amended by striking section 23 and replacing it with the following:

Consideration

- 23 At least once every two weeks during a parliamentary session, the Electoral Moderator must conduct an investigation to determine if any MP is in breach of one or more of the requirements, if they believe any MP is in breach, they must begin activity review consideration against that MP.
 - (a) Activity review consideration is to be completed in a public thread on r/CMHoCMeta and in a Discord channel designated for the purposes of meta where the Electoral Moderator or the Parliamentarian shall be invited to appear to give submissions.
 - **(b)** The Electoral Moderator, subject to other Meta Rules, may request any information that is relevant, and that the Electoral Moderator feels will assist them in providing a determination.`

CMHoC Election Rules

8 The CMHoC Election Rules are amended by striking section 1 and replacing it with the following:

Political Parties

1 A political party, or party, is a group of members of the simulation that may run candidates on a single list or ticket during elections, has recognition with a flair on the subreddit and discord and is listed as a full party on the "Registration" thread and discord party list.

9 The CMHoC Election Rules are amended by striking sections 11-12 and replacing them with the following:

Campaigning Subreddit

11 The Electoral Moderator will designate a subreddit and discord channel(s) as the official campaigning forums for the purposes of that general election.

Platforms

12 Each party must submit a platform, manifesto, or other policy document, to the campaigning subreddit or discord channel(s), no later than halfway through the campaigning period or a date otherwise set by the Electoral Moderator.

10 The CMHoC Election Rules are amended by striking sections 19-21 and replacing them with the following:

Advertising on Reddit/Discord

Mass Messaging Dissalowed

19 Members or parties may not send mass direct messages to members of Reddit or Discord, hereinafter referred to as redditors or discorders, with the intention of recruiting them for any purpose directly related to the model, unless they are their friends or associates.

Must Follow Rules of Other Communities

20 Members or parties may not post advertisements on any subreddit or discord server if the rules of the subreddit or discord server disallow the posting of advertisements or otherwise promotional material.

Advertising off Reddit/Disocrd

Advertising on Social Media

21 Members or parties may advertise for specific parties on social media, but may not do so in a disruptive manner, as defined by the Head Moderator.

11 The CMHoC Election Rules are amended by adding the following after section 38(2):

39 (1) In order to register a press organization, a player must make a post on r/CMHOCMeta or a channel designated for the purposes of meta using the designated format for registering a press organization.

Refusal or Removal of Registration

- (2) No Press Organization, as decided by the Electoral Moderator, may be registered or exist within the simulation that,
 - (a) is similar to an existing press organization, in terms of branding;
 - (b) brings the simulation into serious disrepute;
 - (c) is used as a front for offensive mockery or casual bigotry;
 - (d) is toxic, abrasive, or create a hostile environment in general
 - (e) who's applications for registration are incomplete; or
 - (f) for any other similar reason.
- (3) All registered press organizations are entitled to post in r/CMHOCPress and a channel designated for media within the discord server.

12 The CMHoC Election Rules are amended by striking section 40 and replacing it with the following:

Press Debuff

- **40** Any member who publishes marked content on r/CMHoCpress or a discord channel designated for the purposes of press shall be subject to a maximum of 3 posts per day.
- 13 The CMHoC Election Rules are amended by striking section 51 and replacing it with the following:

Deemed to be cutoff

51 August 1, 2024 is deemed to have been a canon cutoff.

14 The CMHoC Election Rules are amended by striking section 56 and replacing it with the following:

Proclaiming a Circuit Breaker

56 If,

- (a) A party leader or designated contact switches their membership to another party, or
- **(b)** 3 or more Members of Parliament switch their membership to another party within a 12 hour period,

The Electoral Moderator may proclaim a 24 Hour "Circuit Breaker" by a post made on r/CMHoCMeta or a discord channel designated for the purpose of meta.
