Abstract

The abstract must be structured according to the following standards: **First**, provide the main research background problems, then explain the urgency and significance of the topic under investigation, and conclude with the research objectives. **Second, include the research methods used**, such as a qualitative approach with a case study method. Briefly explain the data collection and analysis procedures. For instance, "The research method used is a qualitative approach with a case study method. Data were collected through in-depth interviews, field observations, and document analysis." **Third, summarize the research findings and recommendations**. For example, "The results of the study indicate barriers in policy implementation due to a lack of inter-agency coordination. This study recommends enhancing collaboration and developing human resource capacities."

The abstract should be written in English, not exceeding 250 words, using Times New Roman font, size 12 pt, justified alignment. The title "ABSTRACT" should be written in capital letters, bold, size 12 pt, and centered. Following the abstract in Indonesian, include a list of relevant keywords reflecting the article's content, such as "Keywords: Public Policy, Policy Implementation, Local Government, Collaboration, Indonesia."

Keywords: between 3 dd. 5 keywords

A. INTRODUCTION (bold 12 pt)

The introduction includes (1) the background of the study; (2) Previous research or relevant studies; (3) *Novelty of the research*; (4) Research urgency; and (5) Research objectives and contributions (benefits). Citations should be included using in-text citations (Terry, 2019).

B. LITERATURE REVIEW (bold 12 pt)

The literature review discusses theories related to the research topic, providing a logical foundation for developing research hypotheses (if quantitative) and is allowed to use the research conceptual framework.

C. RESEARCH METHODOLOGY (bold 12 pt)

The research methodology includes data and data collection techniques, research models, operational definitions of variables, and data analysis methods. You may use hierarchical numbering if necessary. Tables and figures should be numbered sequentially.

D. RESULT AND DISCUSSION (bold 12 pt)

Present research findings that may include Tables and Figures with sequential numbering. You may separate results and discussions by numbering them 1 and 2.

Table

Tables should be left-aligned. Do not use 'strange' formats. Ensure correct table creation through the Insert|Table menu. Tables must be referred to in the text, such as: '... also note the font used in Table 1' (tables are written with a capital 'T').

Ensure tables are not split across pages unless they exceed one page. If split, rewrite the header row for each column, with the same table number, and title changed to 'Continued.' Table titles do not end with a period. Tables do not need vertical lines..

Figure

Like tables, ensure each figure has a sequential number and title. Make your figures appear professional, and there is no need to frame them..




Figure 1. Figure title, also in sentence case (capitalize the first letter only)

E. CONCLUSION (bold 12 pt)

Summarize findings or conclusions and limitations of your research. Conclusions should not be numbered and must answer the research questions. Consistency triangle (problem-objective-conclusion) is crucial.

REFERENCE (bold 12 pt)

References include a list of readings cited in the main text. The cited references must be within the last 5 (five) years from the year the paper was written. Self-citations are limited to a maximum of 30% of the total number of citations (References). The minimum number of sources in the bibliography is 10 (ten), and it is recommended that at least 80% of the references be primary sources.

References are written using the American Psychological Association (APA) 7th Edition citation style, with Times New Roman font size 12. In-text citations referring to the references are written with the author and year in parentheses (Author, 2014).

Book: [Author-last name and first name initial, either one author or multiple authors. (Publication year). Book title with only the first word capitalized-italicized. Place of publication: Publisher.]

When a book has more than six authors, write the last name and first initial of the first six authors, followed by et al. (followed by a period).
