

Conflict of Interest Timeline

On April 5th, I reviewed my Board packet for an upcoming April 7th Board of Education meeting. I noticed that my husband's company, IP DataSystems had been awarded a contract. Neither he nor I were aware of this pending deal as he is now mostly removed from the day to day sales operations of the company. I immediately contacted Deputy Superintendent Karalee Turner-Little to self-report this conflict of interest. She assured me that she would be in contact with Legal Counsel Mark Blom.

<u>April 7th Bids and Contracts PC-53</u>: Uninterruptible power supply devices and services for e-rate funding Company: IP DataSystems, Inc, Amount \$427,369.



On April 6th, the BOE received emails from both Doug Pindell and Kathy Hanks, indicating that PC-53 was being removed from the agenda to allow time to investigate potential conflict of interest. I learned via later telephone conversations with both legal counsel Mark Blom and Mr. Pindell that recusing myself would not satisfy legal and ethical standards and the decision was made to permanently pull the item from the agenda. I believed at the time that this would be the end of it.



April 8th: News media reached out to me for comment regarding a tip from concerned community member they had received:

"Hey did you happen to see the HoCo BOE agenda yesterday? They were going to procure pandemic-critical technology items from a company that is owned and operated by a BOE member's spouse. That type of conflict of interest would have gone through without notice because of the rush for technology needs right now."

I clarified with the reporter that the conflict of interest was self reported and that it was pulled prior to coming before the BOE. I sent a message to the concerned community member to share this same information and sent an email to my colleagues detailing what had transpired. I once again believed this would be the end of it.

April 14th: MPIA #2020-372: a request for a list of all contracts bid on by IP Datasystems, including contract details and withdrawn contracts. A simple boarddocs search shows that there has been only one proposed contract between HCPSS and IPDataystems, the one that was reported by me and withdrawn.

April 24th: The following letter was shared with me:

I had hoped that this issue was long resolved but the goal is clearly not to ensure that the Board of Education is held up to the highest ethical standards. The goal is to smear my reputation without regard for both the truth and the good name of a company that my husband has spent thirteen years building from the ground up.

It is ironic that an ethics complaint is being threatened against me for being ethical.

This was revealed on Facebook and we have a responsibility to understand it further.

I expect that the results for these requests will be posted on the Howard County Public School System MPIA website.

Additionally, I am using this letter as a way to serve as an **official complaint that I am now filing with the HCPSS Ethics Panel**. Ms. Cutroneo has used the prestige of her office for personal gain and this has created a conflict of interest. Thank you.
