

Emergency Justice Group Amendment

Gov officials and Legislators allowed version

Due to lack of justice candidates and therefore a non-working court. I suggest that in times of need, a restricted Emergency Court shall replace the Supreme Court. People can sign up as Emergency Justices who will be publicly voted on. It will disband as soon as the necessary justices are elected. This amendment also makes it possible to recall Protectors.

Section 3: The Emergency Court

- A. There will exist a permanent sign-up for an Emergency Justice Group. Every citizen can join this group.
 - a. Members of this group is referred to as 'EJCs', Emergency Justice Candidates.
- B. Should the Supreme Court have fewer than 3 justices, the Emergency Justices along with the justices and jurors shall form a emergency court. This court holds the same power as the Supreme Court and operates identically. The Emergency Justices gain every right as ordinary justices would, except voting rights are 1,5-1 for every juror's vote(rounded up if 1,5 total Emergency Justice vote score, rounded down if above 3) instead of the usual Justice 2-1 ratio.
- C. To select members of this court, you take every elected justice, juror and add up to the intended supreme court justice size from the pool of the EJCs.
 - a. All the EJCs shall be voted on in a public referendum which will select one or more as required to fill the emergency court.
 - i. The ones elected shall be referred to as 'Emergency Justices'.
- D. If the EJCs is a moderator, they cannot become a member of the court.

- E. If the EJC is a legislator or government official, they shall be exempted from dual mandate restrictions and be able to serve in the court.
- F. If 3 ordinary justices are elected after the existence of the emergency court, it shall immediately be disbanded and the regular court assume power.
- G. A member of the court must recuse themselves if they are the topic of the case or vote.
 - a. Should an elected justice or 3/5 of the jurors suspect lack of impartiality of an Emergency Justice in a case, the Emergency Justice may be barred from the case in question and temporarily replaced by another Emergency Justice until the case is over.
- H. Should an Emergency Justice be considered incompetent, 1 elected regular justice and 3 of the jurors or 5/5 of the jurors can recall the Emergency Justice.
- I. Emergency Justices can not replace justices on the International Court.
- J. The Moderation council can start a justice election at any time if it has been 1 week since the last justice election.
- K. The citizens of DemoHOI4 can vote to recall and ban a Emergency Justice from the court for 1 week with a 50%-vote.

Section 2: Protectors

- A. This Constitution hereby creates the office of Protector. A Protector keeps their own separate copies of this Constitution.
- B. A Protector can be recalled, 10% of all citizens must sign a petition to remove them, which will then be put to a 65%-majority public referendum.
 - a. If the recall passes, a new Protector shall be elected in the next planned election.
 - b. This rule cannot be revoked or changed by a Protector amendment.
- C. The five Protectors shall be /u/Asgore_Dreemurr (OboDerf), /u/LightGalaxy (Alex), /u/RB33z (RB33), /u/Revan-117 (Revan) and /u/pitbox46 (TheRealBruceLee).
