PUBLIC COMMENT

Members of the public shall have an opportunity, under Public Comment, to address the Township Board for no more than 3(three) minutes on any matter.

Members of the public may also address a specific agenda item for up to 3(three) minutes at the time the item is taken up by the board. The board may suspend the time limitation when warranted. Board discussion will precede public comment on specific agenda items. Prior to calling for the question, the Supervisor shall ask any member of the public who wishes to speak on the agenda item to be recognized. When all persons who wish to address that agenda item have been heard, the supervisor shall announce that public comment on the agenda item is concluded, and no further public comment shall be entertained.

Written comments will be limited to 1(one) page per person to be read. Only 1(one) written comment per person will be read

Written comments more than one page will be summarized and the entire written document will be made a part of the minutes.
