They collect fruits and medicinal plants, grow traditional crops – such as manioc, beans and pumpkins – and drive cattle over natural grasslands. When wildlife was still abundant and rivers clean, they could hunt and fish. Some of these communities have existed for over 200 years and started as an assortment of fugitive enslaved people, peasants and anyone who wanted or needed to escape mainstream society. The communities identified as fundo e fecho de pasto in the municipality of Correntina, further south of Formosa do Rio Preto, have a similar way of life. In the community of Capão do Modesto around 80 families try to live as their ancestors did. Houses are not connected to the electricity grid. Spotty internet connection is only available via satellite.

- [47] Establishing legal reserves in areas far away from the original farm undermines the ecological benefits of protecting an area, particularly in heterogeneous biomes like the Cerrado made up of a patchwork of different ecosystems. It can encourage high contrast between basins, with some areas heavily deplete and others with a high number of legal reserves, creating biologically poor landscapes. Residents at Capão do Modesto told Earthsight they suspect the couple were used as a front for a land grabbing scheme. This is supported by the suspiciously low prices farmers paid for the land. In December 2022, Bahia's attorney general launched a lawsuit against the agribusinesses that own properties at Capão do Modesto, including the Horita Group, referring to it as "one of the most serious land grabbing cases in Bahia." [90] According to Our World in Data, approximately 1.7kg of meat is produced from one chicken and 3.3kg of animal feed is needed to produce 1kg of chicken meat. This entails that 5.6kg of animal feed is needed to produce the entire 1.7kg of meat available from one chicken, of which 30% is soy, or 1.68 kg. This means that the average soy exported by Bunge from Bahia to the EU per year between 2021 and 2023 was enough for the animal feed for over 214 million chickens. Each chicken produces two chicken thighs.
