The Board of Trustees and Senior Leadership Team had a candid conversation with MLA, Jason Nixon about his party's policies as it pertains to rural education in Alberta. The discussion included many topics related to urban vs rural funding, new transportation regulations affecting school busing, government spending and possible efficiencies, budgets and the new curriculum including First Nations and Indigenous content.

- Discuss Priorities for Three Year Capital Plan
 - Corridor schools is our first priority, modernization of Condor for grades K-6, Replacement of Leslieville for grades 7-12, David Thompson High School lagoon remediation
 - HW Pickup slab movement has been detected and we are continuing to see movement; two different structural teams are monitoring this.
 - Consolidating Breton schools, potentially closing Breton Elementary School and reconfigure Breton High School to a K-12 school, this will also improve our utilization rates
- PSBAA Award Nominations
 - No nominations will be brought forward this year
- Joint Meeting Updates
 - All of our partners are committed to meeting, dates have been set in March
- ASBA Bylaw Amendments Submission deadline March 4
 - No Bylaw Amendments will be recommended
- "Together for Students" public meetings
 - The separate meetings will be cancelled, and the presentation will occur at the next School Council Umbrella meeting
- WRSD Advocacy Plan / Key Messages for Rural Caucus
- Meeting with Drayton Valley Town Council
 - Drayton Valley Trustees met with the mayor of Drayton Valley at their economic development committee meeting of the whole. The joint use planning agreement, Eldorado school, Eldorado playground, the zero tuition plan, and possible use of Frank Maddock labs, was all discussed
- Parkland Busing Issue
 - The cancellation of the transportation agreement by Parkland School Division is still a concern for everyone affected. Letters were already sent to Parkland from the Superintendent and the Board, and we will continue to look for solutions.
- HCC Injury Prevention Committee
 - They are planning to do a mock disaster to test emergency services for all community partners, and on Tuesday, March 19 there will be a meeting - our Health and Safety Operations Coordinator will attend.
