

## **Podcast Guest Release Agreement**

This Guest Release Agreement ("Agreement") is entered into by and between the undersigned individual ("Guest") and She. Fully Alive. LLC, a Minnesota limited liability company ("Producer"), with respect to Guest's appearance on Producer's Podcast ("Podcast").

### 1. Grant of Rights

Guest hereby grants the Producer the irrevocable, transferable, non-exclusive, and royalty-free right and license to:

- Record, edit, use, reproduce, distribute, and publicly display Guest's interview, in full or in limited segments, as well as, and any and all materials (the "Materials") submitted by Guest to Producer (e.g., biography, image, voice, likeness, statements, or performance) in any media, know known or hereafter developed, including but not limited to audio, video, written, and digital formats;
- Use the Podcast or any portion thereof, and/or the Materials, in connection with the promotion, distribution, publication, and monetization (if applicable) of the Podcast, in whole or in part, across any media platform now known or hereafter developed; and
- Use Guest's name, voice, likeness, and biography for the purpose of promoting Guest's appearance on the Podcast.

#### 2. Compensation

Guest acknowledges that participation in the Podcast is on a voluntary basis and that no compensation (financial or otherwise) is promised or expected in return.

### 3. Ownership

All rights, title, and interest in the recorded interview and final produced content in connection with the Podcast shall be owned solely by the Producer.

# 4. Guest Representations

Guest affirms that:

- Guest is the sole owner of the Materials submitted to Producer and has full legal rights and authority to grant the license set forth herein;
- Guest's participation does not, and will not, infringe on any third-party rights;
- Guest understands the Podcast may include editing and may be shared publicly; and
- Guest understands and agrees that Guest will not have any right to inspect or approve the Podcast or any variation or modification of the Podcast and hereby waives any such right.



## 5. Release and Indemnity

Guest hereby releases, discharges, and agrees to hold harmless Producer and its officers, members, managers, employees, volunteers, contractors, vendors, affiliates, agents, and assigns from any and all claims, demands, or causes of action arising out of or in connection with, directly or indirectly, the use of the Podcast, interview with Producer related to the Podcase, or the Materials, including but not limited to claims for libel, slander, defamation, invasion of privacy, compensation, or infringement of rights.

### 6. Entire Agreement

This Agreement represents the entire understanding between the parties and supersedes all prior agreements. This Agreement shall be governed by and construed pursuant to the laws of the State of Minnesota, and any action to enforce this Agreement shall be held in the District Court of Minnesota, City of Minneapolis, and Guest hereby acknowledges the applicable law and consents to such governing law, jurisdiction and venue.

## 7. Electronic Signatures and Storage; Counterparts

This Agreement may be signed and preserved electronically. This Agreement may also be executed in multiple counterparts.

By signing below, Guest confirms that Guest: (i) has read this Agreement, (ii) understands the terms contained in this Agreement, (iii) has had the opportunity to review this Agreement with legal counsel; and (iv) agrees to be bound by the terms contained in this Agreement.
