Definitions

For the purposes of this privacy policy:

- Account means a unique account created for you to access our service or parts of our service.
- Company (referred to as either "the company", "we", "us" or "our" in this agreement) refers to [B.NO.

Collection & Usage Of Your Personal Data

User Consent

By using our services, including but not limited to registering on our website, participating in a contest or promotion, communicating with us via our websites or through social media platforms, you agree to provide consent to our collection, use and sharing of your personal information as described in this Policy.

Types Of Data Collected:

Personal Data

While using our service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to:

- Email address
- First name and last name
- Phone number
- Address, state, province, zip/postal code, city
- Usage data

Usage Data

Usage data is collected automatically when using the service.

Usage data may include information such as your device's internet protocol address (e.g. IP address), browser type, browser version, the pages of our service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

When you access the service by or through a mobile device, we may collect certain information automatically, including, but not limited to, the type of mobile device you use, your mobile device unique id, the IP address of your mobile device, your mobile operating system, the type of mobile internet browser you use, and other diagnostic data.

We may also collect information that your browser sends whenever you visit our service or when you access the service by or through a mobile device.

Cookies

A cookie is a small file placed on your device. We use essential & non-essential cookies and similar tracking technologies to measure communication effectiveness, analyze & improve user experience, track user trends & store user preferences.

These cookies identify if users have accepted the use of cookies on the website & allow us to remember choices you make when you use the website, such as remembering your login details or language preference.

The purpose of these cookies is to provide you with a more personalized experience and to avoid you having to re-enter your preferences every time you use the website.

If you do accept a "cookie", you thereby agree to our use of any personal information collected by us using that cookie.

Use Of Your Personal Data

We only use your personal data within the limits authorized by the laws and regulations.

We use your personal data in the following manner:

We use the data for email, call, SMS (or other equivalent forms of communication) to update or inform you related to the functionalities, products and/or services, and to provide you with news, special offers and general information about other services which we offer. Including but not limited to information about a service/product that you've purchased or have enquired about, unless you have opted out to receive such information.

Data We Share:

- We may disclose personal information if required to do so by law or in the good faith belief that such
 disclosure is reasonably necessary to respond to subpoenas, court orders, or other legal process or to
 protect the rights, property or personal safety of our users or the general public.
- We may share your personal information in connection with, or during negotiations of, any merger, sale of company assets, financing, or acquisition of all or a portion of our business to another company.
- We may also share your information with our affiliates. In this case, they will require to follow this
 privacy policy.
- We may disclose your personal information for any other purpose with your consent.

How Long Do We Keep Your Data For?

The company will retain your personal data only for as long as it is absolutely necessary for the purposes set out in this privacy policy.

This is determined on a case by case basis and is required by local applicable laws. Generally, we retain the information as long as you maintain an account with us and till the time you continue to access and use the website/m-web.

Why we retain certain data?

- We may retain some of your personal information as necessary for business interests e.g. fraud detection, enhancing safety etc.
- We may retain your information to comply with certain legal obligations.
- Any review shared by you may continue to be publicly visible on the website, even after your account
 is cancelled. However, attribution of such information to you will be removed.
