



FASTBridge Registration for 2019-20 Now Includes Option for Grades 7 and 8

This year Iowa's AEA's again will be subsidizing the costs for schools to upgrade their DE-provided FAST subscriptions to include math and behavior assessments for the 2019-20 school year, and are expanding the potential grades available for schools.**

This year schools will have the option to use the expanded assessment suite in math and behavior for K-6, and will have the additional option to include grades 7 & 8. This option is available both to schools that purchased the expanded assessment suite in 2018-19 and those that want to use for the first time in 2019-20.

Pricing

Subscriptions are based on a per student annual cost, and your AEA and the statewide AEA system have committed to covering 50 percent of the cost for each K-8 student in Iowa.

Additional Notes on Grade Level Inclusion

- For any participating school, the upgrade must include the entire population of the K-6 students in that school. ([See examples at the end of this communication.](#))
- Any school expanding the assessment suite in math and behavior to include grades 7 and 8 must purchase the assessment suite for at least **one** grade level.
- There is an additional option to purchase FAST for grades 9-12. Email sales@fastbridge.org if you want to purchase seats for grades 9-12. This cost isn't subsidized by the AEA system.

Registration

- All new and renewing schools must complete a new registration to commit for the 2019-20 school year.
 - K-6 school that purchased the expanded assessment suite in 2018-19;
 - K-6 school that is purchasing the expanded assessment suite for the first time in 2019-20; and
 - School purchasing the expanded assessment suite for grades 7 & 8.
- Registration will open **April 10** and close **May 10**.
- Please communicate in your district who is going to register the schools in your district so we don't have multiple entries for schools with conflicting enrollment numbers.

Billing

Schools will be billed in September or October based on the school's spring enrollment submitted in the registration form.

Examples to illustrate the requirement of having one building participate in grades K-6

- All K-6 students in the school building.

School district B has two K-6 buildings in the district. FastBridge licensing options include:

- All K-6 students in the school buildings 1 and 2.
- All K-6 students in school building 1, no students in school building 2.
- All K-6 students in school building 2, no students in school building 1.

School district C has two elementary buildings in the district. One building houses grades K-4 and one building houses grades 5 and 6. FastBridge licensing options include:

- All K-4 students in school building 1, all grades 5 and 6 students in school building 2.
- All K-4 students in school building 1, no grades 5 and 6 students in school building 2.



- No K-4 students in school building 2, all grades 5 and 6 students in school building 2.

School district D has one K-8 school building in the district. FastBridge licensing options include:

- All K-6 students in the K-8 school building.
- All K-8 students in the building
- Grades 7 or 8 or grades 7 and 8.

School district E has one K-3 school building, one grades 4 and 5 school building and one grades 6, 7 and 8 school building. The school district wants to license FastBridge for grades 1-4. FastBridge licensing options include:

- All K-3 students in school building 1, all grades 4 and 5 students in building 2 and no students in the grades 6, 7 and 8 building. (All students in grades K-5 must be licensed. Grade 5 students in building two have to be licensed because they are in the same building as the grade 4 students.)

*The AEAs' subsidization of this expanded suite of assessments is based on the understanding that your district/school will allow AEA staff working with your schools to access using a specialist log in. This will allow the AEA to partner with district staff to provide appropriate supports for leaders, teachers and students at the district, school, grade and classroom levels.

** It is important to note the AEA agreement is contingent upon FastBridge Learning Software's continuation of the Service and Professional Services agreement with the Iowa Department of Education for the Early Literacy Implementation.
