## **NNAG** (Scott Jones):

- 1. Statewide release for Wide Area Network  $\underline{\text{RFP 5153}}$  bids will be opened on Friday, 12/18/2015
  - a. Circuits-227 K-12, 30 Higher Ed, 98 UNL, & 3 NE Game & Parks
    - i. Question What is the advice to follow up with the bids? (BK)
      - 1. Scott said that the option to add on a year is an option if bid is more or small amount less.
- 2. Categorization of Participants--vote delayed
  - a. Current Draft
    - i. Still reviewing options with sub-committee working on draft.
- 3. Vote was held to purchase two 120 GB packet shapers at a cost of \$325,000 and a yearly maintenance fee of \$66,000
  - a. Purchase one with existing funds and then pay out the second system through participation fee.
    - i. Impact Should result in no changes to next year's due.
- 4. A discussion about desktop conferencing with NNAG reviewing the possibility of offering this service.
  - a. How many accounts might your ESU and your ESU schools be interested in having if price is not an option?

- 1. NITC Education Council meeting on Wed, 12/16/2015. All recommended Action Items for Digital Education and Network Nebraska were approved by the NITC at their November meeting.
- 2. Tech Panel meeting that Dept of Ed meet before them to share about the dashboard and testing enterprise projects. Want to make sure that the providers are staying on task and on timeline.
  - a. July 1 is hoped to be the date for providers to bring up new Layer 2
    Transport services. For the most part, the 226 K12 circuits will be up on
    time by July 1 and, if not, the provider is charged a penalty of \$500 per day
    per circuit following the first Friday in August.
  - b. Second RFP will be coming out for the statewide backbone in January/February.
