We also need a council that will advocate publically for this at the state level and work with our state legislatures to ensure bills to prevent censorship are passed.

Ultimately, the creation of more low threshold housing with behavioral health support is necessary to make more upstream solutions to prevent unsheltered houseless experiences.

1. Do you believe in the right to read, for all people, and would you defend that right against attempts to remove books from libraries in Worcester?

Yes absolutely. The idea of removing books from the library is censorship at its worst, and it's more evidence of a small group of people trying to control a large group of people by influencing ideas on what they believe to be appropriate. Regardless of what people think about issues and topics covered in the books, I support freedom of thought, freedom of information, freedom of expression, and freedom of speech.

2. What role do you see for the Worcester City Council in ensuring the rights of all residents to discover, access, and engage with information? What actions would you take as an elected city council member to fulfill this role?

I'll preface this by saying that I do think it becomes difficult for Worcester City Council to play a large role in this battle simply because the legislation is coming from the state level. I would caution against guaranteeing too much from my perspective as to what the City Council can do to ensure the rights of all residents to discover, access, and engage with information. However, some ideas of how I and my colleagues can help to at least be influencers:

- Contact our local institutions of higher learning to get involved. Ask them to be an
 advocate for freedom of speech and be a resource for those looking for one of these
 "banned books." Promote the fact that even if the state decides to ban certain books
 from public libraries, work with our colleges and especially the mobile libraries and
 bookmobiles to make sure that some of these titles are available through those
 methods. The colleges need to be more vocal, especially those that offer programs in
 English literature like Clark, Holy Cross, Assumption, and WPI (Humanities & Arts).
- Support the Worcester Public Library in a marketing effort to make residents aware of
 the censorship happening at the state level. This can be done with the help of some of
 the publishing companies. Bookmarks with profiles of banned books, posters and
 displays in the WPL highlighting authors of these banned books, resources online
 directing people to where they can find some of these hard-to-find titles, dialogue
 sessions at WPL or elsewhere with the authors of these books.
- Letters authored by Worcester City Councilors to State Legislators advocating for the freedom of speech and freedom of expression and cautioning against the effects of censorship.

- A series of "Banned Book Report Nights" at local coffee shops or at the Worcester Public Library with coffee provided by local shops. I envision these similar to poetry slams or open mic nights where someone could literally give an old-fashioned book report like you and I used to do in school. Then the "Banned Book Report" could turn into a dialogue with a moderator who could lead the discussion about the theories and issues presented in the book and why some people find those ideas to be controversial. Perhaps invite the author for a Zoom session Q&A. Acoustic Java on Brussels St has a great space for this, by the way.

The library states as its mission:

The Worcester Public Library serves as a gathering place that actively promotes the free exchange of ideas in our democratic society. While I see your point that it serves as a catch-all social service for the most vulnerable among us, I do not think the library is appropriately equipped for, nor does it want to participate in this manner for the residents of the city. Without drastically changing its mission statement, the Worcester Public Library cannot and should not be an active participant in providing free, safe shelter for those in need. The Council needs to focus on improving relationships between residents and safety officers, increasing access points for those looking for help, green-lighting sensible projects that provide low-income housing or shelters in areas close to public transit, and enacting more measures that keep drugs off our streets. If we can do that, then the library shouldn't need any additional resources to serve as a catch-all social service and can put full effort into fulfilling its primary mission. I'm looking forward to hearing more about this from Jason Homer, Executive Director of the Worcester Public Library, when he speaks to us at the North Worcester Business Association on October 18th. I think investing funds into hiring more trained staff dedicated to engaging with vulnerable library patrons to provide information, support, and referrals to appropriate organizations and services will help aid the library in fulfilling its main mission. I want to listen and work with librarians, especially in my district, to learn how I can help support them and the library in fulfilling their mission.

As a city councilor, I would advocate for the city opting into Paid Family Medical Leave. We have an obligation to provide municipal employees with good salaries and comprehensive paid leave that allows them to care for themselves and their families. I believe public libraries are a foundational piece of both our education system and of democracy. This is only true though when we provide the full resources our libraries need and allow, encourage and defend the free flow of ideas.

2. What role do you see for the Worcester City Council in ensuring the rights of all residents to discover, access, and engage with information? What actions would you take as an elected city council member to fulfill this role?

I believe at the top of my responsibility list as a City Councilor is paying attention and asking questions of our Administration to ensure that our public libraries are receiving the resources needed to operate fully. Similarly I know I have been conscious and worried these past few

years as it feels Worcester has become increasingly comfortable with allowing our libraries to become a primary solution to opening heating/cooling stations or caring for Worcester's unhoused.

3. In addition to preparing for challenges, Worcester's librarians are facing increasing strain across the city, in large part because of larger systemic failures that all roll downhill onto the most vulnerable among us. As one of, and often the only, places someone can go inside, safely, for free, in our city (and most cities), the library needs additional resources if it is going to serve as the catch-all social service that it has become. What do you think this council can do to aid in ensuring the library can fulfill its primary mission and what will you do as a councilor to help?

I have been paying very close attention to this issue as mentioned previously. I was glad to know that the plan to hire a social worker at the WPL Main Branch was able to move forward so that some of these burdens were at least not completely falling on librarians' shoulders. I supported your ED's advocacy for the Manager to allocate funds to hire a social worker.

We need to keep elevating the importance of our public libraries while also naming challenges being placed on them as you did here. We cannot and should not continue to choose the WPL as the preferred social service catch-all. We need to continue to challenge that and challenge our administration to take pro-active steps responding to the un-house instead.

And also as part of showing we're paying attention and care. I also just need to squeeze in here, that Worcester needs to provide paid family medical leave for our library staff. I led on this issue and met several time with library staff who reached out to me, and put an order to support this call to action.

1. Do you believe in the right to read, for all people, and would you defend that right against attempts to remove books from libraries in Worcester?

Yes.

While I realize that fully answers the question, a bit more: As a former English teacher, I am ferocious about the right that everyone—and this very much includes children—have to access books and other information. We say that books can be windows or mirrors; in some cases, books and other materials are the only place that people can see themselves or the only place in which they see those not like them.

That is a right that children possess, incidentally, independent of the adults in their lives.

2. What role do you see for the Worcester School Committee in ensuring the rights of students to discover, access, and engage with information? What actions would you take as an elected school committee member to fulfill this role?

The "Instruction" section of our policies leads with <u>a policy on academic freedom</u>, which reads as follows:

The School Committee seeks to educate students in the democratic tradition, to foster recognition of individual freedom and social responsibility, to inspire meaningful awareness of and respect for the Constitution and the Bill of Rights.

Fairness in procedures will be observed both to safeguard the legitimate interests of the schools and to exhibit by appropriate example the basic objectives of a democratic society as set forth in the Constitutions of the United States and the Commonwealth.

I quote that in full because I think understanding our responsibility as a school district is to be educating students to be full members of the functioning of a democratic society—which constitutionally is why we have public education in Massachusetts—is an important framing. It changes how one approaches decision-making as a policy maker if one understands that at the end of this, we need healthy, well-informed, thoughtful, compassionate people who can make good decisions for the future not only of themselves but also of the larger community. More specifically, we are the budget oversight, the policy makers, and the evaluators of the superintendent. In each of those realms, we have responsibilities: how do we budget not only for materials, but for those who work with students on engaging with information? How do our policies allow for, support, and further students accessing information? What barriers might we

be creating? And how is the day to day responsibility of that carried out through the work of the superintendent?

And while I think our current policy on adoption of materials is strong, we might see about strengthening the reconsideration policy.

3. Knowing that there are infrastructure constraints at play, what (next) steps would you take to move Worcester toward having a full-time, professional librarian in every school?

I think librarians need libraries, which is of course the infrastructure constraint. We have the same number of students in seven fewer buildings than we did two decades ago, and so space that was libraries is gone in many schools (and that for the schools that had them). The next thing that needs to be done on that (which I believe will be part of the coming strategic plan) is a comprehensive master plan, that lays out what we're going to do about elementary schools (in particular) in Worcester: where are the students and where are the buildings and

The schools we have built this century were built, in the main, with library space; it's just managing to get that space and then that staff.

what do we do next?

1. Do you believe in the right to read, for all people, and would you defend that right against attempts to remove books from libraries in Worcester?

I do believe in the right to read. I would defend the attempt to remove books from libraries in Worcester. I have raised two daughters who are avid readers and I do not believe in policing what they have chosen to read and I would not anyone else to make that decision for my children.

1. Do you believe in the right to read, for all people, and would you defend that right against attempts to remove books from libraries in Worcester?

The right to read and the access to information are fundamental human rights and they should be available to everyone without exception. It is our responsibility to ensure that every child and their parents have the freedom to choose what is in their best interest. My view on this matter aligns with article 17 of UNICEF's Convention on the Rights of the Child which stipulates, "Children have the right to get information from the Internet, radio, television, newspapers, books and other sources.
