

# COSTXLLO'S TERMS OF SERVICE

Terms of Service last updated on July 17, 2025

---

## BASIC ARTWORK

1. Do not use my artwork in a way where you will benefit financially from it. This includes using my artwork for NFTS, Crypto Currency or up-selling my artwork with a character you are selling.
2. My artwork may not be used in any sort of AI Generator.
3. Do not commission me for pieces I have said I will not make. Things like NSFW, fetishes, extreme gore, self-harm or enabling any abusive or violent scenarios are things I will not draw under any circumstances.
4. When commissioning me, please provide a clear, unshaded reference of your character that can be downloaded as either a JPG or a PNG. Zipped files or files that need to be downloaded through obscure methods will not be accepted.
5. Do not request I mimic someone else's style. If you're commissioning me you're commissioning *my style*. You are allowed to request changes once I send the sketch to confirm, however, be aware that I will not morph my style into someone else's.
6. Do not commission me for a character that doesn't belong to you or without the owner's consent. Along with this, try to avoid commissioning me for characters belonging to television shows, games or movies.
7. My artwork may be used to represent you or your characters in any fashion or setting. Such as at conventions or events or even printed for self-use.
8. If I make personal artwork for you, please do not sell it. For example if I make artwork of a famous pet that does not grant you permission to sell it on merch or items for any reason. **This overrides any stipulation you have in place to allow that.**
9. My artwork is a reflection of the personal time I spent trying to grow my talents, please do not take advantage of my time.

10. Once the sketch is confirmed, the piece is considered **non-refundable** and you may not request a refund.
  11. All transactions may be handled through CashApp or PayPal through invoices. When you're sent the invoice it must be paid before I proceed with the commission!
  12. Bases that are made for public use may be used for adopts or personal character artwork. However you may not resell my blank bases.
  13. When commissioning me it's important to understand you are paying for my time and resources. Please do not beg for cheaper prices or insist they are too low. While I appreciate the concern, I price my art what I think it's worth.
  14. My artwork **may not** be used on any 2D avatar chat site no matter what.
  15. All my artwork and commissions must be charged and paid for in USD (United States Dollar).
  16. You must complete payment within **24 hours** of ordering a commission.
