# **LustBunnyArt's Personal Terms of Service:**

By commissioning me, you are stating that you have read and agreed to these terms.

#### **Basic ToS:**

- -Paypal in USD (other currencies automatically convert)
- -Commissioner can re-upload the image with credits given to myself in the form of a link to my DeviantArt, Twitter, NewGrounds, or Reddit post in which I have posted the original image
- -Artwork cannot be used commercially, or claimed as your own
- -Refunds given based on how much work is done. Read below for clarification.
- -BY ORDERING ANY NSFW/18+ ART YOU ARE AGREEING THAT YOU ARE 18 OR OLDER.

### In Depth ToS:

#### SECTION I. IMAGE COPYRIGHT

I, the artist, retain full and exclusive rights to the original artwork. The client may not claim it as their own or use it for anything other than personal use.

All commissioned artwork is for noncommercial purposes only. Redistribution of my artwork for use in printed merchandise or as promotion of goods, services or social media pages is prohibited.

## **Conditions for Reposting**

The client has my permission to repost the artwork wherever they would like, as long as proper credit is given (a link back to my DeviantArt page, Twitter page, or Reddit page) and my watermark/signature remains intact and unaltered.

## **Prohibited Actions**

Altering my artwork in any way without asking for permission beforehand, with the exception of cropping/resizing the image for an icon or other use.

Tracing or re-purposing parts of the image.

Claiming the artwork as your own.

If these terms are broken, you will be privately blacklisted from commissioning me and reported.

### **SECTION II. PAYMENT INFORMATION**

I accept payment in USD. All USD payments will be taken via Paypal only. You will be given 42 hours to pay after a sketch is shown or a quote is given. Non-payment within 42 hours will result in the commission being canceled.

It is the commissioner's responsibility to tell me when the payment has been sent.

Sometimes a payment will not fall through and I won't know about it. If you fail to tell me that you've sent the payment within 24 hours - and I know I absolutely haven't received the payment - then the 24 hour payment term applies to you.

## **Refund Policy**

If the commission is canceled (by me or the client) before work has started, then the client will receive a full refund.

If the client cancels the commission during progress, the amount refunded will be on a case-by-case basis and up to the artist's discretion. I do have a rough basis for refunds:

Sketch: 90% Line: 50%

Line and Flat Color: 0% (Unless shading was included in the commission, then 15%) No refunds will be given for completed or nearly completed commissions. If I cancel the commission due to my inability to complete it at any state, a full refund will be given.

### **Visual Reference Guidelines**

Clients must provide at least one clear and concise visual reference; please supplement the visual reference with any important information I may need to know to correctly draw the character(s) or scene.

If you link to a gallery of your character's artwork, I cannot promise your design will be done with 100% accuracy. Design interpretations may be inconsistent between images and lessen my ability to accurately draw your character. Shading on potential pieces will also play a part in this.

I will not draw another person's OC without their permission, of course excluding this if it is the client in question's OC, therefore giving me permission. I will not draw another person's OC and

make alterations to their work in an attempt to hide that it is their OC, however, if you want me to take inspiration from their OC such as clothing or hair or body type, I will make exceptions.

## **SECTION IV. WILL/WON'T DRAW**

Below is a general guideline for what I will or will not draw. Please keep my art style in mind when ordering; my forte is adult content, and character art. Things outside my comfort zone might not be as high of quality as something I am used to doing, such as intricate landscapes, animals, detailed objects, etc.

#### **Allowed Content**

- -NSFW
- -SFW
- -BDSM
- -Softcore gore
- -LGBTQ+
- -Aged up characters (Some exceptions)
- -Characters from live action sources, but not their celebrity portrayal (ex: Black Widow, Spiderman etc.)
- -Fetishes (Some Exceptions)
- Anthro / Furry

### **Disallowed Content**

- -Extreme gore
- -Scat/Farting
- -Loli/ Shota/ Cub
- -Explicit Rape
- -Anything with a very clearly underage character
- -Real life people
- -Zoophilia
- -Diapers
- -Sensitive subjects such racist, sexist or homophobic themes

You must be over the age of 18 to commission adult content. Breaking this rule is extremely serious and will result in blacklisting/blocking on all social media, email, and any other means of contact. By ordering anything 18+/NSFW you are agreeing that you are at or above the age of 18.

#### **SECTION V. WORKFLOW PROCESS**

When you make the decision to commission me, please give as much info on the idea you want, you can get as specific as you want and include as many reference pictures/video/ or other media as you want.

#### Estimated date to completion.

I have a job and a personal life, and I am only able to work on your art when I set aside time for it. Depending on how many commissions I have lined up, your art could take a very quick time such as in the next few days to a week, or to a month to complete. This also depends on the amount of work that is going into your commission as well as other projects I am working on at that time that I must complete. If the commission is for a birthday or a holiday gift for someone, I will prioritize getting it to you before that said date, however I cannot make promises, as art takes time.

If for any reason I cannot complete a commission within 90 days of ordering, I will issue a full refund.

After I make the sketch of your idea, I will then require half payment upfront. The rest of the payment will follow through when I complete the image, in which I will send you the full HD render of it, after I receive the rest of the payment.

Revisions and edits. If the commission type includes a sketch approval stage, any major changes or revisions must be made at this stage; this includes any significant changes to a character's pose or body shape, or redrawing parts of the image.

After the sketch has been approved, no major edits or changes will be made. If the commissioner requests additional edits after the approved sketch, a price for the edits may be discussed, the prices for these edits vary depending on what you would like edited.

If I, the artist, make any errors in the character design, accessories, or any other visual elements specified in the provided visual references, I will make these edits at no additional cost.

If you do not want me to post your commission online, you must tell me when you order.
