

TRANSPORTATION AUTHORIZATION, ASSUMPTION OF RISK, AND RELEASE OF LIABILITY

REQUIRED FOR STUDENTS USING TRANSPORTATION SERVICES

By accepting this Transportation Authorization, I authorize the After School Learning Tree ("ASLT"), including its authorized employees, drivers, contractors, agents, and approved transportation providers, to transport my child in connection with ASLT programs and activities.

Transportation may include, but is not limited to:

- Pickup from the child's school and transportation to an ASLT program location
 - Transportation between ASLT facilities or program locations
 - Transportation to and from field trips, camps, competitions, special events, parks, museums, and other approved activity locations
 - Transportation to an alternate safe location when reasonably necessary because of an emergency, road closure, evacuation, vehicle issue, or other unexpected circumstance.
- Transportation may be provided in vehicles owned, leased, rented, contracted, operated, or otherwise authorized by ASLT, including passenger cars, vans, buses, or vehicles operated by approved third-party transportation providers.

Acknowledgment and Assumption of Transportation Risks

I understand that transportation involves known and unknown risks, including, but not limited to:

- Traffic accidents and the actions of other drivers
- Sudden stops, turns, road hazards, and traffic conditions
- Vehicle mechanical problems
- Delays caused by traffic, weather, school dismissal procedures, emergencies, or other circumstances
- Injuries while entering, exiting, loading, or unloading a vehicle
- Injuries caused by the actions of other passengers or third parties
- Personal injury, property damage, serious injury, disability, or death in rare circumstances.

I understand that ASLT cannot eliminate all transportation-related risks, even when reasonable safety procedures are followed.

I voluntarily permit my child to use ASLT transportation services and knowingly accept and assume the ordinary and inherent risks associated with such transportation.

Transportation Safety Agreement

I understand that my child must:

- Follow all instructions given by the driver or ASLT staff
- Remain properly seated while the vehicle is moving

- Use an available seat belt, booster seat, or other legally required passenger restraint
- Avoid distracting the driver
- Enter and exit the vehicle only when directed
- Behave safely and respectfully toward the driver and other passengers.

I understand that ASLT may suspend or terminate transportation services if my child's conduct creates a safety risk.

Release and Waiver of Liability

TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, I, ON BEHALF OF MYSELF AND MY CHILD, RELEASE, WAIVE, AND DISCHARGE AFTER SCHOOL LEARNING TREE AND ITS OWNERS, DIRECTORS, OFFICERS, EMPLOYEES, AUTHORIZED DRIVERS, CONTRACTORS, AGENTS, AFFILIATES, AND APPROVED TRANSPORTATION PROVIDERS FROM CLAIMS, DEMANDS, DAMAGES, LOSSES, COSTS, OR CAUSES OF ACTION ARISING FROM OR RELATED TO MY CHILD'S PARTICIPATION IN ASLT TRANSPORTATION SERVICES, INCLUDING CLAIMS ARISING FROM THE ORDINARY NEGLIGENCE OF A RELEASED PARTY.

This release includes, to the fullest extent permitted by applicable law, claims relating to:

- Vehicle travel
- School pickup
- Transportation between program locations
- Field-trip and special-event transportation
- Entering, exiting, loading, or unloading a vehicle
- Traffic accidents or road conditions
- The conduct of other passengers, drivers, or third parties
- Personal injury, illness, disability, death, or property damage;
- Reasonable emergency assistance provided during transportation.

I agree not to bring or maintain a claim against a released party for any claim that has been validly released under this Transportation Authorization.

Parent or Legal Guardian Acknowledgment

By selecting "I Agree" below, I confirm that:

- I authorize ASLT to transport my child as described above
- I understand and voluntarily accept the ordinary and inherent risks of transportation
- I understand that transportation may be provided using different authorized vehicles, drivers, routes, and transportation providers
- I understand that pickup and arrival times may be affected by traffic, school schedules, emergencies, and other circumstances
- I agree that my child must follow all transportation safety rules
- I have read and voluntarily agree to this Transportation Authorization, Assumption of Risk, and Release of Liability
- I understand that my electronic acceptance is intended to be legally binding.
