

COMBVRO COMMISSIONS TERMS OF SERVICE

This document lays out the general terms of service one commits to when confirming a commission with me. This is the terms for our work together and does not chain unless otherwise approved in writing. Breach of the TOS can result in blacklisting from any and all commissions. Please keep these terms in mind and know you are agreeing to them whenever service is confirmed.

GENERAL COMMISSION TERMS

- Note that I am a neurodivergent artist working thru the realities of my condition. This may affect wait times, but never the quality of work received. Note that I am always prompt in my communication, but by entering a contract with me know that completion times vary, especially for more intricate pieces. You are entitled to regular updates from me on the status of your commission and can inquire at any time. Please give a general wait time of three to five (3-5) months to complete your piece. Full refunds are provided for commissions with no work completed in an unreasonable time. If any sketches/lines/etc are completed, you will receive a modified (80-50%) refund.
- I do not work with zoophiles, racists, homophobes/transphobes or bigots of any kind. I cannot - due to logistics - personally check and vouch for each and every client, but know that commissions can be denied or refunded should I find a client's views/statements unacceptable.
- You must be 18+ to apply for a commission.
- I take payments through paypal primarily, however other payment methods may be negotiated.
- Please know **I am a SFW artist**. I have only and will only do NSFW pieces for people I know & trust. I do not accept nor want NSFW images as references, if you have any please censor them before sending them to me.
- If you insist on ignoring my boundaries even after I have expressly told you I am not comfortable your commission will be canceled. If I have already worked on your commission by providing sketches in this circumstance you will not be refunded.

- I may deny any commission for any reason.
- Your commission will be canceled if you do not pay your invoice within a week. If there are extenuating circumstances this can absolutely be negotiated.
- Do not use my art without permission and do not remove credit to me from my pieces. My art may be referenced and traced for personal work & learning material, so long as I am properly credited.
- I still retain the copyright for any piece I produce and may use that piece on my website, commission list & other materials. I will not make prints of commission work without permission. Buying the copyright of a piece will accrue further fees. You cannot use my work for your own profit.
- We must have a custom agreement if you wish to commission a piece that you use for profit - ie prints, stickers or merch featuring my artwork. Feel free to bring it up at any time, even with older work you've gotten from me.
- You may still absolutely get any form of prints, stickers, merch, etc for your own personal use and profitless exchanges. It's your piece! Go wild!
- You may edit your commission from me however you like for personal use, so long as credit for the image is still expressly given to me. That being said, please do not treat my linework like it is something you can take out and recolor.
- If a sketch is approved for a commission, only 80% of the commission price can be refunded unless further work has been completed, then a refund cannot be completed at all.
- Sketches can be very loose and general. The sketch may vary from the finished piece as I work on composition and anatomy. For small commissions there are no updates beyond the sketch. For larger commissions you may receive an update at the sketch, line & color stages, depending on the individual case.
- Alterations are acceptable, but only for 1 or 2 times. Further alterations to a commission will cost extra.
- I will not change my style to suit your tastes. Please know my work before requesting a commission from me.

WHAT I WILL NOT DRAW

- In most cases, NSFW material of any kind. Will only draw genitals on references for trusted friends.
- DO NOT PUSH ME ON NSFW MATERIAL. If you push my consent by sharing NSFW images without my approval or asking me to sexualize my drawing more/at all I will cancel your commission and cease to do business with you.
- Any offensive material: racism, sexism, homophobia, rape, extreme grotesque violence, pedophilia, zoophilia.

DESIGN & ADOPTABLE TERMS

- Any design I create and sell must be credited to me always.
- Do not resell designs for more than you bought them for. You may only add to the price if you got more art, merch, etc. of the design.
- Designs can be altered by you if you so desire. However, you cannot completely recolor my linework nor trace over the adopt for your own purposes.
- The adoptable will be put back up for sale if you do not pay your invoice within a week.
- You have the rights to the character! You may do whatever you like with them so long as creator credit is still explicitly given to me. This includes making merch, using the character in your own works, getting a fursuit, etc etc.
- Some designs I will retain partial ownership of, if only so I can still make art of and produce prints of them. These designs will be explicitly described in this way - like the Herculean Labors - and are special because I intend to continue to work with their theme and designs. Owners of the designs will get access to all the art and works I create!
- If you use my designs to do anything hateful, bigoted or grossly irresponsible then you will be blacklisted.
