As for 83-year-old Roger Taney, he said, "I saw the withered form of Chief Justice Taney, the author of famous Dred Scott decision, that judicial compend of the doctrine of slavery, administer the oath of of to the first President elected on a distinct anti-slavery platform." Taney died in office three years later, Lincoln filled the position with abolitionist Salmon Chase.
