NOTICE OF DETAINMENT:

One individual was dispatched at the scene:

The detained are being charged with:

Treason
Sedition
Attempted Assassination of Members of the Nobility
Attempted Murder
(Countless charges of) Assault
Manslaughter
Necromancy
Illegal Void Magic useage
Smuggling and harboring of an Undead entity
Smuggling of weapons into the House of Parliament
Attempted Fraud
Resisting Arrest
Disturbing the Peace
... and further charges pending investigation.

A thorough investigation is currently underway, with Magistrate Meng Shufen notified. A trial and sentencing is to be set at a future date.

Anyone with information or evidence against the accused are encouraged to contact the Magical Enforcement Bureau (M.E.B). A reward fund has been set aside for those willing to step forward, including those willing to testify.

At least two individuals from House Goldcrest are STILL AT LARGE:

Selanathorei Brightsoul

Last seen near the crypts and tombs of Raven Hill and Darkshire. This individual has been reported as being able to twist and control the souls of the dead. She is also known to have extensive combat experience.

Liana Goldcrest

This individual escaped during the attack on the House of Nobles. Last seen engaged with several individuals and holding hostage one Cerusani Duskbinder for use as a living shield against Zaria Blackmoore and others who were attempting to subdue the attacker. At this time little is known of this individual except that she is proficient in arcane and necromantic magics and has been seen around Duskwood where it is believed she may have an abode or cultist den.

Anyone with information regarding active occult activity is encouraged to reach out to the Stormwind Constabulary or the Magical Enforcement Bureau (M.E.B.).

Please be advised that Acting Lord High Speaker Remona Thane has declared a state of emergency. Individuals are discouraged from engaging with either of these two individuals without proper precaution.

There have been reports of disappearances in and around Duskwood. It is unknown if these disappearances are related to the recent spider infestation in the area or it is due to a sudden rise in cultist activity. Caution is advised to denizens and travelers.

STATEMENT:

At this time I would like to make mention of the fact that during the attack many attendees to the House of Nobles rose up to against the cultists and helped to subdue them. Many did so without access to weaponry, or used quick thinking to acquire some. These acts of heroism no doubt saved many lives, and Stormwind owes the same a debt of gratitude.
