Since December, we have met with you on three separate occasions to discuss significant issues and concerns regarding your performance, including, most recently, complaints about your conduct while you were apparently under the influence of alcohol or another substance. We offered you the opportunity to seek medical attention and/or treatment and to take the time you might need to do so and you declined that offer.

You were advised on Monday, May 1st by Chris Boyle that while we could not require you to seek medical support, any further issues regarding your job performance would result in dismissal from your employment with BNS Real Estate.


On Thursday, May 4, 2023, Chris Boyle requested that you be on site at the Canal/Rider building at 11 am the following day (May 5th), to facilitate the viewing of a vacant space buy a prospective tenant. You did not appear at 11 am as requested, were unresponsive to several calls from Chris, and could not be found by colleagues or management. At approximately 11.20 am, you finally called Chris to say that you had overslept.

Your performance is not consistent with the standards and requirements of BNS Real Estate and your employment is terminated effective immediately. Your benefits will terminate on Wednesday June 7th.

You will receive information regarding continuing health care coverage under the Consolidated Omnibus Budget Reconciliation Act (COBRA) under separate cover.

You will be given 1 month (30 Days) to vacate your apartment at 129 Alexander Ave and 2 months' salary if you sign and do not revoke the separation agreement detailing these terms that you will also receive under separate cover.

FINAL EDIT 6/25/2024 WRITTEN AND COMPLETED 6 MONTHS AFTER TERMINATION LETTER.

My name is Emilio Taveras and I am facing extreme mental illness discrimination done to me by BNS Real estate in collaboration with Dream Charter school opening up in the neighborhood who has been recording and overtly spying on me to convince my bosses that I am too mentally ill and need to be fired. I was also investigating corrupt business practices in my neighborhood at the time, only to find out my boss was now dealing with the same entities. I am up against a large development network that consists of Dream Charter school(previously KNOWN as HARLEM RBI)/Brookfield properties/Joy construction/JCAL as they have been in close relations in contracts and services my bosses are newly taking advantage of. They are also deeply involved in political affairs and have deep ties to politicians whose pockets are lined by their financial ventures. I am fighting for my job after a smear campaign using recordings and videos of me in my private life in my neighborhood, harassing my employer, to the point where my employer BNS Real estate has heavily persecuted me for mental illness. They have painted me a monster and caused my job to be terminated. My boss believed I was too crazy to be safe in the company, but it's not true at all. I worked my job for 7 and a half years in the same mindset and condition. The diabolical organization of investors that have decided to usurp me, I now know by name, organizations and affiliations and I am aware of their goals, dreams, and desires. Unfortunately they have collaborated to destroy my life by terminating my employment for BNS REAL ESTATE via slander, blackmail recordings, and harassment with financial pressure of new business deals because I was on to their uncanny deeds, financial racketeering, political corruption, and plan to use the school to remove key neighborhood figures and families who have resided here for years.

My boss succumbed to pressure from them and has now abandoned his best employee under the guise that I have paranoid schizophrenia. While my ideas and beliefs are strange, none of it interferes with my job, and I truly fear that if I am not employed at BNS, living in the community that loves and knows me for years, that I will have no place in society. This wrongful termination is causing me to lose all my workshops/store rooms, access to my private basement gym, and my possible eviction from my humble apartment home since I am a Superintendent, which I have gone to great lengths to care for and maintain since I was 21. All I wanted was to work and have a peaceful life in my apartment, be able to hang out and be with my neighborhood friends, I have no wife, no children, I live as a hermit with nothing but my humble kingdom, evil has come to strip my crown VIA, harassment of my employer to feed their demands, financial manipulation of my bosses, and overt spying/gangstalking because of hatred of my personal life beliefs, my free speech, and my said mental illness. While they point the finger at my flaws, they buy out and pocket politicians who have done little to nothing for long standing members of this community. I have worked diligently for approximately Seven and a Half years at BNS Real estate, always doing a good job even working through the pandemic of 2020. My role requires me to be on call 24/7 which I have almost always fulfilled my duty to. The amount of work I've done for BNS is massive. I love my company and my buildings with all my heart, and all parties involved knew that. By convincing my bosses I was crazy I have faced the worst, most degrading test of moral character and yet I proved myself time and time again simply for the love of my job and life.

I am attempting to save my company, for I love my bosses and my employer. These developers have tactically used the pandemic which my company suffered financially in, to create deals and backdoor them for control of their properties, especially the lot on 132nd street, for financial incentive, which due to their money struggling pain in the pandemic, chose to take, in order to stay afloat. I have worked the whole pandemic to serve my employer and despite tenants not paying rent, I remained employed with my company despite my objection to the vaccine because I simply worked diligently to be let go, on top of my religious exemption of the vaccine which they have a copy of. They are firing me for my alcohol and marijuana use in my private life, and also for my mental sanity. None of which is legal, but the only reason they break the law is the duressive financial state they are in due to these new investors and the school these entities hold. My company has put up with my spiritual beliefs and mental standings for many years, they know me well. I am bizarre by worldly standards but I am not the disgusting morales drug abuser these new investors have convinced them of. The neighborhood I live in knows me very well, and they know my quirks and behavior, none of which hate me for what behaviors I exhibit in my private life when I am strolling about the block. This company would have never let me go under normal circumstances but financial duress from these entity's harassment and blackmailing, have forced them to take methods to ensure my removal. They know me and my antics very well, and have a great upstanding reputation for keeping their employees. I am willing to take this to the supreme court of law to attempt to prove multiple parties who operate as new waterfront developers, with extreme money ties, and CRIMINAL tier business deals of buying properties, and invasion of landlords who suffered during a pandemic to extort the means to control all of the neighborhood as well as placing pawns of politicians into key roles to accomplish their take over.. This coalition hates all men and women who do not fit society's norm. While they advertise the south Bronx as the spot to be in, they have decimated long term landlords and took advantage of a global pandemic to do so. Including but not limited to BNS Real estate. They have constantly displaced local residents within the neighborhood. As well as actively destroy and harm the lives of anyone they deem mentally ill.

It is my duty to produce this document in the only way I know possible to save BNS real estate from these developer's taking over their properties by offering them financial incentives, gathering control of who they rent to, and oppressive means with contracts and deals simply because during the pandemic my company suffered and terminating one of their best employees because he had become opposition to their plan, by spying, blackmail, and slander and scaring them about my said "mental" health, causing them to discriminate against me, terminate me, and create the false belief that I was capable of crime and sabotage, and using heavy illegal substances. I am also standing in defense of the neighborhood as new and bigger buildings get put up, so that all my people can live a prosperous life and be free of victimization by these developers who seek to control all who live in the neighborhood so they can create their fantasy land in the bronx. They despise the mentally ill, the men who walk the street, and those who are known in the community and are actively paying attention to the money laundering madness. I have become a big target because of my self expression and manors of walking and self talking and standing for all things i believe in. The coalition of developers I am up against are partnered with Microsoft, Pfizer, and various huge companies and institutions of

power who have profited endlessly off the pandemic while my company suffered and had very little choice but to take these deals to survive financial collapse. My employer has suffered the most as they were offered deals they could not refuse and now had been ordered to terminate me under the same controllers. A decision that my bosses would have never had done to me but this relentless attack on me had forced their hand as they are now financially in the grip of these south bronx developers who tactically benefited from the financial hardship of my employer.

These developers have collaborated against me with major harassment of my employer with overt spying and judgment of me in the neighborhood but did not expect me to know the men and women who link them all together by their name. I do NOT believe these men are individually responsible as it is a network of partnerships and deals done in the dark. These are just the prominent figures in the chain that usurps my place in the south bronx. My bosses have deals behind closed doors to these guys which I was unaware of until now and their hatred towards my personal life, friends, and associates have caused my wrongful termination. These men infiltrated my employment company through deals and business and have thrown me under the bus in an attempt to fully control the Landmark buildings, Glass works and the Piano factory as well as the parking lot of 132nd st of the south Bronx. Due to these building locations and them being iconic and being on the same street of the school, gracefully existing on both ends. It is a take over of the block and lot. I have stood in the way of their control and I will continue to stand in the way until Justice is served.

They are taking over from the top down, but also bottom up. My wrongful termination is a decision that comes from neighborhood developers who seek to not have me in their Dream plan for the south bronx. My status in the neighborhood, often knowing everyone, being a local, and my awareness and presence of watch over the block and buildings, as well as my bizarre behavior I have been deemed dangerous to have around for I would soon catch on to their darker deeds. I was an easy target because I am weird, live alone, and have behaviors many consider mentally ill. Behind closed doors, my bosses did talks with Joshua Weissman, Jorge Madgura of MaddRealities, Eli Weiss of Joy Construction, Charlie Howe of brookfield properties who has major ties to Dream Charter School aka Harlem RBI, and ALL of their major associates/Companies as well as links to politicians who are partnered with the infamous blackstone group. Leaving me to the wind. They pretend not to all know each other. I wish simply that they have left me alone. All I wanted was a peaceful life in my community, free to live, as long as we did not commit crime. I will give a brief description of each related man to the best of my knowledge. By eliminating me they take out a serious roadblock that hinders their corruption of development and full control of my neighborhood. These men from this charter school even have politicians in their bag, have money laundering businesses around the neighborhood, and to top it all off, have backdoored BNS with deals to corrupt the company into firing their local neighborhood superintendent, Emilio Taveras. They need me gone because I do not fit the social norm of their neighborhood, I am vocal with weird perks of behavior and thought, and I know many people in the neighborhood. There is also a clear link to the business side to it all as they seek to Eliminate parole, who rents and owns property in the Piano factory

and glassworks and secure deals with all landlords in what I too consider to be the Piano District. Since I am the super of these landmark buildings, they knew to keep me around would be detrimental to their take over, not be beneficial to their advertisement, and ultimately reveal that mott haven is indeed still a Bronx neighborhood full of different peaceful people. They are attempting to control all businesses around the area, while they set up their laundering fronts. But first my company let me summarize my role as a BNS employee.

I work as a superintendent who is on call 24/7. I live in 129 Alexander, a residential building but handle all emergencies after hours for the multiple buildings in the south bronx. My bosses work in the real estate office, with one of them who comes as the field manager. I almost always without fail had all of the 4 major buildings I work in cleaned and maintained before he stops by at 12. My other two co-workers mostly sit to work in 79/26 Bruckner because it is quite large, around the same size as my far complex of rider and canal. I do about the work of 2 men for BNS. Which I am more than capable of and love doing. Since one worker, Godfrey, is ready to retire being nearing 70 years old, I was the prospect to take his bigger job position which I had full plans to retire in. My other coworker, Michael, is about a year older than me and we hired him after the passing of my great friend and coworker Danny Longmore. Michael does a great job cleaning and handling tenants but he doesn't share the same passion and love I have for my buildings or the trade skills needed to cover my role, and his life isn't built around his job like my life is. I love my job, however since the interaction with me and my boss is slim and rare, they don't truly understand me but my work ethic has always spoken for itself as pretty much all my tenants love me and I have gotten into almost no issues in 7 and a half years of work.

I have been a super of about 5 buildings, I've seen all walks of life and have gotten along with each and every individual I chose to interact with. I have almost no major disputes with tenants, and I have done righteousness by all tenants, even taking up more tasks than are considered my job. I have what I consider to be 5 buildings with multiple addresses, have worked a job most men would consider a nightmare which included being on call 24/7 No matter what in emergencies, a duty I fulfilled whenever humanly possible. Yet I was at peace and happy despite all the massive workload. Here is the list of my buildings. I know these buildings perfectly, I have a full mental map of all the buildings features and secrets. I am one with these buildings and I know their in and outs perfectly. I love my job dearly, and having served my duty to this job for 7 and a half years, including during the whole pandemic.

14 BRUCKNER/90 LINCOLN/82 LINCOLN/92LINCOLN- Known as GLASSWORKS

This building sits humbly on the corner next to dream charter school. This was my main hub for work, it contained most of my supplies, belongings, and as a result it has been heavily integrated into my life. I store most of my tools here and my mechanic shop exists in this building as well as my major food supplies. It is host to parole like my other building as well as good tenants all around. I stored even my stockpile food here. They intend to hopefully use this as part of the school since dream charter school who currently operates with mostly teenagers will soon offer grades k-12. This is my main work hub and all my Certificates from the fire department are tied in some way to this building. I have done a major amount of work, and

saved my employer plenty of dollars as much of the work I do I do out of willingness, I take up any repair I am capable of and am responsible for all of the cleaning in public areas. Big contingency point as it is directly across from 101 Lincoln which was bought by Brookfield for 165 Million when the original developer spent 5 Billion to develop it. Triton, who is doing the construction for 101 Lincoln, used to use my building as a hub for office operations, until they set up their own hub within the construction property. This is very important for seeing the bigger picture. Parole operates in this building, a big contingency point as to why they need to remove the building super first, and since I have behavior they could deem unstable, they have hurt me in so many painful ways.

79 ALEXANDER/26 BRUCKNER- Known as PIANO FACTORY

This building is mostly monitored by my two co workers, however I know it just as well as them, and have been on call for it as well 24/7. I have taken care of this building plenty and there have been times where my help was much needed. I have trained the new worker to do a decent job but he does not have the love or the passion I have for my work. It hosts a critical part of my life, my home gym which I have built within the basement. I use the gym regularly and I have accomplished physical feats in this basement that many men wish they could have felt that level of power and strength I achieved in those moments. I have had no issues with my belongings sitting open free, I do lock my barbell up as I do not want anyone getting hurt. The tenants here are businesses and great people. Many people consider this to be two buildings. Parole operates here as well. I had used the gym space in the basement that Danny Longmore originally had some equipment there. I had trained in that gym for years. Parole Operates here as well.

363 RIDER/366 CANAL

This building is a MEGA LOT, in fact there are so many addresses to it that to list them all would be cumbersome. It extends from about 141st to 142st on both canal and rider. This building is isolated from the rest of my job and requires you to commute about 5 minutes by car and 15-20 minutes walking. I have done my job here well. The community around this building has neighbors that are various drug users and vandalizers, none of which I have ever had any problems with. While it is further from my personal life, I have a deep affinity for it as well. I have amazing tenants within these walls as well. Many people will consider this portion of the job to be at least 3 buildings. Around this beautiful complex are drug addicts, crackheads, and many dealers who respect my block because they see me diligently cleaning, treating them like human beings, and understanding their walk of life. They respected my building because I always saw them as human even when they were shoving needles and high off drugs, I gave them love and respect, and never once treated them unfairly just because of how they lived. They even always stated that they would keep things clean for me, and they have indeed done their best, as they began to know me for 7 years plus. Many of the drug users and surrounding cast of characters know me and my building well, hence why it sits gracefully among the unaccepted crowd of societal outcasts, the mentally ill, and people who are human like me.

129 ALEXANDER

This is where my home is. I sought simply nothing more than to be able to retire and die within

these walls. I do not have anything I consider home more than my humble apartment on the first floor. I have taken care of this building greatly, and have been responsible for both maintenance, repairs, and cleaning duties. I love this building, but more importantly, I love my home. My neighbors are very kind to me as well. Since this building is closer to my personal life, many of My tenants have access to my private life, and may even peer into my bizarre or quirky habits. I am no normal man. However I have protected all my tenants with my life, despite me knowing some of even the hated people in their community. They know as long as I am around, they are protected from even what they consider the worst of my friends. None of my friends are bad, which is ironic, you are only as devilish as others' perception of you. Something these developers fail to understand. Currently I am still the only caretaker of the building, I do garbage and sweep outside since management has now barred me from doing repairs and the heavier service I used to. Despite me being terminated, I continue to take care of and serve this building as long as I live here. I refuse to resign from my duties as a super.

Due to the complexities of the piano factory, and the lot at Rider and Canal, I usually say I have 5 buildings. Some may say upwards of 6/7, in fact when I started the job I was handed a list of about 8-10 different addresses and I did not cringe or complain, I was ready to serve my life toward BNS and more importantly my buildings.

To discuss some key figures that are simply links in this greater insidious plot to control the south Bronx with use of a school, taking out community members they view fringe or unpleasing, using financial leverage to grab land with powers in key positions, in a neighborhood that suffered financially after the pandemic.

Through the covid 19 pandemic these groups were able to launch the biggest scheme of money laundering, land grabbing, and property take over, now they are on a warpath to displace members of the community, hold business hostage to launder money, and overall attempt to control what comes, and force who leaves the neighborhood. With my firing, they seek to control the landmark buildings, who rents from them, and who works in them.

They hate homeless people, they hate the poor people, and they hate mentally ill people, while they actively work to ensure that people end up homeless with malicious intent. They have been using dream charter school/Harlem RBI to do this for years.

None of the following men are explicitly responsible but they are key members of the matrix network of dream charter schools, in fact, they are all collectively working together to clean up the neighborhood and I have been caught in the crossfire because I happen to know many of the people they desire to get rid of. I also am in a key important position of maintenance for the landmark buildings that they are pressuring my management about since their location is between us.

Charlie Howe of brookfield properties is the brookfield link to dream charter school, he is in bed with the Charter school, as a result he sought to eliminate me on whatever he thinks is unacceptable around a school. He and Brookfield properties have infiltrated my employer via

deals. He has no problem destroying hard working men and since he works for Brookfield properties he has helped destroy my life through backdoor talks he has with BNS. He has a moral problem with certain community members, thinks he can do whatever he wants, and due to his connections at Dream Charter School is using it to take down any community member he pleases. I consider him to be at the head of this mess because my boss is now using Brookfield contractors after they had a meeting with him behind closed doors.

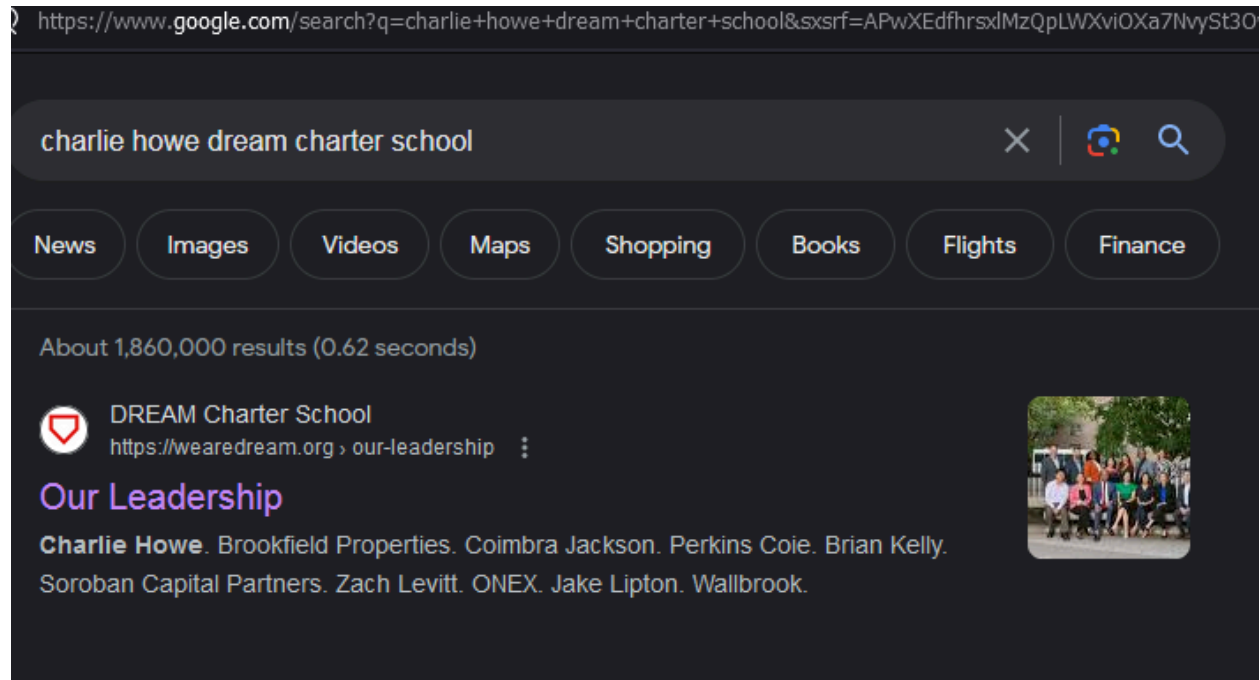

Both are behind Dream charter school. They know if they control a school, they can abuse community members and influence parents and politicians as well as use the police force


wrongfully against those who have been here for years. They have used the school and their business deals with my bosses to terminate me wrongfully of my employment because it was the only way to get me out of the community. By attacking my artistic self expression they successfully succeeded in creating a problem in the minds of my employer, bringing unneeded surveillance of me, pretending as if I was dangerous. And forcing my torture with harsh treatment, and disgusting defamation of my character and principles. He seems to own Joy construction which has ironically aided in the removal of my happiness and freedom. Very sad. He is also in with NYU who you will read about their abuse of me later.

Katz died in a 2014 plane crash, and his son Drew has helped steer the reclamation of 20 Bruckner Boulevard toward fruition. A community of pigeons was evicted and the building was gutted and reinforced to be structurally sound. It will be the flagship for Dream Charter School, which is based in Harlem.

“It’s one of these projects that you feel will define your whole life,” said Weiss. “You’re taking a building that’s been vacant for decades and using it to educate inner-city youth.”

Weiss, an executive at Joy Construction who is doing 20 Bruckner Boulevard as an individual, said, “My father used to say, ‘They don’t build them like this anymore.’ That saying was made for this building. When you go inside it, it’s just magnificent.”

The History Channel sign came down in 2016 and was replaced by an iHeartRadio ad, which will remain on the roof — along with a gymnasium with a full-size basketball court for Dream. Internationally renowned architect Sir David Adjaye is designing the K-12 school.

Brad Domenico of Progress Capital brokered the debt for the project. The loan, which closed virtually, is from Sterling National Bank with participation from Metropolitan Bank. Justin DiMare of Newmark Knight Frank brokered the 35-year lease with the charter school.

Over time, the stately but aging edifice at 20 Bruckner Boulevard became known as History Channel Building for the network’s massive advertising sign on its roof. Naming it after the occupant wasn’t an option — there hasn’t been one for decades.

That will change next year, when the Dream Charter School moves its main campus to the Mott Haven site. Jorge Madruga’s Madded Equities, developer Eli Weiss and Drew Katz — son of the late philanthropist Lewis Katz — will develop the school in the shell of the former ice house, armed with a \$50 million construction loan that closed Friday afternoon.

Drew Kats is the son of Lewis Katz, and he had his father die in a plane crash, to give you an idea of how powerful these people are. None of this is related to him, he has since stepped away from everything, he is a MAJOR victim of these powers. His father Lewis Katz was the original owner of 20 bruckner where the school now resides; he had refused to sell the buildings even after a relentless Department of buildings attack that caused the building to lose right to occupancy. All these developers profited off the death of Lewis as he refused to sell his

It's final. **Drew Katz** has **sold his shares** in Interstate General Media to **Gerry Lenfest**. And he affirmed Lenfest's leadership of the company that owns the *Inquirer*, *Daily News*, and Philly.com on his way out.

"Gerry Lenfest, like my father, strongly believes in independent journalism," Katz said in a statement. "He supports journalistic integrity and my father's primary objective will be met under Gerry's stewardship. I will support him in any way that I can to continue this strong and fundamental journalistic right."

"Today is the beginning of a bright future for Philadelphia's three most important institutions for news: *The Philadelphia Inquirer*, *Philadelphia Daily News* and Philly.com," Lenfest said in his own prepared statement. "I am honored to confirm that a successful sale of these publications has now concluded. I feel humbled by the privilege to now own these award-winning print and digital news institutions."

Katz had announced **that he would sell his stake last week**, but the delay in finalizing the sale **prompted speculation** he would opt to remain with the company instead.

In regards to the construction for Dream, drew katz serves as a passive investor since 2016

In July 2016, the two men struck a deal: Mr. Madruga would be in charge of developing 20 Bruckner; Mr. **Katz**, meanwhile, “would serve as a passive investor uninvolved with the project’s operations or construction,” said his spokesman, James Yolles.

Let's talk about Lewis Katz (drew's father) and his feud with George Norcross. Since Lewis Katz is the original owner of 20 Bruckner his death is really important to understanding how much power these men have. Lewis Katz was attacked by the mafia back years ago. And even had his law firm raided. His friend Simon endured an attempt to having his house burn down. After beating George Norcross of New Jersey in a law firm bid, Lewis Katz' plane crashes the next day alongside the wife of a New Jersey prosecutor.

They were photographed standing next to a vintage Jaguar in their Cherry Hill driveway.

Mrs. Katz was at one time a Catholic school teacher in Haddonfield. They are survived by two children, Melissa and Drew.

Katz's success story took a bizarre turn in 1977, when he was seriously beaten by an assailant outside his law office. It was reported at the time Katz had just parked his car at his office on the morning of March 1 when a man approached asking directions to a bus stop.

After Katz acquiesced, he was beaten.

No one was ever convicted in the case, but rumors abounded that the attack might have been linked to the **Mafia**. Five months later, Katz's law office was burglarized, and shortly after that, there was an unsuccessful attempt to burn down Simon's summer home, according to Courier-Post reports.

There were a lot of people shocked Tuesday when **Lewis Katz** and **Gerry Lenfest** emerged the winners over George Norcross in the bidding for Philadelphia's two major newspapers. Among those who didn't expect Katz to lead his team to victory? Katz himself.

That seemed apparent in the **press conference right after the auction**, when Katz and Lenfest repeatedly declined to answer questions about their plans for the papers. But Katz's own statements in recent days have buttressed that notion that he expected **George Norcross** — who led a "majority faction" of owners — to out-bid him.

Immediately after Lewis was victorious he died in a plane crash the next day. Also the wife of a New Jersey prosecutor who I suspect was looking into Norcross' Legal matters.

In addition to the pilot and Katz, the others who died in the crash were co-pilot James McDowell, of Georgetown, Delaware; flight attendant Teresa Benhoff, of Easton, Maryland, Anne Leeds, a 74-year-old retired preschool teacher he invited on the trip just that day; Marcella Dalsey, the director of Katz's son's foundation; and Susan Asbell, 67, the **wife** of a former New Jersey county prosecutor.

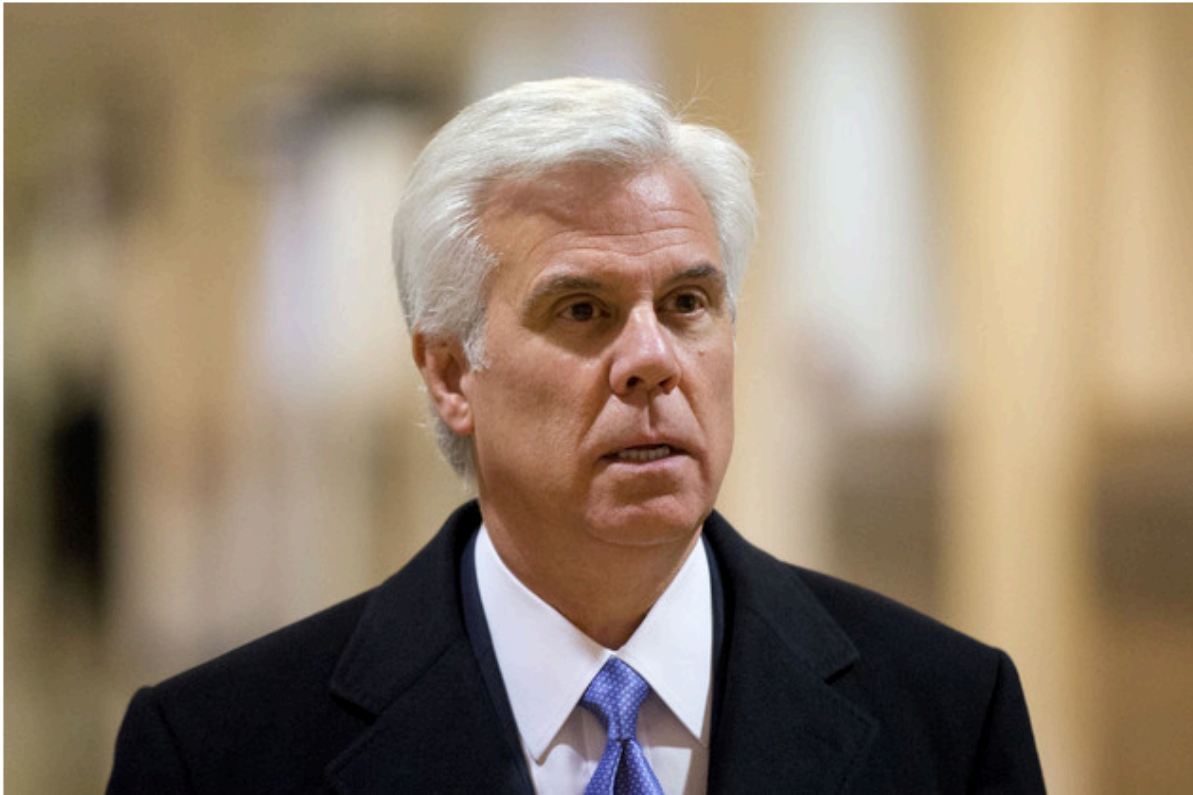

New Jersey power broker George Norcross is stepping back from politics

“It’s time for others to lead,” New Jersey power broker George Norcross told POLITICO, citing “catastrophic” losses in 2021 from which his machine hasn’t recovered.

George Norcross spent decades building one of the most effective and influential political machines in the nation. Now the New Jersey Democrat says he’s all but giving up on politics.

Norcross, a 67-year-old insurance executive, never held elected office yet wielded power rivaling governors. He stacked the state Legislature with allies, cut deals that decided control of government and backed multiple members of Congress, including his brother.

What makes this character more interesting is the group that was behind the LEGAL dispute between Norcross and Katz is none other than Blackstone which is currently heavily represented on the ambassador list on the school's list. 2. IGM acquires PMN

In October 2011, Katz and Norcross discussed the possibility of purchasing PMN and conducted at least some due diligence on a potential transaction. As early as December 2011, PMN began working with investment bank Evercore Group LLC (“Evercore”) to facilitate a sale. In January 2012, Katz and Norcross formally retained investment bank The Blackstone Group (“Blackstone”) to assist them in evaluating a potential acquisition of PMN. Between January 2012 and March 2012, Katz and Norcross, with the assistance of Blackstone, continued their due diligence regarding PMN. This diligence included, among other things, reviewing the contents of a “data room” established by Evercore⁶ and conducting interviews with PMN’s senior management.

In early February 2012, the Katz/Norcross-led group that ultimately became IGM sent an initial offer letter to PMN. On March 1, 2012, IGM submitted its

To put in perspective how well connected Dream charter school is to high level politicians, and most importantly the department of buildings, despite 20 bruckner being one of the most dangerous construction sites. Look at the minimum amounts of fines they paid on lives lost. They have such big financial power that they were able to get away with paying not even a middle class year’s salary in fines. I had known this long ago, but I never thought they would harm me or my job with their wrong doings.

No other construction site in New York City has had this many separate fatal incidents since at least 2003, when the Department of Buildings began keeping electronic records. But despite the pattern of deaths, the consequences have been negligible.

The Buildings Department shut down the site for nearly two months after the second fatality, but the work geared up again, and another man died. While government inspectors have issued numerous violations in connection with the deaths, they have exacted just \$28,864 in fines.

City investigators said their inquiry into the elevator collapse a year ago is continuing. But they did not speak to the lone survivor, Mr. Pineda, until this month, after questions from The New York Times.

As needle towers and super-tall buildings rise to puncture the metropolitan sky, the deaths cast in sharp relief the gulf between those who redefine the cityscape through sketches and contracts and those — mostly powerless and often unseen — who do the grunt work.

All three of the dead laborers lived on the city's margins: Two were undocumented immigrants, one a homeless man. Only the last death received any local news coverage, and it was brief. None of the men had union representation.

Dream charter school was previously known as Harlem RBI, they have changed their name but they are no stranger to displacing people living in poor communities based on their actions in harlem. For the last six years, the 3.5-acre plot has been home to Harlem RBI New York, a nonprofit agency that runs baseball programs and after-school tutorial programs for 300 children. The city's plan could also temporarily close down another field, where 600 children in the East Harlem Little League play, opponents say.

"Nine hundred children are more important than 30 homes, which people in East Harlem cannot afford," said Richard A. Berlin, the executive director of Harlem RBI.

Housing officials say that the city has offered the leagues alternatives: leaving one field at the same site, and relocating the other, to a site 16 blocks away. But the groups have been reluctant to accept the trade-off, citing distance, interrupted play and crowding.

The 100th Street plot was originally cleared for low-income housing 30 years ago. But three lawsuits against the city kept it from development.

Of course their development of East harlem causes them to be no stranger to causing supers to lose their job.

I checked into the dream chater's school AKA Harlem RBI finances and they have hid about 80 Million in assets from the Department of education. Their NYSED filings are completely different from the massive amount of money the organization has. He had visited the school but I am certain the money flow is there as well because black stone group was his 3rd largest funder. Black stone group is heavily represented on dreams board of directors. In fact almost all his funding comes from Real estate investors. He is owned and operated by them, simply a pawn used to do their bidding while they gentrify and destroy communities. He serves in my district but none of his money actually comes from the neighborhoods he supposedly represents. Very suspicious indeed.

City Councilmember Ritchie Torres' bid to represent the South Bronx in Congress is raking in real estate cash, campaign finance records show.

Torres leads a crowded pack of Democrats seeking to replace retiring Rep. José Serrano, pulling in a top \$878,000 since declaring his candidacy in July.

At least \$110,000 of that came from people with ties to the real estate industry, according to THE CITY's analysis of the [latest filings](#) with the Federal Election Commission.

The vast majority of donations to Torres' campaign — 96.3% or about \$845,000 — came from outside the 15th Congressional District, which is among the poorest in the nation. Overall, about 93.5% of the contributions came from addresses outside The Bronx.

Torres defended his real estate industry bounty, and pointed to the number of small donations he's received.

Members and sponsors make THE CITY possible.

"In the latest quarter, two-thirds of our contributors are small donors who gave less than \$100," he told THE CITY in a text. "We have a diversified donor base with contributors big and small."

The ‘Next Williamsburg’

The real estate sector donations have flowed in during a development boom in the South Bronx — and follow pledges from some in the race to forgo money from developers.

Some donors to Torres’ campaign have big real estate projects in progress in the South Bronx, including a residential complex being built on [“the most expensive development site”](#) in the borough.

William Cote, the founder and chief executive of Hudson Meridian Construction Group, which is building on the property, gave \$8,400 to Torres’ bid individually and through an LLC, federal campaign finance records show.

That development is planned for Mott Haven, a neighborhood some eager brokers already are calling [the “next Williamsburg.”](#)

And as new buildings go up, the price per square foot for home sales in Mott Haven and in nearby Melrose is rising — [shooting up close to 60%](#) between 2016 and 2018, according to the nonprofit Association for Neighborhood and Housing Development.

He is also behind attacks on the board of education. Their plans are simple: by using charter schools, they can target individual community members, other real estate landlords to heed their bidding, and ultimately control the neighborhood, but they also apparently have no problem getting hard working men in the neighborhood fired, and arresting those they deem undesirable. New York, NY – New York's leading charter advocacy groups were joined by school leaders, advocates, and parents of public charter school students on the steps of City Hall Friday morning to announce a push for eliminating the charter cap in the final month of the legislative session. Supported by New York City Council member Ritchie Torres, advocates outlined the pressing need to eliminate an arbitrary cap on high-quality public charter schools that left tens of thousands of parents on waiting lists, and vowed to pressure members of the State Assembly majority and Mayor de Blasio to support the measure.

In recent weeks, charter school networks like Success Academy and Achievement First have reported record numbers of applications for charter school seats, reflecting growing demand for charter options from New York's families. With only 25 charter schools remaining under a cap for charter schools in New York City, the State Legislature's failure to eliminate the cap threatens to serve as an arbitrary barrier to high-quality schools, disproportionately impacting low-income black and Hispanic families who apply to charter schools in outsized numbers.

"I believe that charters schools can coexist with a traditional public school system," said Council Member Ritchie Torres. "I reject flatly the notion of an inherent conflict between the two. A system that contains both charter and traditional public schools is one that combines equity and innovation, and I see no reason to cap either one."



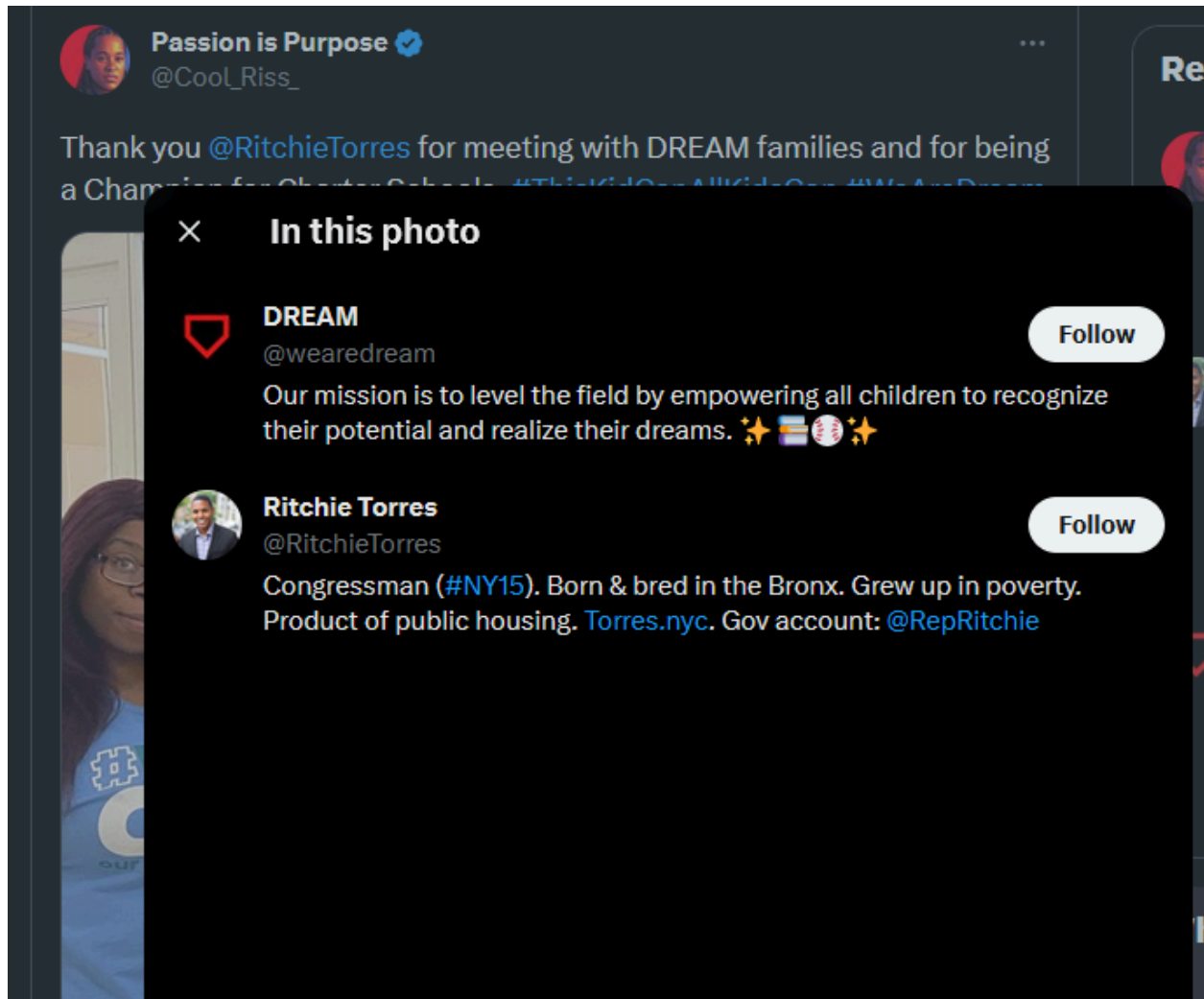

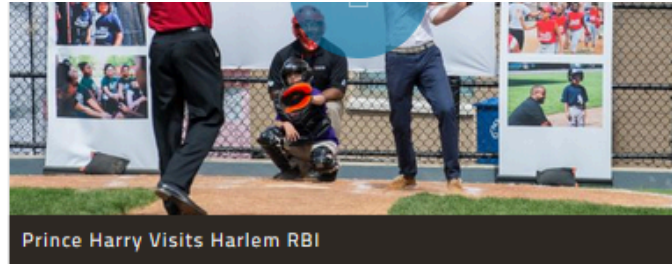

The ADDRESS for sculpt is 126, but their LLC is filed in thinkubators address. All of this I believe to be linked to JCAL's man Alfredo Anguiera. These buildings are currently run by true management but given the ties of just who works in Sculpt i do believe this venture is linked to jcal/beatsro/alfred anguiera. Now get this those buildings are run by true management, but despite no business in thinkcubator, the spot seems to be being held by the same team with money laundering through sculpt which isn't even registered at the right address as it holds 126 and not 128 Like its listed. And since it used to be an old tattoo shop/art studio, I do believe this business just is the same money funnel changing names to avoid suspicion.

JCAL Development, founded by outer borough developer Josh Weissman in 2012, has brought its share of affordable housing to the Bronx, too. But in another sign of a changing borough, its portfolio includes several market-rate developments, along with commercial tenants who seem geared toward cementing Mott Haven's burgeoning hipster status.

The firm has brought more than 200,000 square feet of development with a mix of 150 market-rate and 58 affordable units to the borough. Its portfolio includes **131-135 Alexander Avenue**, **136 Alexander Avenue** and **55 Bruckner Boulevard**, all in Mott Haven. And next month, JCAL and co-developer Altmark Group plan to start leasing at the BridgeLine at **329 East 132nd Street**, its largest project to date.

Strangely Ritchie Torres supports chocobar which is a puerto rican restaurant that opened up in the neighborhood within jcal's buildings. Jcal somehow was able to come out of nowhere and scoop up a lot of property as well as being behind the construction of bridgeline. Chocobar is also located in a JCAL building. Just to show you how they are advertising using their connections.

“We have seen and we’re going to see the Puerto Rican community occupy a greater place in the political and economic life of our country,” said Representative [Ritchie Torres](#), a Bronx native of Puerto Rican and African American descent who was elected last year in the borough’s 15th Congressional District. “I’m excited by the Puerto Rican empowerment of new venues like Chocobar NYC and the entrepreneurial spirit they bring to our borough.”

Carlos Cortés expressed concern about the role of businesses in expressing everything Puerto Rico has to offer.

“We have J. Lo. We have Lin-Manuel Miranda. We have Ricky Martin,” Mr. Cortés said. “But I’m trying to be an example so other entrepreneurs can say we can do business, too, instead of being left out of the conversation — which feels doubly frustrating when you can speak two languages.”

But when you look at the news network Bronx net which they promote a lot of their covers and endeavours on you can see who really supports it. As they cover their own, and support ritchie torres at a very unusually frequent rate. You can find numerous articles of chocobar, beatstro, thinkubator and of course extended content with ritchie torres the man who was bought out by these developers. 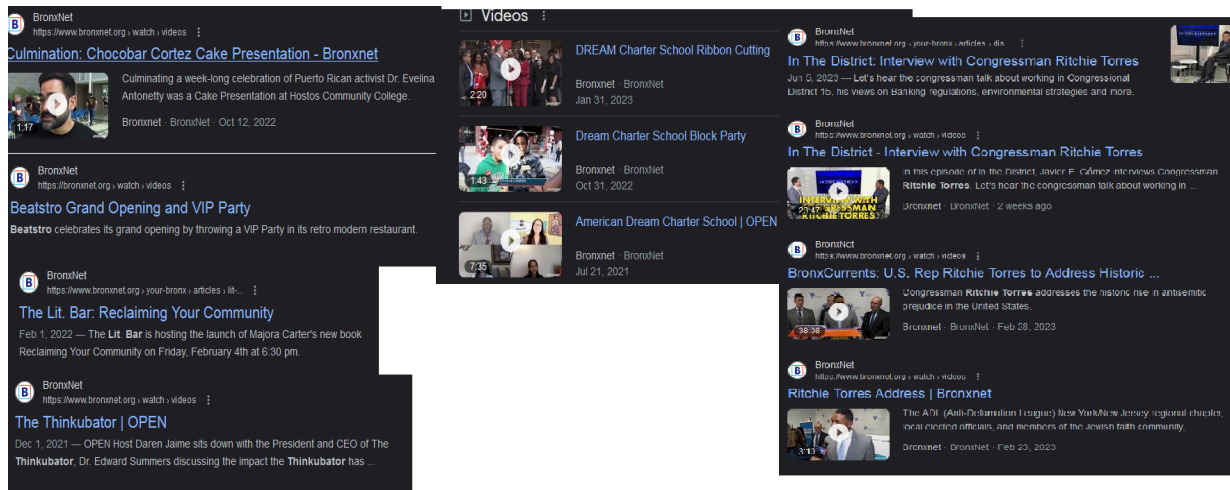

At the time, Mook recalled, Andrés said he needed someone he could trust to lead WCK.

But Mook said he would take the chief executive job only if the organization followed the blueprint that WCK had invented on the fly in Puerto Rico. “A lot of organizations go after money first and then they do the work. Right?” Mook said during an interview with The Washington Post. “I said [to Andrés], ‘What we did in Puerto Rico and what I saw in Puerto Rico, we do the work, and we figure out how to pay for it ’”

Now guess who Nate Mook is affiliated with, of course the rockefeller foundation. He of course has stepped down from his position after doing his dirt. Their tax record is so suspect and it can be found here. They have made a killing off a worldwide pandemic somehow tripling their revenue and nearly quadrupling their assets.

In this pandemic everyone has a personal story to tell. Alfredo Angueira's is about how helping others became a way to survive. When he was about to close his restaurants he thought the logical thing to do was to share his remaining resources with those most in need, he never imagined that this gesture was going to become a new impulse to stay afloat.

Angueira was raised in The Bronx by a mother of Puerto Rican descent and a father with Venezuelan and Cuban blood. In his own words: "It doesn't get more melting pot than that." After earning a law degree he decided to work closely with his community; appointments as Executive Director of the Bronx Empowerment Zone and the Legal Department for the New York Council on Adoptable Children allowed him to help families affected by HIV and get children out of the foster care system. Angueira also served on the staff of the Bronx District Attorney and The New York City Council among others.

Enter the lit bar, one of the weirdest Jcal tenants who somehow despite running a bookstore that makes almost 0 sales, survives the pandemic with little to no issue. I believe her operations to be funded by these same business ties. It makes no sense why she would be able to operate during the pandemic, or even worse, financially survive. Somehow they partnered with bookshop.org right in January but yet, there were no shipments of books coming or entering her shop. In fact she was rarely operating and always empty, I am certain that there is no way her company survived unless she is operating as a money funnel for jcal's expensive rent as she even has a full fledged basement. On top of that suddenly in January of 2020 she linked up with bookshop.org which gained major funding out of NOWHERE. Ultimately this business is a cover business and given its Jcal association I am not surprised, as even beatstro somehow stayed afloat "giving" out meals that nobody wanted. In fact these jcal partner's names pop up together so much, it's obvious they are products of an inner working deal. The theme is simple, be puerto rican, and you will gain the "community trust", a complete fallacy as they launder money and usurp and distress old landlords who have operated in the area for years. This land grab extends to the highest levels of power.

Before Noëlle Santos struck a deal to rent 2,300 square feet along Alexander Avenue for the only independent bookstore and wine bar in the Bronx, she was already well-aware of the gentrification debate that has gripped the neighborhood for years—and of the role her business might inadvertently play in adding fuel to it.

“There are many people in the Bronx that feel like this is too fancy: books, wine,” she said of her store The Lit. Bar, which is slated to open this month. “‘That’s very white.’ That was some of the reaction I received when I first announced the concept.”

To combat this, Santos said she has tried to make sure her store maintains strong ties to the community by hiring locally and giving space in the store to local authors and artists. And rather than just taking the first offer she got from a landlord, Santos said she waited until one came from a company— JCAL Development —whose

The Lit. Bar will join multiple other trendy businesses clustered along Alexander Avenue, including the hip-hop themed restaurant Beatstro, the flagship location of the Famous Nobodys clothing line, the sushi restaurant Ceetay and the Italian restaurant Nobodys Pizza. While the stretch of stores occupies a fairly small part of Alexander Avenue and Mott Haven, it plays an outsized role in discussions about the neighborhood's future. Some community members view it with suspicion and as a sign that they will soon be priced out, but business owners and brokers are confident that they can galvanize community support and attract enough customers to thrive.

"What we're doing is very new, not just for the area but for New York City," said Alfredo Angueira, who runs Beatstro. "It does feel like a little bit of an outlier, but the more that you're in the community and the more that you're out and about, it actually feels very authentic."

The spot on the corner that is now becoming bodega social, was previously taken from our guy Keith Rubenstein as well

[La Grata](#) opened on the avenue near East 134th Street earlier this month — one of many businesses launched in the South Bronx by the prolific real estate investor, including [Filtered Coffee](#) and the combination art gallery-fashion boutique [9J](#).

The kitchen is being lead by chef Erminio Conte, 41, who moved to the city from Southern Italy 15 years ago, with a simple menu featuring pizza, paninis, salads, calzones and spaghetti made with a meatball recipe passed down from his grandmother.

"Here, I can be myself and enjoy cooking," Conte said, adding that he cooks a mean lasagna that he learned to make from his mother.

Destroying Keith Rubenstein seems to be part of their goal, they appear to have taken so much

Somerset Partners is renovating the single-story commercial building at 2430 Third Avenue, on the corner of East 134th Street in Mott Haven, into a coffee shop. [According to DNAinfo](#) (h/t [Curbed NY](#)), the NYC-based coffee chain Filtered Coffee, co-owned by Karen Paul and Aaron Baird, will operate the new café. Both the interior and exteriors of the structure are being renovated and repurposed. New entrances are being added in addition to a skylight, per the latest filing with the Department of Buildings. Vladimir Constant's NoMad-based The Hudson Group is the applicant of record, although Barcelona-based Alonso Balaguer is designing the project. The shop's grand opening is scheduled for April 2.

Weissman has worked for JOY construction, which is his link to dream charter school. They are all behind my firing, and the oppression of good landlords in the area. Yes they have collectively caused the BNS superintendent to get wrongfully terminated. With major financial pressure because my company simply had no means of taking advantage of “non profit” organizations, loans, grants, or anything of the sort to financially suspend themselves. You can see how they set up their basic network for take over. In fact now this entire collective has turned their back on me by blackmailing and harassing my management, only possible with financial leverage from the pandemic they benefited off of.

When Bronx **Borough President Ruben Diaz Jr.** released his annual development report for the borough this week, the top four projects were massive affordable housing complexes from prominent developers like Phipps Houses and BFC Partners. And even more such projects are coming to the Bronx, including a roughly 750-unit complex from Maddr Equities on River Avenue and 1,045-unit building from L+M Development Partners near Mill Pond Park.

JCAL Development, founded by outer borough developer Josh Weissman in 2012, has brought its share of affordable housing to the Bronx, too. But in another sign of a changing borough, its portfolio includes several market-rate developments, along with commercial tenants who seem geared toward cementing Mott Haven's burgeoning hipster status.

The firm has brought more than 200,000 square feet of development with a mix of 150 market-rate and 58 affordable units to the borough. Its portfolio includes **131-135 Alexander Avenue**, **136 Alexander Avenue** and **55 Bruckner Boulevard**, all in Mott Haven. And next month, JCAL and co-developer Altmark Group plan to start leasing at the BridgeLine at **329 East 132nd Street**, its largest project to date.

Though JCAL's projects are relatively small in scale, they've generated buzz. The developer is leasing a ground floor retail space at **131-135 Alexander Avenue** to The Lit. Bar, the Bronx's first bookstore since Barnes & Noble shuttered its Co-op City location in 2016.

As you can see, all this network is so complex but working tight nit together to eventually control and take over the poorest area in the bronx, and I bring their dirt to light, because they through the use of a school crushed me, my job, and harassed my employer with a spy network of people in the neighborhood who have filmed, documented, and slandered my name. Pretending I was some kind of monster who had no place in his community simply because they deem the

mentally ill unfit to have around children.

Enter Carnegie management, who controls the clock tower and built 280 E134th street. They are linked to Brookfield as well because all the developers are working together. Carnegie is not just a management company, their ties run so deep, its insane, you won't find much on this connection but do know. If you notice, IBM is listed too, this will come in later as there is a man who is linked to the school and IBM.

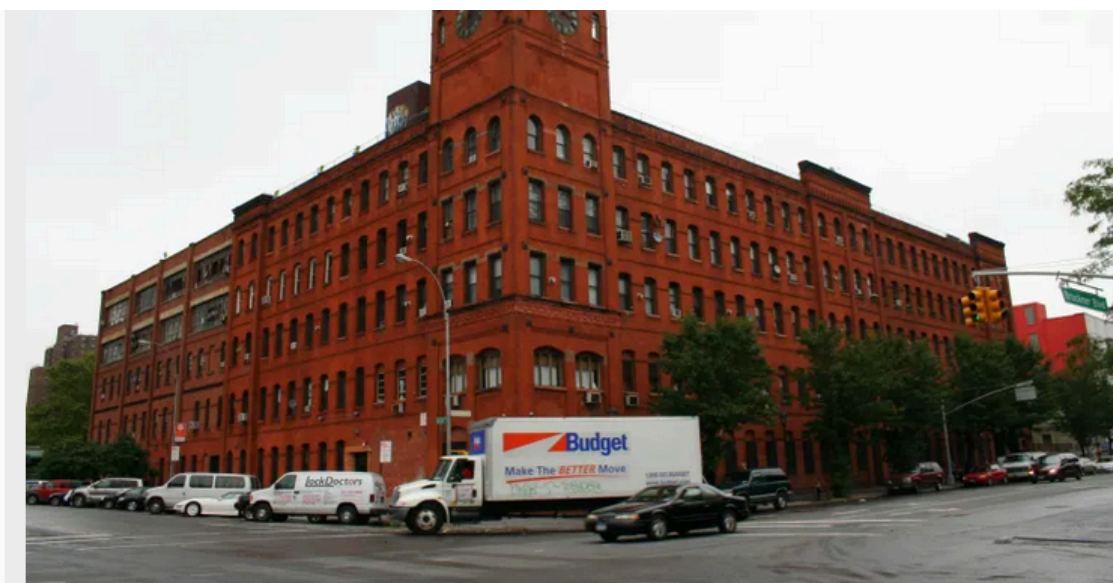

Brooklyn's **Carnegie Management** has refinanced and extended its leverage on a newly built residential project in the Bronx with a \$38 million debt package, city property records show.

The deal, which closed just after Thanksgiving, brings Carnegie \$29.5 million in the form of a new gap mortgage from **Capital One (COF)**, as well as a refinancing from that bank of an \$8.5 million loan that **Signature Bank (SBNY)** originated in August 2017.

Carnegie uses Comelit as well just as Brookfield does. This point will come in later as I suspect there is collusion as to why after my boss installed carson I was terminated,



The plot to remove parole is so sinister and thought of long ago that they even opened up the cayuga center right next to the school with the same construction done by GDI/JOY as the building of 24 bruckner is part of where cayuga center rents. Parole had to downsize and no longer rents the 5th floor at 25 bruckner, which was taken over by this, of course non-profit organization. Called DFOY. They rent from my landlord, but are almost NEVER in the space, in fact I don't even really know what they do, I never really saw them operational before my firing.

The parking lot on 132nd street is a big contingency point for all this. BNS used to have full control of 132nd between Lincoln and Alexander, we had a cut out for the back area of 20 Bruckner but since it was now being opened, dream has now seemed to claim full ownership of it even flying their standard besides both entrances. It is a disgrace to my landmark buildings to have their parking lot street claimed by another entity. The enemy flies its flag on both sides of the street, locked down by gates they put up, taken from my landlord. Previously the street was filed to be opened up but somehow dream lands the ability to put up gates on both sides and keep it a private street/parking lot, which now had paid parking spots belonging to my boss, previously parking was free and we had so many more parking spots, a complete downsize done by the school.



I am in No way saying that these men are individually responsible but they are simply links and key players in chains into the greater scheme of the dastardly plot to control the south bronx. The organizations and ties run so deep it's like a huge shadow entity that has attempted to financially absorb all of the mott haven/piano district They put up charter schools, put up huge buildings, attack landlords with it, and attack people who lived in the neighborhood for years with them. Needless to say they hide behind children while damning me to homelessness with removal of my job. Where they attack my job on the ground with harassment and gang stalking, they attack my landlord with their power, forcing them to break laws and ultimately fire their best employee. The only one who stands in their way. They are using Dream Charter school to attack me. There are so many connections, I alone am in their way because of my prominent position as the super of parole/the landmark buildings of the south bronx, became politically wrapped up in a funnel of money that is backing a political figure, while their shared charter school project attacks community members, and since they seek to remove parole from around the school "for the kids" they needed to get rid of me, the one man who would testify on behalf of all my parole members and parolee's who come quite peacefully so often.

Deeper into the connection of my original Boss Bradford N swett to lewis katz is where his memorial was held, Mrs Swett's Funeral was held at Abyssinian Baptist Church at 132 West

138th Street, New York, NY. He is tied to Lewis Katz and this entity through the Abyssinian Development group because he supported the church greatly, what makes this all uncanny is Mrs. Swett was also in the school development industry.

Sheena Wright who has worked at Lewis Katz lawfirm also served as CEO of Abyssinian Development group. And since my new bosses were able to buy 14 Bruckner which was run over by pigeons since Lewis Katz was angry at the Department of Buildings for its excessive targeting of him to shut him down, it is very likely the two were friends.

Perhaps no group has felt this shifting tide of anger and excitement more keenly than the Abyssinian Development Corporation, which built the school in partnership with New York City. As the development arm of the Abyssinian Baptist Church, which has served the poor in Harlem for 195 years, the corporation has been forced to walk a fine line between bringing economic growth to the community and remaining true to its community roots.

As President and CEO of ADC, Ms. Wright has been responsible for leading and managing one of the nation's premier community and economic development organizations. During her tenure, ADC built 785 units of residential housing in 78 buildings and nearly a half million square feet of community, commercial and retail space, including the first new high school building in Harlem in 50 years, creating over 1,000 jobs in the process.

Under her leadership, ADC created the "Abyssinian Schools" division, which comprehensively manages five educational institutions that annually serve 2,100 school children and their families. Ms. Wright developed an award winning workforce development program which has helped 200 young high school drop-outs obtain their GED or high school diploma and secure gainful employment. She also developed a neighborhood based Naturally Recurring Retirement Community that annually serves over 1,000 seniors and increased the service delivery of ADC's homeless shelter.

Ms. Wright previously served as Chief Operating Officer of ADC. Prior to ADC, she served as the General Counsel and EVP of Business Development for Crave Technologies, a Senior Associate at the law firm of Reboul, MacMurray, Hewitt, Maynard and Kristol, and an Associate at the law firm of Wachtell, Lipton, **Rosen** and Katz.

Making her linked to both Katz, and Bradford, Oddly she now serves the Mayor Eric Adams, which could explain his presence at Brookfield Properties Bank Side. Which was constructed by Triton Construction which built Bank Side, I had heckled the Mayor the day he arrived. I was never a fan of his, and I am certain the man is being blackmailed just as all parties involved are likely controlled by their handlers.

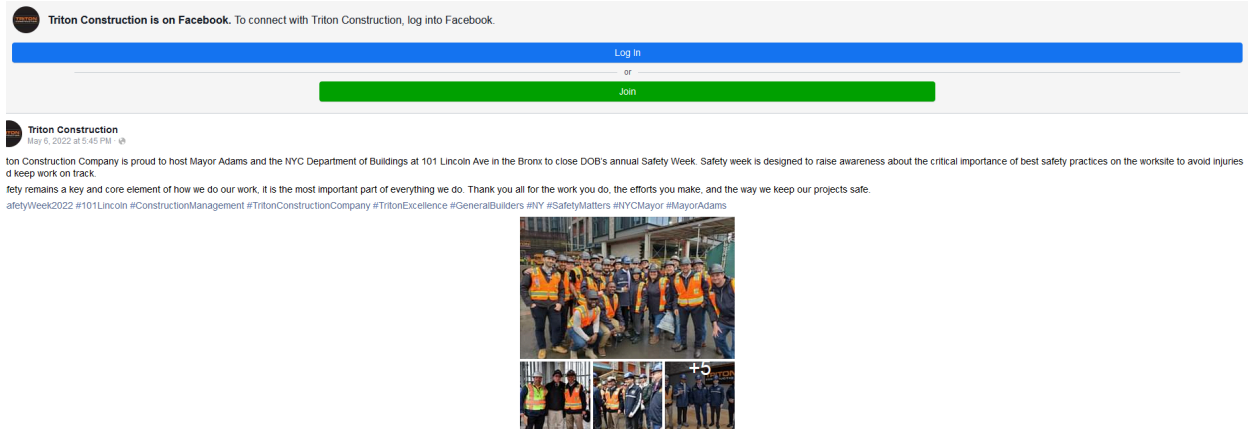

Deputy Mayor Wright previously served as the first female president and **CEO** of United Way of New York City and president and **CEO** of Abyssinian Development Corporation. Before joining the Adams administration, she was appointed to the city's Education Sector Advisory Council and the state's New York Forward Re-Opening Advisory Board.



These men are behind the Dream charter school which has employees who spy, record, and stalk their competitors. Since BNS is now on both sides of the new school, they have spied on me, harassed my bosses about me, and made me a subject of discrimination of mental illness, they do not understand me or know me, they do not know the members of the neighborhood, and since they do not agree with my beliefs or how I express myself, they deem me unstable, dangerous, and have forced my bosses into wrongfully terminating me, and causing me to suffer greatly at the loss of all i worked for and my career. I am losing my home, work, gym, and happiness. I have already tried apologizing, I have already tried to make amends but nothing works, I have been forced into therapy unwantedly to save my job. I am being a target of heavy discrimination of mental health just simply because I am not an ordinary man, and I have beliefs and principles and a way of expressing myself that is deemed unfit by their self absorbed standards.

These men have directly attacked my life, and likely hate my friends because we often hang out in the neighborhood and know everyone. They fear those who know everyone because divide and conquer is their strategy for destroying the lives of all the members of the south bronx community. I do believe my bosses to be innocent as they are simply trying to protect their business and have already made these deals not expecting it to all cause them to lose one of their most trusted employees, myself. They hate my alcohol and marijuana use and have fired me for using these things in my personal life which is against the law in new york.

Due to the deceptive nature of the deal my bosses have denied knowing them though I heard their names out of my bosses mouths a few times. I would not be surprised if these men will deny knowing my bosses as well as if they have no clue who I am talking about. EVEN though BNS and GDI/JOY/DREAM worked closely to build the school as access to my building was necessary for construction. They think I lack memory of it all, they pretend as if I am deranged or crazy but the reality of this situation is so big and evil that they would probably take their lies to the grave if not for me. They have no problem lying to me because they deem me too mentally ill to know the truth. But my bosses are not silly or dumb, they know what these people are doing, they just simply could not say no to many of the deals because of the pandemic they were not financially able to.

Upon my firing I was heartbroken, hurting, and upset stemming from a terrible hospital incident that happened the exact weekend before I was let go, realization that I was being slandered and blackmailed despite me feeling it was very wrong to slander or blackmail me about for I spoke the truth and knowing that I truly did nothing wrong to be fired, and that my bosses completely discriminated against my perceived disability. I was painted to be evil, irrationally and capable of criminal activities and worse. I argued with my bosses and tried to work my job anyway for free. I was locked out of all my things furthering my suffering. Very few men can ever understand what it's like to lose everything you love in a single moment of time, especially when you feel righteous about all you spoke and done. I have never done my job poorly and my job is very difficult as I am the hardest working man in a 3 man crew. I originally took my anger out on my bosses for putting me through this unjustly, but I am simply an at will employee who doesn't have the same protections as someone in a union. My bosses lack compassion to see what damage has been done to me so they still refuse to give my job back, but they are simply protecting what they deem "company interest." I realized real quickly when my tears and rage did not work that something of greater evil was taking place, and more importantly, I realized how harsh discrimination of mental illnesses can be. They assumed me to be a criminal, and treated me as such, they were so scared of me that they thought me to be capable of harming them, attacking them, or being violent. Despite all my suffering, I continued to do the right thing, but I spent time researching and learning exactly who was behind this wrongful termination. I learned who was really pulling the strings and harassing my management. I figured out what financial leverage can do to a company. I knew at that moment that BNS had terminated their best employee because of the demands of organizations with more money, and more power.

This is a conspiracy of a great evil plot to control all members of the community via influence from a school. Something that I now am required due to pressure to stand in the way of. If they lie when they lie, I worry greatly that justice will not come in the form of LAW. They even boast cockily that they have enough evidence to terminate me for job related stuff, a fallacy if you knew how well my tenants speak of me, and how little issues my building has due to my diligence. Any just opinion of firing me comes not from my job duties, but my personal life and conduct based on the destruction of my life and the opinion others have of me based on my beliefs and what I deem true. It comes off the heavy hatred of those deemed mentally unwell, especially when schools are involved. It speaks volumes to how quickly people can turn on you when they find out you have a disability or illness even if simply perceived as having one. Hence why I continue to write this Manifesto.

Needless to say they have taken this way too far and on the brink of losing my spot in the south Bronx to developers I am now in a final battle for my life, the community, and freedom. These men are richer, more powerful, and if they are ruining the lives of people who live in my neighborhood, of worse moral character than me, and it is obvious when they have constructively destroyed my life through back channels. Now I am at war. These men have painted me a monster who does not deserve to live in the neighborhood. Forced my bosses to terminate me, showing they do not believe men like me should even have jobs. They despise my principles, they hate how I live, and since they could not fire me themselves, they used their

connections to my bosses to do it. I am just one of many people they will likely target in this organized corrupt fashion.

I am aware of the financial suffering and hardship the pandemic brought on my bosses so as means to recover, they were left with no choice but to accept the will of the men with money who were building relentlessly during a pandemic, while my company's tenants could barely pay rent. However none could foresee the money forcing them to fire their superintendent but that day has come. Now I am set forth to save my employers from their enslavement by financial dealings, and be reinstated to my job because I deserve to work and the buildings need me, I am a free man who self expresses the way he sees fit, I may be mentally ill by the code set by the world but I have a right to work because nothing of what I am interferes or has stopped me from doing a diligent proper job for 7 and a half years. The same will of these people have deemed me evil, monstrous, criminal, and undesirable to have in the neighborhood. I have been punished and harmed, broken, and infringed on yet I prove their opinions of me false. I have done no crime, I have not destroyed anything, I have remained true to myself. I believe I have a right to work my job and be left alone. Simply put, my Job was my life. I am also going to expose MANY neighborhood money funnels, corruption, and suspect businesses/operations in my neighborhood. Im am certain there is a bigger power that is brutalizing my company that stems lots of their profits from my local neighborhood. Simply put, there are people who profited in very strange and sudden ways that are not by good work ethic or chance, they are funneling money through various non profits, near criminal money laundering, and suspicious business operations that receive more grants and free money than they provide service or product for the community.

Within my company lies suspect leases, suspect contractor switches and an overall change of company policy that seemed to force my job to be under a position of distress, especially as the entity of organizations I was fighting were supplying new money to my bosses. I had become a company liability based on the design and beliefs of these people's Dream. I do believe this level of post pandemic extortion to be on a tier of A RICO.

My company has switched contractors, their email provider, security service, and many more to fit the demands of brookfield who partnered with Microsoft. We used to have our own private email server. Now our emails operate on a verified Microsoft network. This is major as we used to have an old email server that worked great for years, even our tech guy switched when someone called to help me. The new one couldn't even figure out that the Microsoft suggestions were causing the app to crash on my phone when trying to send an email. But it's obvious that they would fail the reverse infrastructure integration of our devices, as they upgraded with no regard to the workers who were on the ground. I had to figure that one out myself, it's funny that they are attempting to use my inability to respond to emails as a point to my termination which I have direct proof of. A testimony as well to their lack of understanding of what kind of phone their workers use. Microsoft's brookfield partnership is behind the switch. Microsoft is a leader, through bill gates, of vaccines so as a result it is obvious why me being unvaxxed in my company would be a problem by these people. Since the partnership came around pandemic timing, it is the same kind of money that now has me at the brink of losing everything. Around

October is when we switched to microsoft, two months later, suddenly the flak for my job began, that is when the developers began to become critical of my personal life, so to start building the case, my management was using the email against me in december.

My company is using Carson.Live app as security now, I know this the company is funded by Brookfield Ventures as well, through a deceptive partnership led by Comelit. In fact the company is so new, and my bosses didn't use their old security guys to upgrade the intercom, around this time is when the pressure for my job began. It offers them the ability to constantly monitor and watch my buildings from a remote system that I have no clue who truly has access to CARSON in shady deals that my company was offered. They first locked me out via their digital intercom, but did not count on not surrendering my keys to have entry. It is partnered with COMELIT which is the same intercom system that sits exactly outside of BANKSIDE which is owned by Brookfield. The financial links have created leverage over my bosses to convince them that letting me go was proper, sound, or even legal. Their hatred of my mental state causes them to do this to me. It is important that I note this because I am sure the deals go even deeper but there is a reason they had set up this kind of infrastructure in Glassworks first. I don't know if they will extend this to 26 or 79 or even Rider/Canal, but I do know it was part of my targeting. I work funny, I am a janitor, I cannot imagine what kind of perceptions

they have of me off of needless spying. My boss has a right to witness my work and record me. I have no problem with it as I do a good job and do no wrong, but I find it highly suspicious that I began to take heat about my employment most heavily once Carson was installed. I also know that highschool children, and elementary kids are often separated. I believe glassworks may be part of a deal to serve the younger children, hence why Brookfield/Dream's intercom system was installed preemptively to fulfill that goal. Since dream intends to serve grades k-12 they will likely split the main building to serve highschoolers and utilize glassworks to serve the younger. It is also likely why my boss had rented the open space to his worst tenant, and left one vacant. It is much easier to get out one tenant from two spaces, especially if it is your worst tenant. This may not be the case but it is sensible to say the least. Ironically this tenant services the mentally ill members of society, and yes, I get along with these people perfectly. I have now been grouped in that category by all developing parties, including my own bosses due to the influence these new deals, and investors have. I have attached proof that Carson is funded by comelite, and proof that Brookfield uses them as well. The intercom system at 79 and 26 remains unchanged, in fact even the code to said buildings remained unchanged, and I technically still have access to those buildings, showing how targeted the discrimination is of just the mentally ill employee, since my co workers spend more time at 79/26 on the weekdays, while I cover the buildings on the weekends.

Property management tech startup Carson Living has announced a \$3 million seed funding round for its platform, which provides services to unstaffed residential buildings.

BuildingLink, a New York-based web-platform for property management, led the round. Jerry Kestenbaum, founder of BuildingLink, said that Carson is a “perfectly targeted solution” for the residential portal space.

The startup, founded in 2017 by Guy Blachman, provides a mobile application that connects to a front door panel, and allows residents to view in-building cameras, make payments and receive deliveries.

The startup has now raised \$4 million in total. To streamline its services, it has partnered with Comelit, an intercom provider, and SMARTAir, an electronic key provider for multifamily properties.


Blachman’s previous startup, ActiveBuilding/MyBuilding was acquired by RealPage in 2013.

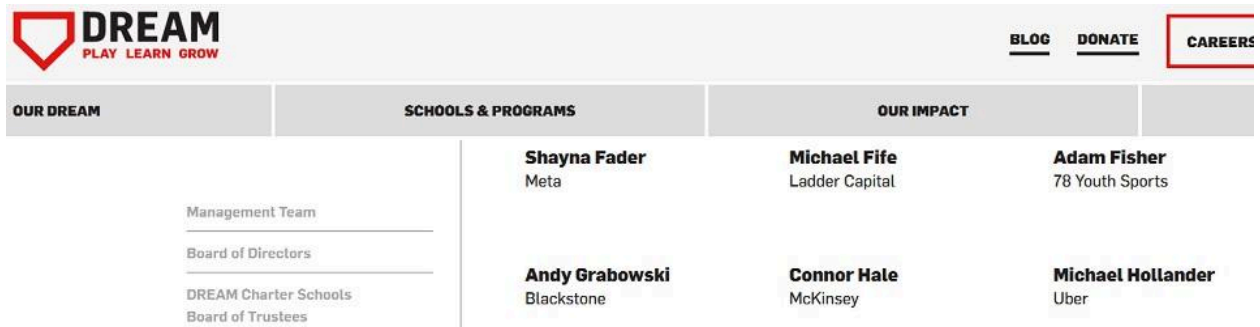

101 Lincoln across the street from my glassworks building is owned by brookfield properties using Triton construction, who rented out space during the pandemic, before they had built their own office. Another small hand from brookfield properties utilizing our space as per the deeper darker connections, now if triton rented to build brookfield properties building, who do you think paid for that? More knowledge that BNS was under financial incentive to listen to brookfield properties coalition of developers. The people from Triton were very kind to me. In fact I even helped many construction workers find a location to use the bathroom as my building was always well kept and maintained compared to the porter potties they had on the site. Until

Brookfield changed our intercom system I was no longer able to help their workers. I think the people from Triton were very cool. They quickly rotated out as the pandemic died down, they built their own beautiful office in the street level of the new building. This space remains unrented and unshown as 3B, it was previously known as 3C within the building but my bosses floor plan says otherwise. Which makes me curious. Many packages for triton arrived months after they moved to 101 lincoln, including heavy things like ladders, which I returned to them justifiably..My boss threw a big fit when this space was accidentally painted well by ICL, which makes me rumor that potentially talks were made to own all 3 spaces. It would be weird for a contractor to make this kind of mistake as they are segmented. Once we changed the name, my bosses rented the old what used to be known as 3B (previously 3C) space out. The names were swapped before the lease signage leading the men to make an obvious mistake when they did indeed paint a spot labeled 3B. They sit directly across from glassworks.

This project at 101 lincoln and 2401 third ave, known as bankside, was originally owned and developed by Keith Rubenstein and the Chetrit group but brookfield properties took it over in a almost criminal robbery/losing deal. Screaming more financial duress/political force caused to good landlords by these land grabbers who hide behind the children and their politicians. Of course the ones who brokered this deal sit on the dream team of corruption. They are killing all old time south bronx real estate companies and submitting them to their whim in almost criminal deals. I believe Somerset partners to be victims from this same corrupt entity that is using the NY US 15 Congressional leader to do criminal displacement of the locals and control businesses. Just as BNS is a victim. What kind of political leverage do you need to make such a losing deal happen, but more importantly you can see why they needed anyone who opposed them out of the way. Somerset has been active in the development of the south bronx and have been running buildings here for years, making them a target as well for these new developers who have politicians in their pockets.

UPDATED, 3:44 p.m., April 4: When Somerset Partners and the Chetrit Group were getting started on their massive South Bronx project, Brookfield Property Partners was in talks to be a possible lender. Instead, it's becoming the owner.

Chetrit and Keith Rubenstein's Somerset Partners are selling the site of their megaproject to Brookfield for about \$165 million, according to sources familiar with the deal. The developers initially spent \$58 million acquiring **2401 Third Avenue** and **101 Lincoln Avenue** along the Mott Haven waterfront, and broke ground on the first phase of the seven-building development last year. Now, they're bowing out.

"It posed a really good opportunity for both sides," Rubenstein said. "For them to develop a large-scale property, for us to realize a profit

Rubenstein told *The Real Deal* that he and Chetrit had talked to several lenders about making a construction financing deal for the project, including, at one point, Brookfield.

"We did speak to them early on," Rubenstein said, "but nothing concrete."

The deal, which is being brokered by a Cushman & Wakefield team led by Doug Harmon, Adam Doneger and Adam Spies, is expected to close in June.

In this torture session I was given 3 medications, one was an anti psychotic and a sedative, as well as the last one midazolam given later which is intentionally designed to make one forget traumatic surgeries/ordeals, It was ineffective on me, I remembered everything they did to me and had bruises to prove it. I was held against my will and forcefully medicated despite being rational

and sane. They defiled me and my religious rights which were against medications and tests all to see if I was a heavy drug user. My employer has a copy of this religious exemption which I had submitted during the pandemic when vaccination was requested for work, I will quote it here. This ordeal only added to the constant heavy persecution I faced.

“ I am also deeply against any medical test, any medical procedures related to covid 19. Nose swabs and even saliva samples are blasphemous to my lord because they seek man to diagnose problems that are unseen physically, unable to be tangible, and beyond the knowledge of man. Which is direct competition to god. I believe only in the manifestations of illness and physical harm. I do not allow tests to figure things unseen, I only believe in symptoms created in the body designed by the lord himself as a forewarning, thus I refuse all testing as it looks for things unseen as to reach for god's throne and determine illnesses upon you without sight or symptoms. These tests aim to be god, to decide your health, beyond what you can see, beyond what you can understand. I believe god has given us all the tools to understand our body.”

In order to hide their operations in the neighborhood after I called them out for my kidnapping, they removed the NYU logo and covered the cooperate with a new fresh direct logo that is simply just a signboard over the the operated by, and the addition of an updated address. See pictures of the trucks below. Since propark is heavily partnered with NYU, it is likely this is just use of all company trucks to now service fresh direct, the oddity of this is why did they have their logo for so long until i called them out in the neighborhood for what they did to me. Just note that even if fresh direct trucks are operated by pro park, why did NYUlangone's logo only disappear after I had called out their scheme. You can see the pictures of how they updated the trucks who used to say NYUlangone, compared to the original Fresh direct trucks. Propark mobility is their truck partner and it serves many different companies including fresh direct and NYU hence why I have a picture of NYUlangone trucks in my neighborhood.

Lets go on lobbying to get fresh direct into the neighborhood before I drop the medical trauma I received. .

“Because the consultants aren’t obliged to disclose their compensation and the lobbyists’ reports combine work related to the move to the Bronx with other lobbying on the company’s behalf, it is impossible to tell just how much FreshDirect has spent in its campaign to win approval for its move and the accompanying tax breaks and grants, but the reports suggest that it is at least \$200,000.

Among those lobbied by the Parkside Group and Akerman Senterfitt LLP are a deputy mayor, the borough president, the heads of the Bronx Overall Economic Development Corporation, the city Economic Development Corporation and the state’s Empire Development Corporation, the counsel to the governor, City Councilwoman Maria del Carmen Arroyo, the Bronx director of the Dept. of City Planning and members of Community Board 1 and its district manager Cedric Loftin.


Parkside has represented FreshDirect since 2004, according to the records of the City Clerk. Through 2011, it was paid a retainer of \$48,000 a year to advance FreshDirect's interest in city and state legislation and in regulations concerning trucking and workman's compensation.

In 2012, its fee shot up to \$6,500 a month. Through the first six months of 2013, according to state and city records, it has earned \$112,000 to lobby state, city and local officials in connection with FreshDirect's move from Queens and the grants and subsidies that added up to \$128 million.

Months before FreshDirect's planned move was announced, Parkside officials met with Deputy Mayor Robert K. Steel, with the borough president and with Seth Pinsky, then head of the Economic Development Corp., filings with the state's Joint Commission on Public Ethics show."

As you can see the office of the borough president is represented by bronx net, and fresh direct lobbied with the borough president.



I tried to confide in my bosses about what happened to me in that hospital but they refused to listen and instead just hit me with my termination paper, because at the time I was already deemed a mentally unstable as a person. Driving me further down into misery, I was happy and loved my job. The darker forces that were behind recording and slandering me had won over the hearts of my bosses and they were too ignorant to see the levels of corruption power has. I was deemed unstable to make my own medical choices by that hospital so they forced their will on me. I could only describe it to my bosses as being 51/50'd which was probably a bad choice of words but their opinion of me was already so tarnished by the campaign of defamation that was launched by gang stalkers that served the interest of their 'new investors'. I don't really have that many people to talk to so I considered my bosses to be some of my closest friends and I always treated them as such. In fact I had so much love for them, I trusted them to protect me from anything and anyone who sought to discredit my work or defame me. They have chosen these new investors' sides. And have deemed me a monster. The punishment I faced as a result has been so unjust and without right. By having this on my hospital record they are able to justify my abuse as well, which involved a later 36 hour stay I was forced to endure at Lincoln hospital. Without drugs in my system, and knowing that I was a man who would stand against them without an exploitable criticism point like hard drugs, I had invoked true fear into their hearts.

As a result these investors had sent their locksmith who locked me out of my glassworks buildings and store rooms and digitally changed the intercom which was controlled by Carson to

keep me from access. We use manor gates for all locksmith related things, Ivan/Manny are my favorite locksmith brothers. I have seen the new man who changed my locks, he has no affiliation to my company from what I knew at the time. Due to the difference in contractors, not even my co-workers were alerted or made aware. In fact nobody had the keys available or ready when I went to repair my brakes, I was left unable to change my rear brakes, I couldn't repair my car properly, as I was locked out of my personal mechanic shop that I host in the building, if I served a building diligently for years, why have I been locked out? On top of it all, the man who changed the lock failed to properly install the back end, as a result anyone who came down that staircase was not able to exit, a blatant fire hazard that I took very deep into my heart as my duty to the building was unmatched and I couldn't believe that when they changed my lock, they had failed my tenants and guest too. I felt as if my building's integrity was defiled, a testimony to my love of my job and building. My bosses were even unaware as to who had the keys as this locksmith did not drop them off with my co worker, nor give them directly to my bosses, he had to retrieve them later that following monday. I made a big deal about this to my bosses because I was already locked out from work, I had entered through a different entrance, I did not use force or illegal access. It pained me to see my building be damaged by some other entity who sent their own men to do this to me. What is so odd about this is why did neither my bosses nor my co workers have the key, it made it obvious to me that it was not their doing, it was simply done on request of the same collaboration of people that have sought to force my bosses wrongful termination of me. There is no way this man is of our original locksmiths because our original know godfrey and michael well, and they likely would have never made a mistake that resulted in a fire hazard.



Almost all of the development here in the south Bronx is tied to the same influencers and investors. I am at war against things bigger than I could ever imagine for a simple humble living within this community. I was put on the front lines when I spoke publicly against dream charter school publicly, and now they have collectively, maybe inadvertently, come for my job, life among my peers and friends, and home.

The following would likely only be able to be verifiable by business records.

Our sprinkler company was switched to capitol sprinkler, which I know is operating in the dream school as well. Before this we never used Capitol we had made the switch recently. While it may just be a switch the nature of removing our old guy was suspicious as he served my company for longer than I have. I have seen this capitol sprinkler operate for the school, I am not ignorant and I paid close attention to realize that out of nowhere my company was suddenly sharing the same contractors that were recently introduced to our dwelling. Atlantic Fire was our original, and part of the deal is the corrupt changing of contractors to destroy our family image. BNS was one of the most family oriented and friendly companies, it is a shame to watch them sell out.

Capstantax was recently introduced into my company as well. I suspect that they too are sleeping with brookfield properties. I used to carry all of our heavy tax boxes down 4 and sometimes 3 flights of stairs. I did this as a favor and duty to my company, but now our taxes are being handled by a third party, which is unheard of as we had a man in the office who specialized in that ordeal and did his due diligence. I would not be surprised. They know deep down they would never find a man who would do that for 7 years, as most men these days are winded off a simple flight of stairs. Ziv Carmel, who is a major player in the company, inspected both the piano factory and glass works, because his company is now in charge of our taxes. Ziv Carmel is a very cool dude, but if I had known that my company was being taken over at our critical time as the south Bronx develops, by the same big deal players, I would have asked him the right questions. We enjoyed small talk, and I actually like the guy.

The company that used to service our gates before the swap was United Door/New york door, now this new company I have no clue who they are. Dream seeks full control of the parking lot, on 132nd street which is why many of my parole officers had a very hard time accessing it. On my side, the glassworks building, I have given them all the information and loop holes so that they could easily conduct whatever Parole business they could. Since the sally port in the back parking lot by my building is used to take parolee's who violated, to jail by picking them up in a gated area for easy transportation and a reduced fleeing rate. It is a critical part of their job so using the keypad and a trick with the sensor, they could easily get into the parking lot when needed. I even left the padlock open as a favor to all the men who worked within dream showing them the means of entry as well, hated me over the parking lot, despite how easy I made it to enter, and how little trouble I made for him when he and many other employees' parked wherever they wanted, including even in my spot designated to the BNS SUPERINTENDENT, which was me. How foolish I didn't see that BNS in the image I originally worked for did not exist. They have used this contract of the gate to control more dealings within the parking lot, hence why people have to pay for a parking spot now, and our number of spots have been reduced. I previously designed the parking lot on my side to offer space to 7 cars, One for each tenant and including many spots for parole's bureau chiefs. Now it currently only fits 4 on the 14 side, and many spots on the 26 side were removed as well. More evidence that the organizations involved had more power over my management than I previously thought.

If triton was building brookfield's property and rented one of my spaces, why would my bosses pretend not to know brookfield when so many contractors have switched, its because brookfield is feeding us money to have financial leverage over us by switching of contractors, which

resulted in them using said leverage to remove their opposition, the BNS superintendent of 7 and a half years. Eventually said leverage will be used to remove parole, and control whoever BNS rents to. Which also allows it to line up perfectly for the school's plan to potentially use my building glass works for the students hence why the 79/26 piano factory's old intercom system was not replaced. I still have the code to this building and can enter whenever I want, but my bosses dont want me in there, and I have NEVER sabotaged any of my buildings during this horrible time of unemployment.

On top of the control for 132nd street a new building is being constructed soon on the opposite side of my gate, the permits for 180 E 132nd street have already been obtained. You can see my beautiful glass works building on the left of this photo as well as my old 7 car set up in the parking lot which has now been down sized to 4. Careinge management is behind this new building that is why I also mentioned them in this network of developers who are doing this extreme take over. I will expose the architect connection next. This is just an example of the city based power these entities have over my company.

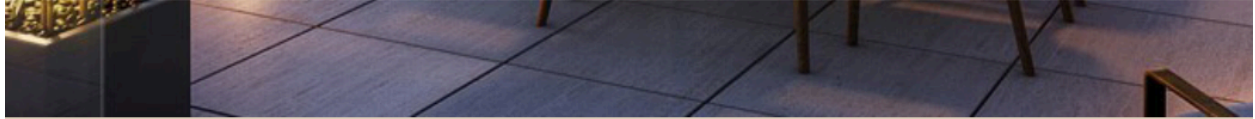

My bosses may be even unaware of all the financial implications these entities have but they know many, and have lied to me about who they knew, but I wondered explicitly who is slandering my name. On top of that my bosses drove me further into despair when they pretended not to know any of these people or connections, Especially when they denied knowing charlie, jorge, and eli weiss when I knew GDI worked with BNS as access to our buildings were needed, and I even heard them talking about meetings over a christmas dinner. Needless to say the plan to terminate me was long in effect, and I was very much aware. However, I work so well and diligently. They had no work related reasons to fire me, in fact they are simply doing it because of money, and to gain approval from this network of powerful people. So I had to pin down the network and how far politically it went up.

BNS has been heavily pressured by the south Bronx developers and their affiliates and thus these developers have used that leverage to destroy my life with shadow operations. Since our company hardships caused by the pandemic, they have done their best to continue operations, often tapping into building financial resources. When these developers of the waterfront met with them, they offered them a deal they could not refuse due to their hardships, and it eventually led to my wrongful termination. On top of it all, my bosses are getting ready to retire.

I have 4 Main bosses.



First is the CEO of the corporation Mark brookes, Mark brookes is a man who thinks life is a movie, he made a killing when he married into the bradford N swett family as he became the head of who runs things in the office, he is the only boss ignorant to not see how money could control the company. He is the only one who signed my termination paper, and honestly his wife would be ashamed of him if she knew what he was doing. You can see what type of character marries into a family, I suspect him to be morales, as he fired his hardest working man. He signed my termination paper with no shame and talks about "firing" people for less as if a man who marries into a family for money has a care in the world about a working man. He also plans to retire within the next 10 years. He attempted to use Anthony as the fall guy for my firing. He knows he is no man and thus hates me with such malice he doesn't care to make me homeless, and he would never tell his wife what they did to Danny Longmore's friend.

Chris Boyle pops up into the building around 11 o clock or 12, he keeps pretty standard hours but he is kind with a slight temper sometimes, but I never expected him to be the type to throw me out for money. He plans to retire within the next 5 years or so since he is the eldest of them all.. Chris boyle has no clue the amount of work I do because he doesn't really check anything when he stops by. He simply goes to check if Michael and Godfrey are in and knows that I am working hard. He has always stated that my work wasn't the issue of my firing and that there were bigger players involved, but he didn't expect me to know them by name. Or me to find out his opposition's money laundering scheme. He is under financial duress from these guys and since he needs to retire soon, he took a deal he could not refuse because the pandemic scared

him so bad when they started to go under due to nobody paying rent. At least Chris Boyle talks to his wife about me. He is quite older than all of my bosses. And he would never sign my termination paper. He knows how good of a job I do.

Anthony Reinglass is one of the greatest men ever, they had pinned me against him on purpose by putting him as temporary manager to my residential building. However he resigned and retired and left his position because he doesn't believe that bns should have sold out like this, and he also never agreed with my firing. Thus after summoning me to housing court he left the company to help me keep my house. I had gotten angry at him for telling me I would never get my job back. He had gotten sick of real estate and if I am correct has moved to Florida like he wanted, he is a true patriot of America like I am.

Brad Barr is an amazing man, he operates the finance and knows how much money I have saved the company. I know he knows that the pathetic 6400 dollars the developers put on my head was supposed to buy me out. But I never worked for money, and that is why I rarely asked Brad for a raise. I have saved the company so much money that by firing me they have already spent more than my firing date to year end salary.

They seek full control of the waterfront, and they also desire to control the landmark buildings we have by controlling who rents it, Glass works and the Piano factory, by back dooring my company in some crazy hostile take over, which in my opinion operates on a high level of criminality. They are using the school to even potentially remove Parole (One of our largest renting tenants) from the area which is part of their sinister plan.

This is an attack on all community members who have been here for years. These men are operating in secret. Thus they had their gang stalkers record me and documented me, presented defaming, slanderous, and false accusations as well as information about my private life and friends in private contact via email/phone calls/text with my bosses so much to the point where my bosses thought me to be capable of violent crime toward them, and even to sabotage the buildings I love. The slander of my character is evident by their police escorted removal of me from the gym on May 11th which by my termination letter my benefits should have ended on the 7th of June, and it states nothing of me not being allowed into my buildings. At the time of my removal, my bosses deemed me so dangerously evil that despite them being at the building while I was exercising, they refused to see me out of fear. Fear is a form of discrimination when all know I am a peaceful man who is capable of being rational, even when angry. Why would a man who served a building of nearly 8 years be capable of destroying the same things he loved? Worse, why would I harm the men who give me employment, and who I care for deeply, who I always felt I could trust. The truth is they knew everything they were doing to me is evil and it's so painful that it could have easily brought a man of moral character and even without my questionable sanity to do horrible things. Other supers who they have let go took full advantage of stealing company property, and even sabotaging the boiler room. I remember these stories because they were told to me by my late co-worker, Danny Longmore. My personal character was attacked so heavily that even my bosses thought I was capable of harming them. It's true we live in a world where men like me, who have nobody, who work hard

jobs, and lose everything they love in a moment often are driven into madness. I was in a madness state but I am no criminal, I am not evil, and this only fueled me further to figure out exactly what was truly happening to me. In fact my love for the buildings triumphs even the love I have for myself sometimes as I often sacrifice to ensure that the building runs efficiently, spending some of my own money, and utilizing my time to maintain it. I loved my buildings, and I loved my bosses, despite all the sinister treatment, I have remained lawful. I may be insane but I am not evil, and none of my mental state has ever interfered with me doing my job. I live alone, have no kids, and I work hard, and work out, it's all I have ever known and done.

The men in this matrix-like network who pretended to be looking out for my company with new deals are guilty for suggesting the belief to my bosses that I was a user of harder drugs. They are guilty for convincing my boss that I am irrational, they are guilty for causing my termination. This is why when they brutalized me in the hospital and did not find any, I tried to speak to my bosses about what happened to me, and I was terminated. They are guilty of spreading the belief that I was a demon who would be executing his revenge in illegal, vandal, or criminal fashion. I just wanted to work and be left alone. They are guilty for tricking my bosses into suggesting/forcing therapy on me over my job, they are guilty for getting my bosses to wrongfully terminate me in the first place. They are guilty of causing extreme discrimination of my mental illness, but so are my bosses for not believing in me. I still after all the abuse, crave my job back, it means the world to me, and if I am so deranged that I am mentally unstable and unfit for the world, what better place for me to be than in the neighborhood that accepts me and besides my bosses who know me, doing a job that I am capable of.

My bosses have not provided evidence or shown me any videos they have of me, but have attempted to use it in discussions in meetings about my termination. The footage originates from dream charter school spies, which I can validate from the fact that even their community relationship manager had threatened me with releasing the videos explicitly when I took a secondary public stance to defend myself and she had come out with 3 other workers to intimidate me. Self expression comes in many forms and having my level of passion is one of them. My final words when my boss confronted me about the recordings was if there was audio, and I said if there was audio everyone would see I was telling the truth. On top of attempting to confide in them about my hospital ordeal. That is when I was handed my termination letter. I have signed no agreement to my termination and now I have been sent to battle these developers who used the school to force mental illness discrimination on me, arrest me to try and build a psyche case, and force my employer to terminate me after attempting to force me into therapy which I denied, then tried in order of hopes of getting my job back. If being threatened to be arrested had sparked my "illness" to show, what good is using footage of my mental breakdown as grounds to fire me? I believe the harassment my bosses faced with said video to be cruel to both them and me. If I supposedly had a mental breakdown off the clock in my neighborhood, there is no grounds to even begin firing over conduct. I did not perform such conduct on the job. If I was standing up against unlawful arrest as I was, what better moral principles do I have? If I asked peacefully, did no crime, and did nothing unlawful when I protested, what good can they stop me for? If alcohol use was the issue then all should know the following: It is illegal to terminate employee's over use of alcohol, especially when use had

not interfered with their job, and use took place off work hours. The treatment of me is only fair based on a social agenda and perception that I do not fit in with. My socialization, my personal quirks, and behavior, are not proper legal or moral grounds for my termination, especially when I have done nothing but be a free man in america.

I asked to be trialed by the family and before all the company members, and even my tenants. I was denied this request, that is when my suspicions aroused and I figured out exactly who had bent over my company. Especially when my bosses have told my co-workers in private conversations that it was not their sole decision, and that there were bigger players involved in this decision which was unjust, they will deny this, but the biggest players were simply shareholders. When they attempt to force me into therapy, and tell my co workers that I need help, it is obvious they are discriminating against me and taking my job because I am a paranoid schizophrenic to them, and even if I was, it doesnt matter because I did my job well and I didnt deserve this torture, and I didnt want to lose my job, losing my job was my worst nightmare.

I had then made it my quest to find these bigger players. I even attempted to apologize to these bigger players but they refused to aid me in getting my job back. They knew if they kept me in my job position long enough, I would eventually figure out more about the terrible ways they operate to control the neighborhood, or maybe at least learned how discriminatory they would be toward the mentally ill. If I kept working, the mountain of evidence of their corruption, greed, and hostility toward all residents would grow. They hate me for several reasons, my beliefs, my self expression, but more importantly they hate the fact that I am friends with those who they deem degenerates to society. Why would my employer not let me be? If they had bigger players to submit to, what is the deal? It's because they have to play along with bigger players with more financial leverage. I am protecting my company where they failed to protect me. That's ultimately why my termination is up and about. I do not behave in a manner that the school feels is reputable for them, yet they do not know me outside of their projections of my self expression. They do not hear me or speak my truth, nor will they listen to those who know me to tell the truth. The school deemed me a demon, only because of their own hatred and need to persecute mentally ill individuals.

They have terminated my job simply because of my use of speech and what I believe in and how I live personally in the community. They hate me for my behavior which is deemed mentally ill. One fact that proves deeper discrimination is the fact that I continued my job after the main blackmail incident for approximately 3 weeks, until bigger calls were made. Never once were true duties to the job in question, words both my co-workers and bosses have spoken until they had received more pressure from these groups to switch up and fire me. This is an extreme violation of moral law and what doing the right thing is. If I did a good job, do I deserve to lose my livelihood and living? I can prove that dream charter school is even willing to use blackmail through their treatment of me with recordings of me through various private life activities, I can prove they had deals that caused my termination, and most importantly my situation is all proof that because I have the symptoms of what the world wants to call schizophrenia they hate me,

despite me living all my life like this. Yet when pushed to the near brink of losing everything, forced to clear out my belongings they held hostage under lock and key, losing everything, being without pay, and unable to get unemployment due to fraud, escorted out of my sanctuary home gym by police, and thrown into asylum by lies of the school, I have done nothing but stand before court rooms to defend my apartment.

They knew they would be successful in this route but did not count on me having known my enemies. Black mail only controls those who are embarrassed about what they do and have done, however through loose channels and spying they painted me as mentally unstable and pinned my job between getting medical help, forcing me to take leave and receive therapy which did not result in my employment being reinstated. It is illegal in New York state to fire people based on mental illness, this is the truth. The developers convinced my bosses to pin me between therapy and my job, knowing how much I hate the medical industry, their affiliates blamed alcohol use, but when I remained sober I still couldn't get my job back. I do not know if it's even legal to control someone's personal life in this manner for a job, but I was willing to give up alcohol if it meant I could work. Proof of my undying love for my job and current state of life.

The main event in this cascade of slander and defamation, in late/mid april, I took to the streets and performed the greatest protest known in the south bronx, in fact it is so well known that I have seen no recordings of it, yet all know it happened, and these recordings have been used to blackmail my employer into firing me. I do not want to live in a world where self expression is banned, and you must operate in a perfect manner of behavior that is controlled by not you, but others criticism of such. I feel all humans have a right to self expression and the cell phone was used to encourage my boss to get rid of me, a single moment of time nor defines my character, but to have shoved me with arrest threats that day and not see me arrested, they punished me with termination and other cruelty as a monstrous conglomerate that was not meant to be seen, but who would want to do that to me? Why is my boss not protecting me from these people who have connections at dream charter school? It seems like financial leverage would be an incentive. That's why AA wasn't good enough. I was also exhibiting the right to use free speech, something that is protected by our own bill of rights. I had conducted no crime, and no arrest or punishment was made to me until higher ups began to continue to defame me and cost me my job, all done to me on purpose with direct intent of ruining my life. The emotional distress they knew it would cause me, only allowed me to further prove my moral and principle integrity. The monster they see and saw in me simply is a figment of their imaginative creation, for their goal of terminating my life. It is a completely falsified matrix-like attack of powerful networks who seek to control the community by removing anyone who does not fit into their social standard. I am well aware of this, and I stand in the way of this, because I am friends with many on their list of people to remove being all the mentally ill, homeless, and even crackheads and criminals. Being in one of the most prominent positions as the superintendent of Glass works, and the Piano Factory. They know if they can get away with this, they will have full control to fire, remove, or damage the reputation of anyone enough to get them exiled.

I knew this was a hoax to demonize me because if anyone bore true witness they would've

known I was a sensible man. Many and all my community members know me as a sensible honest man. Plus the proximity of my life being close to my job, they sought to control me, they did not expect me to combat for my freedom. In fact they even didn't expect a silly super, who mops, sweeps, and fixes things to be logical, versed, and well able to combat evil with truth and words. They have set a stage to fire me on the simple grounds that I am too mentally unstable to be around a school, and too unstable to work my job, both of which are a fallacy because all the community know I am a rational and peaceful man. I had done the job for 7 and a half years, and my "mental illness" is still the same "mental illness" I've lived with all my life. I do not even consider my mindstate to be ill, I am simply me, how the world perceives me is on them. Yet I was told to get help, which was simply to control my behavior, and control my thoughts. Each therapist I visited wanted to medicate me, hurting me emotionally even further. The best help I have received was alcoholic anonymous who inspired me greatly to quit drinking to save my job, a task that I easily handled and remained sober for over 30 days in order to battle properly and as wisely as I can by working with my employer to get my job back. None of it worked.

I have even helped many teenagers from Dream. I do believe many of the youth to be welcome, and I protect them greatly. I know what it is like to be young, and I am not a bad example or danger to the youth, yet many from Dream will pretend this is the case, especially when my own bosses have thrown me under the bus. I've patched up wounds, given wisdom, and have been a great example of a man with principles and morals. In fact I do believe that the school will hate me for simply existing around children because deep down they are using the school to influence the community members and I suspect the students to have been on my side when I protested the arrest of my community member who was deemed mentally unstable. Many people from the community actively avoid the school, do not want to get involved, and fear it because of the powers it has.

A display of their level of power was a secondary stand on June 13th, i got in contact with dream the only way i know how, with the same discrimination they hate, i spoke my truth on the corner outside of where I live, and surely enough I got to speak to the community relations manager at dream after spilling all the trauma they did to me including taking my job, rather than face up to it, they locked me up in Lincoln hospitals mental health holding area for 36 hours. Lying and slandering my name again, pretending I was intoxicated with alcohol once again. They lied saying I was harassing kids when I was openly speaking to the public around me, practicing free speech. By pretending my intoxication they justified my arrest and holding. They lied. Police body cam will prove that I even requested a breathalyzer because I knew they would be lying. All the footage is recorded, there is no intoxication in my voice, I even mentioned in my stance when I do it sober what will they say. They even pretended I was in front of the school but in reality I was on the same corner of alexander and Bruckner, they lied to the psychiatrist too. Resulting in my extended stay of 36 hours. This level of cruelty was only done to me so that when I released this project they would attempt to paint me as illogical, a complete fallacy. If they could repeat this strategy of locking good community members up, and using their matrix network to spy and attack them as opposition, they will. I am only one of the many members of the community who has/will lose their spot and job if this isn't rectified and known. It comes from a matrix-like business entity that profited in near criminal ways and has pocketed politicians for

the takeover of the Piano District.

I am not just fighting for myself or a job. I am attempting to save all the community serving landlords, and families that lived here for years from people who have no idea what the Bronx really is. My 36 Hour sentence in Lincoln hospital taught me that it operated just like a prison for thought and behavior control. I found many of the people there to be more god fearing, moral, and kinder than these men who do corrupt business for the sole purpose of taking over poor neighborhoods. But I also knew that even at what is considered the lowest tier of humanity, these men and women who were in the ward with me, belonged with their families, friends, and loved ones who could care and understand them. I will fight the battle of freedom and self expression, as well as the right to be who you are for eternity. The truth is the school had enough power over this ward to cause what should have been an hour stay extended to a 36 hour psych evaluation. Simply because they were a school. This kind of police force leverage comes in so handy when opposition speaks out against you. You can simply lock them up for doing no crime, which is what they did, they hate being ousted for their activities for all to judge, because unlike me, it will be their own actions that make them look bad, where mine are simply a twisted perversion of the truth they would like others to pretend to see.

The irony is there was a lady with a microphone protesting the school but she was not locked up, or arrested like me. The day she did this was Monday, June 26th. Since they could not use her behavior neighborhood quirks against her, she was left alone.

All my job duties have been done properly for years. Better yet as I battle them with words, I only make more and more sense. It is very sad that we will eventually live in a world that polices everything you do and cast their own judgment on whether or not you should live, or live in exile. I have been sentenced to exile for fighting for the freedom of all my neighbors by those who develop and plan neighborhoods. I have been deemed unworthy but I refuse this damnation. I will be trialed before the people if anything. I believe that part of the reason I am targeted is the day my protest was launched, the children stood with the man who was arrested, and likely caused turmoil with the staff over his arrest, he was cleared of all charges and freed two days later in what i considered the most beautiful display of how proper the law could be, and how scared dream charter school really is about the truth behind their dealings. I cannot prove this solely on my own, but I am certain it was when they explicitly started to attempt to get me removed from my job. Staff of the school threatened to arrest me before I began my first protest, after I had gone to the school nicely to tell them to help take leniency on my friend. They thought I would do nothing with the threat, but the threat reminded me to stand up on principle. So when I finished my 3 hour protest for my friends freedom, which resulted in no arrest of me, no punishment of me, they decided to blackmail me with footage taken out of context, and harass my bosses into deeming me a monster. I know they are behind the footage because when I performed my secondary stance they confessed to having footage of me. Staff will deny the original threat that they spoke to me over the phone. But were fully able to take advantage of this power the second time I stood up to them on the corner of Alexander and bruckner.

Brookfield/Dream charter/Maddrealities/Joy construction and a massive network of developers are behind this since I stood against their arrest and torment of community members with the school. They used the way I expressed myself to deem me a Devilish character who was capable of crime and harming children as they seek to control the whole parking lot on 132nd street, and the Bruckner blvd between Alexander and Lincoln for school buses. Yet they bid on parking spots which are sold on payment for all my tenants in both the piano factory and the glassworks building. I am highly upset that as a result of the schools take over, I am being bound to homelessness, was removed from my gym with police force, and my property was placed on lock and key despite my job benefits ending June 7th, to add to my misery and pain, they have decided to terminate my phone on May 23rd as well as my parking spot, they even have gone as far to pay me a measly 140 dollars from a check that used to be 1200ish every two weeks. I am still working at 129 Alexander because my co-workers cannot begin to handle my workload. One is nearing retirement age, and the other does not share the same love for the buildings or skills I have. They have only recently been paying our cleaning company to take out garbage. I am still repairing, and doing my best to perform daily duties for the building as I am since I lived in this apartment for 7 and a half years as its rightful superintendent. My boss simply sided with the school out of fear, and through that same fear the bosses justified their poor treatment of me and discrimination of my perceived mental illness.

The original plan was to have me take two paid weeks off to require/force me into therapy, something not legal, but once I refused, they looked for any reason to terminate me because the discrimination was already deeply rooted in their hearts from these stalkers, and harassment done to them by the school. After that I said I would go in hopes of getting my job back. Yet they preemptively stopped my checks. I have received no check since, and to top it all off a false unemployment claim was filed on my name to deceive my bosses into not trusting me. whether this is related or not is up to suspicions but given all I have gone through I do not doubt it was. On the day my phone line was terminated my bank card was also hit with fraudulent charges which may or may not be related. This was filed simply so that it would be impossible to reconcile things with my management. I did not collect unemployment as I truly believed in getting my job back, and I still do, I have held out financially as long as I could, and am currently attempting to try to receive it as of 6/20/23. It feels wrong as I simply deserve my job back, but given they have forced me out of work, I no longer have a choice.. I had gotten help from alcoholic anonymous known as AA and on June 7th I was already 20 days sober, perfectly in line with a month of leave to supposedly "fix myself". AA helped me a lot because unlike the forced therapy, they did not seek to medicate me, they had only given me the advice I needed.

I have done no wrong on the job and I am fighting my wrongful termination on behalf of all my tenants, on behalf of those who do not believe that people should be persecuted for their private life, and for my community's freedom from the unnecessary and targeted harassment done by the new charter school and the displacement of businesses and people by developers who do not truly seek the betterment of the neighborhood. I am also battling for freedom for those mentally ill to have a place in society and work especially when they have been doing it with a proven track record for years. I did not need help, I simply needed my job and to be left alone. I was not failing job duties, they had begun to pretend I was while pretending to be ignorant of all the other failings going on, while lying to me about the new network of partners. I was the hardest man working in the 3 man crew and I created tolerance and leadway for all my other co-workers because I understood the buildings and truly loved my job. I was made a specific target because of who I was mentally, spiritually and my beliefs, and from a school that provided defamation against using it against me to harass my employer.

Their greed is unmatched and they have zero issue crushing lives, businesses, and taking over landlords going through financial hardship caused by a pandemic which they profit off. I am one if not the only man left brave enough and tactically placed in a position where I could prove all things.

They claim I am mentally unwell yet when pushed to the breaking point of police escorts out of my gym I've done no crime, when pushed with my belongings held hostage I did not steal them back, when facing possible eviction from my rightful place in the south Bronx, I simply am going to face whatever happens to save my life from destruction, protect my company, and serve both my employer and the neighborhood. When stalked and recorded constantly, I did not lash out at my recording stalkers. They sought a target they deemed mentally unwell and attempted to make him a criminal. They were unjustly punishing me and pushing me toward crime or maybe

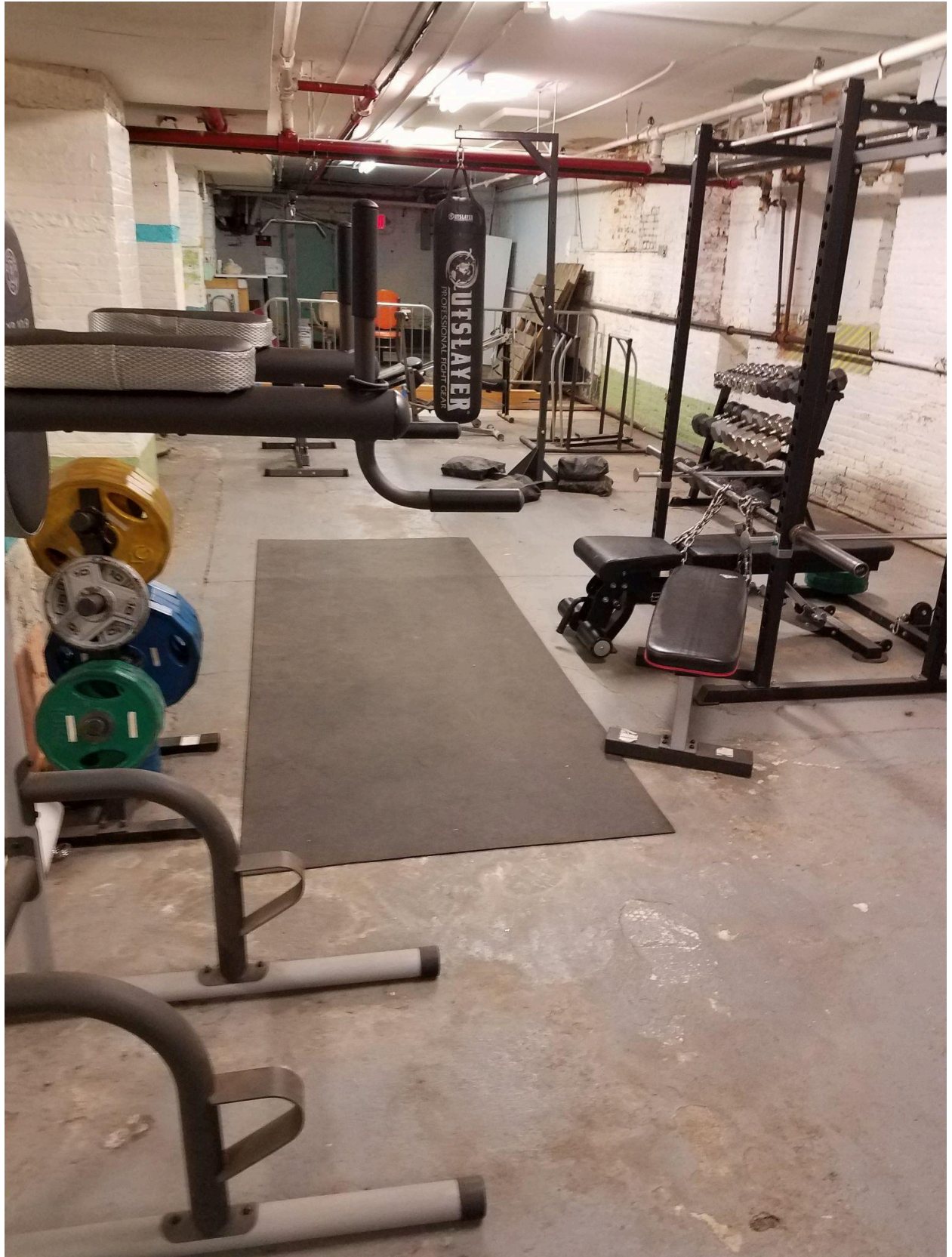
even suicide. Even after being sentenced to 36 hours in a psyche ward, I came out and have done no crime. The level of cruelty I am facing is more than enough to jeopardize someone's emotional well being so badly that they would never recover mentally, commit crime or revenge, and cause them to break. However I am strong and I remain hopeful that I will indeed get my job back, it is all I want from life, and I am willing to continue to battle for it. My bosses asked me to sign a release form which I refused because they wrote it not to protect or help me, my life here, and all my plans, all my friends, all my work, and all I've done for my buildings, and how much I have loved my buildings, I refuse wholeheartedly to sign my job away. I refuse to lose my job, I do not deserve to, and I know for a fact I do not. This is not sent to me on BNS's accord. My company would have never fired me, because when it came to the pressures of the world with covid vaccination, they accepted my religious exemption, and made no effort to rid my employment because I was too valuable to the company to lose. What is happening to me now is coming from someone else's accord. I was too valuable of a company asset to lose and I still am given my experience of 7 and a half years working the same job.

No matter what they have already failed this mission, as all know me, know me, and how I behave is not up to their decision to control. My bosses were pressured into asking me to go to therapy/medical treatment to keep my job, an idea suggested by the same ones who demonized me simply because the developers seek to silence me with recordings sent to my boss. Yet whenever job duty called I had always completed any task asked by my boss. I even still work after this incident to fix things and take out garbage as well as clean the building I live in..I have made every attempt to rectify the situation, I have made every attempt to compromise, and yet here I am still asking for the same thing, my job. I do not believe there is a single person who would battle this hard to keep a job, but this job is my right as long as I work well. I am receiving unfair treatment by them and I can easily prove it based on the fact I was the hardest working man on a 3 man squad.

I am not going to go quietly into the night, and soon all will be revealed and I will be vindicated. I seek to return to my job without the fear of wrongful termination, with full freedom to express myself in my life. Oftentimes I may walk around and appear to be talking to myself but I am talking with god, self expressing and relieving myself of stress that comes with life, none of this is illegal, and if that makes me mentally unwell, so be it, but it is not just or fair to terminate my employment on these grounds. I seek BNS to have the same power over its own decisions as it used to have. Should I have failed my duties on the job, I would have gladly accepted my termination but I was not fired over my work. This is an attack on my life and principles. It is retaliation based on the fact that I protested the arrest of a 10 year long community member who chooses to live in his car that was done by a school I consider the developers' new power tool. It is pressure of them dropping out of financial dealings with BNS that have forced my bosses hands as well. The evil developers took advantage of my company's crippling situation during the pandemic. The school took advantage of my odd behavior to influence my bosses to view me as a monstrous criminal who needed to be removed. Dream charter school was placed tactically by these evil men who develop to remove all community members, businesses, and operations they feel are undesirable for their development plan. More importantly they are

attacking landlords with deals and offers that are very hard to refuse. Many landlords were damaged during the pandemic and these offers came with strings so heavy. BNS had terminated me, their best employee, the most locally known man, and their biggest foot on the ground in the south Bronx development process for reasons that do not help, aid, or support my company or benefit them at all in the long run. It was immense discrimination and horrible pain that I faced and I still just want my job back, to me my job was my everything, it was all I had.

I have signed nothing, and I have not agreed to anything, and I am already at discourse to lose everything I ever owned. I am in the final fight for my right to remain a community member through all the struggles of my torture session which includes suggestive job termination to force me into therapy to supposedly keep my job, a fallacy when after I've been clean for 20 days my job has not been returned to me. My bosses are being backdoor controlled by these people due to the deals, I am not surprised when my job was terminated, I just knew to find my enemies and find the influence they had in my company. It was blackmail, slander, and back end business deals that caused them to have this extreme level of influence over my job position. It is hatred for the mentally unstable, and it is hatred for anyone who is different in this world. My company kept me working in the pandemic despite my refusal to wear a mask, and my refusal to get vaccinated and my refusal to get weekly testing, I was able to remain employed and working because I was one with the buildings, I was diligent and well suited for my job, and I was the best and hardest working man they had in the south bronx. To say that BNS would have never naturally fired me is not an understatement. There are bigger powers at play, and I have found them.



In the midst of my gym removal, BNS has now decided to renovate the basement of 26/79 alexander, to better suit their new clientele that they will host at 26 bruckner. Much of the old waste and debris have been cleaned out of the basement including old pianos that must have been there for centuries. It is very obvious that my firing has become a tactical business decision which I defile in my work efforts, and all the years that I have never charged for my after hours labor. It is a shame that I have been fired for foolish financial gains, but also a sham that they would use my firing to clear out a multi century basement, when I would have gladly moved my equipment for them to perform their work. I am curious to see who rents this spot in the future and to see if their collusion is indeed with the school for monetary gain.

I was quickly locked out of glassworks by unknown contractors and their digital intercom, tortured by NYULangone forced medical treatment which obtained proof I had no hard drugs in my system. I had nobody to talk to about what terrors were done to me, and when i tried to emotionally confide in my bosses and I was terminated, and their next attack was being escorted by police from the 40th precinct out of my home gym in 26 bruckner that I have built, trained in, and used for many many years as a stress relief to my very difficult job. But I still feel I am righteously a BNS employee my real enemy is BROOKFIELD /DREAM CHARTER SCHOOL/MADDrealities who owns GDI that build the school/Joy construction, who is using a school, money, and power to destroy the lives of not just me, but any community member, business, PAROLE and even landlords that have operated in my community for years if they do not see them fit to have around for their final plan which is many years in the making, they damned me to this fate because I stood in the way of their corruption when they locked up my friend and stood up for parole's place in the neighborhood and have been an community member of SEVERAL YEARS. They have sent footage of my protest to my bosses in an attempt to embarrass me. Ultimately it serves as blackmail that I am immune to, as only my bosses are deceived but they are not as deceived as they say. The truth is in part of my firing they are protecting their financial deals done behind closed doors that I did not have knowledge of until after I was terminated. I STAND fully in the way of the evil coalition's takeover and thus my enemies have sought to eliminate me strategically for development of the south bronx. This is the ultimate displacement but they have never expected me to learn, write, or see.

Parole's lease policy requires a 24/7 super as many officers work diligently on schedules that you could not imagine. I have done this job for 7 and a half years. Part of the school's plan is they seek to remove parole from around the school by tactically setting up the school in between our buildings which are landmarks. By placing a school in between parole they will argue that parole shouldn't be near a school and people who fail to understand that they had to take me out first are ignorant to the evil in these men's designs as they pretend to operate on moral principles. Since my job only exist because of parole, once parole is gone, I suspect they will attempt to buy even my home at 129 Alexander and turn it into co ops through the same shadow channels that my company is being ran by and controlled by brookfield/madd realities operating in the dark secrecy of the company I once know. I serve only the the Bradford N Swett family and I will not stand for this take over as I suspect that loss of our old level of control of these buildings is not in good faith of Mr. Swett's will, ask the men who pushed him in a wheelchair if he would have done this, but they have already begun to deal with the devil of

development forcing them to terminate their hardest working super.

I have seen even my closest friend Danny Longmore pass away on this job, which he taught me to fight for eternally, and I am eternally fighting. I knew this position would be pressured in time by forces beyond my control once my bosses began talks with Eli Wiess, Jorge Madgura, Joshua Weissman of JCALI and Charlie Howe for control of the block by the school and 132nd street. I knew a school would hate me simply because I am "mentally unwell", I even knew the school would just label me as a danger to children and teens but I never suspected my bosses to wrongfully terminate me for my "mental illness". I will not stand for my own removal or termination which is both cruel and abusive, anyone reading this will know I have died metaphorically, and lived on principle. I want to return to my job. I believe Dream seeks to take over parole's spot in Glassworks at minimum hence that is why Carson is installed there. It is part of their school fantasy to have glassworks as a center for the school as well as they intend to serve grades K-12, currently they only have high school aged youth in the main building. This is why one of my tenants' spaces was rented to what my bosses considered to be the worst tenants while the other remains vacant and un-shown, it is easier to get one tenant out of two spaces than it is to get two out of two different spaces. These deals take time, and are thought of long before its execution. You must do them in secret, in patterns only the hyper observant will see. But more importantly they seek to completely remove parole from this neighborhood.

They have painted me as a mentally unstable monster, and even sought to arrest me for working out in the building I served for many years even before my final benefit date which was meant to be June 7th. If I was locked up it would have been an easy case for them, but since the 40th precinct recognized me, they took leniency on me despite the claims that there was a man capable of harming his bosses in the gym he owned in his bosses building. I thank the 40th precinct for their kind treatment of my friend/neighbors/community members. They operate very well and are some of the best if you ask me, but I know they are under the same political pressures too as soon they will be forced to move from their iconic landmark spot.

Rendering of the new 40th Precinct designed by architectural firm Bjarke Ingels Group

After almost a year since the latest round of plans and renderings for the new 40th Precinct to be constructed in Melrose at 149th Street and St Ann's Avenue, plans have finally been submitted to New York City Development of Buildings.

The \$50 million facility will be the first of its kind in the city combining a precinct with a community space with a separate entrance.

Police and community relations in the 40th are strained thanks in part to years of the NYPD's abuse of stop and frisk tactics (one of the highest uses of the controversial tactic in NYC).

This social experiment will be interesting to see how it plays out combining the public and NYPD in this state-of-the-art building.

Designed by Danish architectural firm, Bjarke Ingels Group, the building will be almost 50,000 in size representing a 475% increase in size from the current 10,000 square foot station house on Alexander Avenue and 138th Street in Mott Haven.

The current landmark precinct is simply too small and was built in 1924 to serve a much smaller population.

In fact I can prove that the Bjarke Ingels Group works with Harlem RBI especially in the work at HESTER STREET. So it's not surprising they would move the precinct collectively.

The school had already used the police force for against said community member because of his proximity to life by the school and his economic and social status which is why i had no choice but to stand firmly against it especially since I knew they had placed me in the same group especially since I was threatened with arrest before I even stood up in the art performance, I had tried kindly asking, when I was then hit with that threat forcing me to stand up for righteousness with what some may call PTSD. Of course this network's spys and associates decided to record me out of context and send it to my boss, resulting in a damaged reputation that forced my boss to discriminate against me on grounds of mental illness. Now it has come my turn to lose my job by the same powers who had arrested my friend unjustly, they will repeat this strategy as long as the people let it work. When they cannot fill the position properly with a man of my same caliber and principles what will they do? When my buildings decay they will call contractors, by their will there will be no longer a community member who is not vetted or controlled by them serving in any proximity of the building. When the community loses members and associates it has known for years, who will rise up? I was the only man brave enough to show them their wrongs would be spoken of publicly. When these same men come for every landlord who suffered in the pandemic who will be in the way? I will be standing up for BNS forever. I work for BNS not the school, why do they have such influence over my job? It screams financial leverage, but if not financial leverage then my bosses are the fall guys to the dismay of discrimination of the mentally unwell but best believe the entities hate the mentally ill as well which is why they arrested my friend. Everyone pretends to be a good righteous person but look how they treat anyone they view mentally unfit.

If the future has no need for me and my job, and if my job has to go, what do I have left? I can find a new job but the levels of pain they have put me through to simply get me out of here has been criminal and wrong. My protest was conducted in April only after the man in the staff of dream, threatened me with arrest over a phone conversation because I had politely went to the

school to ask them to take it easy on the man who lived in his car in our community for ten years. My protest was such a success and a work of art that it was recorded and sent to my boss by dream charter school's gang stalkers only to make sure I was fired. Imagine having artwork so powerful that it results in a loss of job, loss of home, loss of gym, and loss of parking spot, as all knew my job was the reason I had those things. I worked for those perks, and they had no problem using my self expression to remove my job. They had no problem retaliating against me to take my job for my protest because my bosses are in bed with the school and brookfield properties. I risked all my kingdom to do the right thing, how many people would have done so? I am the type of man they fear beyond illness beyond it all, they hate those who get in the way of their wrong doings. If they hate the mentally ill so much that they force them to get fired, what good are they? At the time I did not see it as a risk because I thought I worked for BNS, I did not realize the deals and partnership and influence these men had over my company and bosses. They deemed me dangerous and mentally unstable, and thus have discriminated against me to the point of a wrongful termination, preventing me from working out in the gym I had for years as well. I tried to comply to get my job back but nothing worked. The hatred the developers have for mind sickness and self expression is uncanny and leaching into my company like corrupt seeds. My bosses fell for it and now after 7 and half years decided I needed to be gone.

They hate me because I have been the community member who stood on a strong moral stance and expressed his mind against their corruption so they sought to terminate me expecting me not to be able to voice or express myself. I suppose all schools look down on men like me as illiterate just because we choose to do physical work, never went to college, and simply have a small humble living without the fantasy or lies or dreams of major success. However here I am wisely using words and constructing my thoughts just as well as they pretend they have superiority in doing. To learn and grow is not to be limited, hence why as I learned to fix many things, I have expanded my ability to speak and reason as well. I used to be bullied in school, how ironic that a school has chosen to bully me in adulthood.

I have dealt with both parolees and parole officers, and I have never gotten into any bad situations with these people, in fact many parolees are happy to see me working, and often recognize me. I was the face of building maintenance to these people but I was shamed in a blackmail and slander campaign. I have no criminal record but my ability to navigate the mentally ill and understand even some of the criminals, made me a target. How could a man get along with so many different walks of life? Because I believe in paradise, and I knew how easily I could get along with any man or woman as long as I understood them. Yet this coalition of dream charter school, brook field properties, and those developing my neighborhood, hated me so badly that they sought to have me arrested too so that they too could paint me as a criminal but what have they done to drive me to that state? Yet I never faltered, I always respect the law despite my constant outside drinking with friends.

This school has no problem slandering people and using police force to do so, they enforce their lies. They continue their slander, and they act as if their actions aren't the reason for my

removal. The first time they could blame alcohol and since it was after school hours, they could do nothing. The school wanted to arrest me so badly, so the second time when I was sober speaking to myself, they decided to send me to an asylum with lies about my intoxication. Their cruel treatment of me is CRIMINAL. Not only did they remove my job, it wasn't enough, now they have to pretend to be trying to help me, by sending me to hospitals, and keeping me locked up for extended hours. The community manager lady knew how bad it would look to arrest the same super who got fired so she attempted to talk me out of both releasing this bombshell of information to people, and to pretend as if dream did not remove my job with slander. The school found me an easy target because I drink, because I have no wife and kids, and because I am vocal with weird behavioral quirks to discriminate against me on grounds of mental illness. But this community manager will never do her due diligence and see her own footage of the day Juan was arrested where I went to the school nicely first. When kindness was met with arrest threats, I went to the streets to bring my brother home. She believes she will find a disgruntled super or something reflective of the man they deem a monster, but instead when she finds out she will see a super pleading for good treatment of his friend.

They refuse to admit or correct their wrong doings of me, the guilt and lies they spill will eat them at night. They lie, they have lied, and will continue to lie to defend their evil conglomerate from being looked into, researched, and figured out. She is just a plant they put in the neighborhood to remove men like me who are onto them and mentally ill, just as Jcal plants many in their network of big business partners to take over Mott Haven. This plan of slander and taking out community members will continue, they can do it to anyone, they have the police force on their whim and call, and will continue to place unnecessary pressure on them to remove good community members. They ultimately refuse to own up to the fact that they have used out of context footage with the most dangerous weapon in America, a cell phone, capable of catching men and women at their lowest moments, capable of causing good hard working people to lose their job.

When you are threatened with arrest, when you see your own friends and community members removed from a school that claims to be a dream, when you speak out against it and lose your job, then report you lost your job only to serve a sentence in the psych ward, who will be there to defend you? My job was taken from me, my life is terminated, and there is nobody else but me to discover this evil network that is gentrifying the neighborhood, crushing anyone who speaks out against it, getting rid of any undesirable neighbors, and using police powers and school leverage to do so. I am hated because I am deemed mentally ill.

They have slandered and harassed my boss with footage of me and pretend to be innocent parties. Blaming me for my explosion, when the reality was I was on to their corruption. They are cruel, and had no problem making sure I end up homeless. The holding period was not meant to help me but instead an attempt to break my will, and pacify me from releasing all the lies and campaign against me. Business ties, worker lies, a strong discriminatory hatred toward the mentally ill, mixed in with pandemic money, and desire to control the street, I am attacked with this simple ordeal. They have collectively determined I am too dangerous to have in what used to be the poorest neighborhood in the Bronx, because gentrifiers have deemed me a Demon.

They are protecting their own by making up the same lies. No relationship manager can answer why over the phone they threatened to arrest me for asking the school nicely to take it easy on my friend. Instead they continue their march of slander and attack me right on the block I live in. They are trying to remove their guilt of getting me fired with malice and falsehood of trying to protect me, by sending me to a mental asylum for discovering their whole plot. Ironically I do not lie, but liars and slanders surround your kids, hide 80 million they could be using on your children, and destroy the lives of community members who have principle and integrity. I continue my record of doing no crime or wrongdoing still after every ordeal. The truth is they hate me. They cannot break me, and nor can they buy me out. I know their operations, and I know how dangerous they are, but I am not afraid of tyrants, I am not afraid of people with money, yet they fear community members like me. Soon they will clear out anyone they do not want in the neighborhood.

I believe this take over plan to extend to the removal of the projects, by relocating the 40th precinct to ST and they could ruin community policing eventually the projects will be a shameful disaster of crime, justifying the removal of the buildings. This plan is many years further down in the making, so it's not too relevant here. Just know it will continue beyond just the underpass that serves as a divider of gentrification and the bronx roots.

Here are the habits they smite me for, and best believe it is nothing worse than what any of your friends, family, teachers, or community members do. Remind yourself always that these people go home to real nice lives, real nice wives, real nice pockets, some with children and cars, and MORE MONEY than I could ever make in my lifetime, they talk multi million dollar deals. Yet their corruption and greed and their desire to influence the next generation completely, they chose to assassinate the living of a building superintendent with no wife, no children, a little bit of money in his pockets with a home gym, and a plethora of tools and skills, a old car in their parking lot, for his mental state and beliefs, which they know through their network of gangstalkers. They even hated me for working on my own old car in the parking lot of my building, something I had done for years before their arrival. They also need me gone because I was the only one who stood up against their neighborhood clean up operation. They took my friend, they took my job for defending my friend, but what did they expect me to do when I have no job. I am still fighting for just simply my job back, and this manifesto will remain permanent and true. They hate the mentally ill. They do not like men like me who are honest and hardworking. I will be fair and give you all my habits so that you can see what they hate me for.

I LOVE to smoke cigarettes and weed.

I LOVE to drink wine, beer, and I love to do it outside with my friends on the block. The 40th precinct knows us well.

I am on good terms with almost everyone, I have been peaceful and I have no criminal record.

I protect my friends to the end and I will always speak against injustices.

I seek to be free without control over my life by employers or those who control big deal developments. I have no problem working and working hard for a living but that has been stripped from me.

I am capable of having a peaceful yet seemingly off means of speaking to myself and spreading

wisdom out loud. Free speech is a human right..

I believe in GOD, and I talk to myself and walk around the neighborhood on watch at night to keep my neighborhood and loved ones safe.

I did NOT take the Covid vaccine, a major hatred that many people have in their souls that they cannot seem to relinquish.

My terms are simple, I even begged to be reinstated but nothing is working against these developers and they successfully changed the hearts of my bosses as my begging and pleading doesn't work.. In fact I have seen my tenants mourn for my loss, and believe I should have my position back. I am fighting to the metaphorical death, they painted me as a monster with blackmail, I have been through so much pain to simply keep my job that I have done well. I am tormented every night, and while Dream charter school pretends to get children to achieve their dreams, I am being crushed, dominated, and the way I dream to live is being destroyed.

My terms are Just, and proper, reinstate me as the super, ignore the pressure.

I seek the following.

I do not want money, I have escaped greed long ago, they cannot buy me out.

You will return every property to me, and they will be declared landmarks of the united states of america.

I want my freedom of self expression to be validated and protected by my employer, I lived in America all my life. All I know is freedom.

I want nothing more.

In the mean time my Dream is simple, the court will see the torture I have been sentenced to for self expression and worse of all my BNS management will continue to be forced to endure this unfair pressure and control these financial conglomerates have over them.

It will be a disgrace and unlawful violation to Title I of the Americans with Disabilities Act (ADA) and Section 501 of the Rehabilitation Act of 1973 (Section 501). With this manifesto I feel even the people will have enough information to judge whether I am correct, I feel that many if not all of the community will see that I was forever of good moral character, all the community will see my persecution and exile. I will forever keep and provide my testimony until justice is served. I believe all I know and everything I've been through to be full testimony to the power, corruption, and pain that these developers bring when they ISOLATE community members from their development in the community, based on personal behavior, based on their own bias toward others and how others live, based on hatred on what kind of mental illnesses neighbors of a school can have. I believe all will see the unfair pressure and financial pain family landlords dealt with in the pandemic only to be saved by devilish deals from developers who sought this neighborhood take over from all angles of society.

This is the real form of gentrification that destroys individual lives, takes over land, and hurts good family landlords, takes over businesses, as well as an extreme displacement of members of the community and worse of all it discriminates harshly on all accords. But I will not forgo my home, I CANNOT let these developers get away with displacing me and others within the neighborhood. I am simply one of many dominoes to fall but they did not expect me to speak my

truth, they wanted to keep my quiet in the dark as they wrong me. Those who do evil hate being ousted.

If I am granted nothing, I will seek vengeance by simply telling the truth I am no criminal. The BNS superintendent is coming for the developers of the south Bronx with logic and honesty. This testimony cannot be erased from the memory of those who knew, heard, saw, or read or witnessed my suffering. This testimony is just a simple part of my ongoing war. A war of the neighborhood, as I am at battle against those who will deem anyone or any business or any land owner, who lives/operates here unfit to be part of their development plan.

I stand alone, as simply the super of BNS real estate and for bradford n swett's true will. I sought to be tried by the company alone but because backroom deals, private conversations, blackmail, and persecution of perception of my life has damned me to this destruction of my LIFE. All of BNS, and all their original contractors know I have always done a good job. I have never failed my duty to get along with all business partners and companies that aid and work with my management. However, these deals by organizations and developers who hate me based on my self expression and mental illness, have forced my company's hand to wrongfully terminate me. I stand to fulfill my duties as a company employee, I seek only reinstatement of my life, I seek only that developers leave community members, struggling landlords, business and my management alone, and stop using their financial leverage to accomplish their botched and corrupt DREAM of owning all of the south bronx. When they could not arrest me, they took my job instead for simply doing what a man who has been here for 10 years does and defending his place in my neighborhood, and when I spoke out of what they did to me in a second stance, they locked me up in an asylum. A one man army display has deemed me inoperable for their plan because they find me repulsive through their hatred of men like me, my knowledge of their evil plot, and my awareness to oust their wrong doings.

I had no plans to bring Indignation down upon these people but they sought to bring their judgment on me, without jury, without trial, with leverage over my bosses through deals, and finally blackmail and gang stalking of my private living. Thus I have exhausted all options but to fight with words. I am no criminal, I am non violent. I live alone, I have no children, and I sought to simply be left alone, but they refused. They hated me for how well I worked, and they hated my existence simply for my own choices of alcohol/weed, my very own beliefs, existence, my mental state and my own dream but most of all my ability to stand up for what is righteous even with peaceful rage and fury. I have no apathy toward life, and I do not think life is a game or movie. I know life to be good but I am aware of how evil chooses to conduct their corrupt idea of business. I may be mentally unwell, and the arrest threats may have triggered me but these are no grounds to fire me, tortment me, or take abuse of my life to such extremes.

I am on the front lines of the communities freedom, the right for all men and women who have been here for years, to live and do as they please in the south bronx while men with more power, money, and sinister desires step up to destroy our natural living based on what they deem unworthy to be next to their school. I will not be ashamed of myself, especially when all see I have told nothing but the TRUTH. This is a gentrification attack that comes in the form of

terminating long standing employees who are aware of their wrong doings. They do not know the full story of my life and they simply hate how I behave, who I am, and what I do and believe in, and when they witnessed how passionately i spoke against what they did, they deemed me insane and mentally ill, since I was now their opposition they sought to take my job intentionally by sending my protest footage to my boss, who was scared of their financial leverage over him, so he yielded to their idea.

I am standing in the way of a conspiracy that is indeed criminal, to round up and displace all members of the community who are deemed delinquents, to control all businesses that operate in the area, and to take over landlords who have owned property in the neighborhood for several years, by the school preferential treatment by false perception of truth, through use of the school's power which is only one seed in their plot, a second seed being financial leverage over suffering landlords and business who struggled through the pandemic, all because they have deep rooted partnerships with those who profited in the pandemic's suffering, and have politicians in their pockets. The organizations involved plan to repeat this strategy over and over again on unsuspecting community members. I am sure, there is much much more information to be found on this network but my testimony is simply just a start. Soon all will come to light.

As it stands there is not a single civil rights leader left, there is no man to represent the community, good landlords, and good businesses, there is simply money and big deals that are controlling everything while hard working people ,and long term community members are DISPLACED/EXILED/REMOVED. Long term businesses are taken over financially, and Good Landlords are being manipulated by deals and offers that come with strings, all because they stood by their tenants who couldn't pay during the pandemic. I have risen to this moment not by my own choice, but through the injustice of blackmail, slander, termination, and destruction of my life, I have been sentenced to exile without judge, or jury, suddenly then I realized there was a bigger battle I did not see. I am fighting for my company as well. I am crazy enough to expose the wrong doing to me because of my mind's condition.

Ask your school what dreams they can fulfill if they crush the dreams within their community. Ask the coalition of evil and all their partners how much money they made during the pandemic while good landlords suffered.

Ask community members who should have control over the south Bronx, those who have been here for years? Or those who sought opportunity to take over with leverage from a pandemic? Why did BNS not protect me against these people?

If they attempt to paint me as having a mental illness, everyone knows it does not interfere with my job, and I am in the same mental health I have been since I started the job. It is a great disgrace to the law. In this case since I lack a diagnosis they simply have believed what the school says.

The Americans with Disabilities Acts (ADA) protects employees from discrimination based on a disability—including [mental health conditions like depression or anxiety](#). That means you cannot legally be fired just because you have one of the following:

- a physical or mental impairment that **substantially limits one or more major life activities**;
- a **history** of such a disability, or if an employer **believes** that you have one, even if you don't; or
- a **record** of, or being **regarded** as, having such an impairment.

All parties involved, including my bosses, view my spiritual beliefs, my religious beliefs as means to take my job away all because the school has decided to harass them and torment them with footage of my personal life. I believe the level of harassment my employer faces from these developers caused them to discriminate against me for my mental health thus provoking their attempts to force me into therapy, and ultimately my termination. My bosses accepted my religious exemption because they trust me fully, my bosses know all my behavior quirks and liked me for it, it was only until this needless, wrongful pressure and defamation from these new partners caused me to be sentenced to exile, removal, and to destroy the life i built here in the the neighborhood. I worked hard untested, unmasked, and unvaccinated during a pandemic for my buildings and my employer. I am being taken out of the location that has people and businesses that accept me. I am being taken from the job I love, and I am being taken from the buildings that loved me. I used to collect inanimate objects as a kid and give them names and they were living to me. Now I believe even my buildings are weeping on my removal. I need to be returned to my rightful place, without fear of this level of corrupt high level discrimination so that I can die and live in peace, the pursuit of happiness, and with freedom that is only found in America. My company needs me, my buildings need me, my neighborhood needs me, and I need my job. It made me truly at peace, and I was truly happy. I suppose I could find happiness somewhere else but I fear I will never be accepted. There is no way I can let this stand without me utilizing all of my ability to refute it. I cannot let corruption continue in secret when it has taken my life from me.
