

Screening and Training Protocols

Dioceses, congregations, and other organizations must screen all persons according to the **Screening and Training Protocols standards.** For some positions, screening consists only of a Public Records Check. There are additional screening requirements for other positions of a written application, interview, and reference verification. The chart on the following two pages is a standards checklist for each role within the congregation and the Application Requirements and Training Requirements.
