WHEREAS

The PhD position and the scholarship are governed by the laws and regulations in force in Italy and at the home institution, in particular:

- Ministerial Decree no. 226/2021:
- Ministerial Decree no. 118/2023 (Next-GenerationEU the Italian 'National Recovery and Resilience Plan') which, among other things, provides for periods of study and research in Companies, Research Centres or Public Administrations from a minimum of six (6) months to a maximum of twelve (12) months, for scholarships in the fields of 'Digital and Environmental Transitions', 'Public Administration' and 'Cultural Heritage', and that the PhD student may use qualified and specific operational and scientific facilities for study and research activities;
- Ministerial Decree no. 117/2023 (Next-GenerationEU Italian 'National Plan for Recovery and Resilience') which, among other things, provides for periods of study and research in companies from a minimum of six (6) months to a maximum of twelve (12) months and that the PhD student may use qualified and specific operational and scientific facilities for study and research activities:

COMMITMENTS OF THE PARTIES

The Home Institution undertakes to
