	snow damage on the side of the building and add an overhang to prevent this from happening
	again. Shane was impressed with Mark and with the quality of the bid. We have funds that have
	been earmarked for this project along with money from the insurance company when the damage
	occurred. Shane wants to check out a few things, like what concrete work is already in place. We
	thought it would be better to use steel instead of wood for the posts of the overhang for less
	maintenance in the long run. Erica will ask Mark about a timeline; then Shane will contact Mark
	about moving forward. Can this be completed before winter? Debbie moved, Ross seconded to
	accept Mark Draper as the contractor for a multi-phase project to 1) repair the snow damage to the
	east and west sides of the building, 2) make improvements by creating a roof overhang, and 3)
	upgrade the north and south sides to match the new construction on the other two sides. We are to
	make it clear to Mark that our budge is not to exceed \$60,000. UA
