VI. IFLTA Reports (as needed/available)

- a IDOE Chelsea Isley
- Certificate of Multilingual Proficiency Updates:
 - We worked over the summer to clean up the <u>2021-2022 End of Year Data</u> in preparation for the Locally Created Pathways review (more information below). This provides additional context about the students who earned CoMP the year before last, and will be a steppingstone to compare the data that's rolling in now from the spring.
 - o The required End-of-Year feedback form was sent out at the end of June, but many people were out of office on vacation for the summer (thankfully, they deserve it! (a)). So far we have only received 26 responses from the total 85 participants, with 250 students earning the award. The languages represented so far are Spanish, French, German, Arabic, Japanese, and Korean. The deadline to submit this information via JotForm is September 1, 2023. A reminder email will go out next week to keep this on the radar, and closer to the deadline we will send out targeted gentle reminders. We've been struggling to complete a data request for more concrete numbers from transcripts, so it's important that this information is more accurate moving forward.
 - o The JotForm to sign up to participate for the 2023-2024 school year has not been publicly shared yet via Dr. Jenner's Weekly Update, but it is open for schools to sign up! Sign up here as a reminder, this is a low-risk intent-to-participate JotForm that will share your contact information with IDOE so that you're included in all communication and reminders we send out and will allow you to receive the CoMP template at the end of the school year. If no students end up earning CoMP, that's okay! You'll just submit that data at the end of the year as well.
 - o Informational webinars about CoMP with updated resources, data, and guidance will be held on September 14, 2023 and March 7, 2024. The links to join will be shared on the <u>IDOE EL PD Calendar</u>.
- Dual Language Programming Updates:

- o In the spring, there were 24 Dual Language Pilot Program grant applications. The funding available was \$425,000 (the same amount since 2021 when it was reduced from the initial \$500,000 in 2015) and that will be the same amount available next year. All the same programs applied from last year as well as Batesville and Goshen, who have received the grant in the past but did not apply for a couple of years. Additional funding and support is needed as many of these programs continue into the middle school and secondary space. We do have one new program Lafayette School Corporation! who will begin their planning year this school year and begin enrolling for the 2024-2025 SY.
- o This year, in an effort to ramp up professional development to support the state's DLI programs and help foster the DL community and networking in the state, IDOE is offering a variety of events throughout the year:
 - Three "Office Hours" sessions which are relaxed, one-hour targeted PD presentations for all DLI leaders and educators with collaborative components and resources. These will take place from 3:30 4:30 p.m. ET:
 - #1: September 21, 2023: Dual Language 101
 - #2: December 5, 2023: Monitoring Target Language Acquisition
 - #3: May 2, 2024: Bridging Language
 - In-Person Networking Day: On March 5, 2024, WIDA will be hosting a one-day in-person PD to introduce their Marco DALE framework that focuses on Spanish language development. This has a dual language focus but could be beneficial for any bilingual teachers. The next day, March 6, (back by popular demand!), IDOE will host an in-person networking day for dual language leaders, educators, and staff members.
 - Bi-monthly Dual Language Leadership PLCs: Every other month, IDOE will host a dual language PLC for the state's dual language leaders to network and discuss important topics related to dual language programming (such as staffing and professional development, family and community engagement, target language assessment, curriculum and resources, and secondary programming). Any leaders that are interested in learning more about DLI programming are welcome to join as well! The dates, once finalized, will be posted on the EL PD Calendar.

IDOE Updates

- o English Learner (EL) Exit Criteria Change Proposal Open for Public Comment
 - IDOE is seeking to adjust the state's exit criteria for ELs, and the drafted proposal which includes the possibility for additional evidence review in determining proficiency as well as WIDA Alternate ACCESS exit criteria is now open for public comment. Review the details of the Indiana Exit Criteria Change Proposal and provide feedback via this Jotform. Public comment closes at 5 p.m. ET on Monday, August 28. IDOE will then review and respond to comments, finalize changes, and submit a state Every Student Succeeds Act (ESSA) plan amendment to the U.S. Department of Education. Contact IDOE's Office of English Learning and Migrant Education with any questions.

- o Two new language-focused Locally Created Pathways <u>officially approved in</u>
 <u>July by the State Board of Education!</u>
 - This is as very exciting win for language learners across the board. I'm currently working with the Graduation Pathways team to see what this looks like in action, but plan on sharing more information as we collaborate with Perry/IPS/MSDLT/Highland during their first year of implementation. For now, I want to get the word out that the LCPs have been approved, so that districts can be thinking about how to implement and leverage these opportunities for the next school year.
