# MINUTES OF A JOINT SPECIAL MEETING OF THE BOARDS OF EDUCATION CITY OF LAKE FOREST SCHOOL DISTRICT 67 LAKE FOREST COMMUNITY HIGH SCHOOL DISTRICT 115

March 9, 2021

Governor Pritzker recently extended the disaster declaration related to the COVID-19 pandemic for all Illinois counties to April 4, 2021 Based on the current public health concerns, the Board Presidents of Lake Forest School District 67 and Lake Forest High School District 115 as heads of the public body, have determined that it is neither practical nor prudent to hold an in-person meeting of the Boards of Education on March 9, 2021. The Board Presidents have further determined that it is not feasible for the public to be present at the public body's regular meeting location due to the health concerns related to COVID-19. This Board meeting will be remote and comply with the procedures set forth in Public Act 101-640 that Governor Pritzker signed on March 5, 2021.
