Pursuant to Section 3012 of the Education Law and in compliance with Part 30.3 of the Rules of the Board of Regents to appoint David Smail, who holds Provisional New York State Certification permitting him to teach Biology 7-12 in the public schools of New York State, to the position of JSHS Science Teacher in the Academic (Science) tenure area for a probationary period of four years, to commence on August 1, 2023 and to expire on August 1, 2027 (unless extended in accordance with the law). This expiration date is tentative and conditional only.

Except to the extent required by the applicable provision of Section 3012-3 of the Education Law, in order to be granted tenure the teacher must receive composite or overall annual professional performance review ratings pursuant to Section 3012-c and/or 3012-d of the Education Law of either effective or highly effective in at least three (3) of the four (4) preceding years, and if the teacher receives an ineffective composite or overall rating in the final year of the probationary period the teacher shall not be eligible for tenure at that time; and that David Smail during his first year of this appointment be paid at the annual salary as outlined in the agreement between the Dundee Teachers' Association and the Board of Education, dated July 1, 2021, as being the salary for a teacher on Step 14 of the current agreement plus any hours or degrees.

5.1.1.5. Pursuant to Section 3012 of the Education Law and in compliance with Part 30.3 of the Rules of the Board of Regents to appoint Simone Blount, who holds Initial New York State Certification permitting her to teach Childhood Education (Grades 1-6) in the public schools of New York State, to the position of Elementary Teacher in the Elementary tenure area for a probationary period of three years, to commence of July 1, 2023 and to expire on July 1, 2026 (unless extended in accordance with the law). This expiration date is tentative and conditional only.

Except to the extent required by the applicable provision of Section 3012-3 of the Education Law, in order to be granted tenure the teacher must receive composite or overall annual professional performance review ratings pursuant to Section 3012-c and/or 3012-d of the Education Law of either effective or highly effective in at least two (2) of the three (3) preceding years, and if the teacher receives an ineffective composite or overall rating in the final year of the probationary period the teacher shall not be eligible for tenure at that time.
