

Fairview Township Annual Meeting Minutes

March 7, 2023

I. Call to order

Angela Jackson, Township Clerk, called to order the annual meeting of the Fairview Township at 7:03 pm on March 7, 2023.

II. Roll call

The following persons were present: Mike Seiner, Max Andersen, Todd Mockler, Jamie Neitzke, Angela Jackson. Guests in attendance: Mary Anne Meyer, Laura Murphy, Dustin Carter, Glenn Pulse

III. Approval of minutes from last meeting

Minutes from March 1, 2022, annual meeting were read and approved as read. Minutes from the February 28, 2023, regular meeting were read and approved as read.

IV. New business

- a) Mike Seiner made a motion to re-elect Max Anderson to a position on the Board of Supervisors. Todd Mockler 2nd the motion. All were in agreement. Approved. Mike Seiner has rotated into the role as the chairperson.
- b) Max Anderson made a motion to elect Jamie Neitzke to the position of Treasurer. Todd Mockler 2nd the motion. All were in agreement. Approved. Jamie Neitzke took the oath of office and was sworn in as Treasurer.
- c) Mike Seiner made a motion to re-elect Angela Jackson to the position of Clerk. Todd Mockler 2nd the motion. All were in agreement. Approved. Angela Jackson took the oath of office and was sworn in as Clerk.
- d) Clerk reviewed and presented the annual report. Max Anderson made a motion to approve the annual statement. Mike Seiner seconded the motion. All were in agreement. Approved.
- e) Bills were presented to be paid for \$189.00 for Broadcaster press; \$97.94 for Sturdevants, and \$287.50 dues for SDATAT. No deposits. Motion to approve Mike Seiner. Seconded by Todd Mockler. Approved.
- f) County Weed Contract - Max Anderson made a motion to hire Clay County Weed to spray the ditches this year for weed control. No contract has been received so far and Angela to reach out to the Highway Department to get a copy of the contract. The contract will include that records for what and where

was sprayed need to be included with the invoice. 2nd by Todd Mockler. All were in agreement. Approved.

- g) Two gravel bids were received and read by Todd Mockler from Pollman Excavation for \$14.93/ton for gravel and \$19.30/ton for crushed concrete. Rechnagel Construction was for \$15.80 /ton gravel. Max Anderson made the motion to accept both bids with Pollman as our primary and Rechnagel Construction as backup. Second by Max Anderson. All were in agreement. Approved.
- h) Wages for Maintainer – Max Anderson made a motion to raise the wage of township maintainer operator from \$21/hr. to \$22/hr. Todd Mockler 2nd the motion. All were in agreement. Approved.
- i) Wages for additional staff time - Mike Seiner made a motion to set the salary for additional time provided by the supervisors during emergency situations and over the scope of their job descriptions at \$20/hr. and for additional time over the scope of their job descriptions for Clerk and Treasurer at \$20/hr. Max Anderson 2nd the motion. All were in agreement. Approved.
- j) Snow removal and gravel needs - There were no changes made from the previous year's snow plan and maintenance funds. The board agreed that the funding and plans are adequate for the coming year. Dustin Carter, guest, expressed that the road at 4400 block of East Main needs gravel every year and more snow removal.
- k) SB1 Levy - Mike Seiner made a motion to apply for SB1 levy at \$ 0.50/thousand for road and bridge improvements and \$200,000 or maximum for the general fund. 2nd by Todd Mockler. All were in agreement. Approved.
- l) Burbank Schoolhouse report by Rebecca Kruse via email - AMS has begun the ceiling repairs. She was told the sheet rock was delivered recently but have not heard back from Nick Slattery that it is all completed. When the AMS project is complete I will share the final bill and any additional information with you.
- m) Road and right away issues - Laura Murphy reported that the grade on east main needs attention. Angela Jackson stated there was a couch and recliner dumped in the right away on 466 avenue just north of hwy 50.
