Approval of Minutes

Public Commentary and Guests

President Farr opened the meeting by suggesting we address our guests and their topics. The meeting proceeded with discussing the fire hydrants and sign maintenance, followed by a discussion of the purchase of 1 Briar Lane by the IL PGA.

The Village of Niles representative (Pete and Ronnie) left at 7:26.

Tim O'Neill, president of the IL PGA Foundation (the charitable arm of the IL PGA), introduced himself and discussed the history of the organization and their programs. Carrie Williams discussed the IL PGA and how they operate as a member service business, with a small staff of 7-10 personnel, also visiting many events around the state. The group is very interested in being a good neighbor and excited about the opportunity to own the building. There was a brochure about the IL PGA distributed to the Board.

Trustee Dominick asked about the future of the organization, providing more context on the future usage of the building. President Farr provided history about the Village of Golf and its founding, to provide context on the fit of the IL PGA as a business. Trustee Miller asked about the timing of renovations, and Carrie relayed that they would like it renovated as soon as possible, targeting a move-in around Fall 2022.

The IL PGA representatives left at 7:41.

There were no other participants in the discussion online (a conference line was open during the discussion).

Police Report

Chief McEnerney distributed his monthly summary of activity and had nothing else to report.

Engineer's Report

Brian Wesolowski is still looking to determine what IEPA will require of the Village for the CSO permit, the village is currently in violation, more will be forthcoming at the next meeting.

Legislative Matters

The updated zoning ordinance and approval of the WGA to IL PGA documents were discussed. Each document has been updated with all changes and distributed to the board.

Trustee Kalogerakos moved to approve the resolution of the consent to the sale of 1 Briar from the Evan Scholars Foundation to the IL PGA Foundation, and jointly approve the agreement of covenants, agreements and easements. Trustee Dominick seconded the motion.

Reports

Approval of Bills

Emergency Services Department

Nothing to report.

Building and Zoning Department

Trustee Tillman shared that a resident inquired about installing solar panels, and we do not have a building code to guide the Village. Bruce had drafted a renewable energy ordinance that would address wind and solar structures, which Bob Hammer and Trustee Tillman have reviewed. The Board discussed various approaches and other villages and their approaches, and will look in detail at other examples.

Public Buildings and Grounds Department

Trustee Shine shared that he talked to TruCut and asked them to address specific areas. He emphasized that we wanted quality work given the increase in price.

Finance and Administration Department

Trustee Miller shared that our cash position is very strong.

Streets and Sanitation Department

Trustee Kalogerakos brought Pete and Ronnie, public works independent contractors, for an explanation of the signage and fire hydrant (maintenance) costs and implementation. They provided details of the review of the village fire hydrants and signs. They would provide a 5 year guarantee for their work, and also do hydrant flushing. Trustee Miller and Trustee Der Avedisian asked questions about the maintenance and costs for signs and fire hydrants. The repainting will occur after flushing the hydrants and would be done by October 2022.

Trustee Miller moved to approve the repainting all of the fire hydrants to the amount of \$6500. Trustee Kalogerakos seconded the motion.
