VI. Membership - Explained by Membership VP Anurag

- A. Deadline: September 22
- B. Requirements:
 - 1. Grades 10-12, Seniors are required to join prior to their final semester
 - 2. Cumulative weighted GPA of **3.8** or greater (+0.3 the 3.5 from the previous year)
 - 3. Minimum of 10 Hours verifiable community service
 - 4. All other requirements are listed on the form
 - 5. *Seniors must pay an extra \$10 ON TOP of the \$5 renewal/application fee*

VII. Volunteering Opportunities/Committees - Explained by Service/Volunteer Chair Akansha

- A. Service Opportunities
 - 1. Organizing both virtual and in-person events
 - 2. You must have at least one event this semester (to stay as a member)!
 - 3. (First opp) Helping in the library: Come by during your Gael!
 - a) Work: Checking in and shelving books, running errands / delivering books, refilling mask trays
- B. Committees: Three fundamental committees within the National Honor Society
 - 1. Fundraising Chair Justin explained the duties of the Fundraising Committee
 - a) Main purpose: To propose fundraising events (preferably in the local community) to have funds necessary for future payments/events.
 - 2. Event/Social Chair Medha explained the duties of the Induction Committee



- a) Main purpose: To plan out the eventual Induction Ceremony as required by the national bylaws for all future inductees of NHS.

 - a) Main purpose: To carry out unique community service events for all NHS members to contribute valuable time, benefiting the community at-large.
