



On-board rules  
**Anubi Project**

Definitions:

**Shipowner** - Owner of the vessel and designates the captain and crew

**captain or Skipper** - Maximum Authority on board

He/she is responsible at all times for the fitness of the craft to navigate and its conduct, he/she has the right at all times, if he/she deems it necessary, to vary the planned itinerary and/or to stop the craft depending on the meteorological or safety situation.

He/she is responsible for the routes taken, the landings and the navigation of the vessel.

It is responsible for the protection of the health and life of the persons on board

He shall be responsible for relations with authorities, infrastructure and other units at sea, whether directly or indirectly related to the craft's activities.

He/she shall be responsible for the education and certification of the crew for all shipboard duties

It is responsible for educating Guests on emergency procedures.

He shall hold the judicial authority on board.

In the event of rest or incapacity, he shall designate his replacement.

Designates the shipboard finance officer

Help with shipboard duties

**Crew** - permanent crew

Carry out the progress of shipboard duties

Provide mooring and anchorage during landings in support of the captain

He/she is responsible for the departure operations, the dissolution of the moorings, the raising of the anchor assisting the captain in the maneuvers

The designated officer shall be responsible for the management of on-board finances

It handles the exchange and the supply of essential goods for survival

Help with coordination in case of emergency procedures

Provide sentinel/lookout service to support the commander in case of distress sailing.

It deals with relations with Guests, before, during and possibly after the cruise.

It deals with relations with partners/suppliers on shore.

He is responsible for cleaning and hygiene on board.

**Guest** - Person who, for remuneration, benefits passively from sharing the cruise, it does not participate, unless he wishes, in the duties of the ship.

**Traveler** - Person who actively participates in the on-board duties, for remuneration or free of charge, during the cruise and carries out the on-board duties assigned to him by the captain (for example in case of crossings, sentry shifts, cooking, cleaning of the boat) Statute this decided before the departure of the cruise.

**Main vessel** - It is the mother ship with which the cruise is carried out

**Support boat tender** - Small boat for movement from the mother ship to the shore and vice versa

**Cruise** - Voyage period of the vessel between embarkation and disembarkation

**Shipment** - Period comprising a single journey from one location to another

**Rada** - Anchor mooring in a bay or haul

**Pension** - act indicated in the cruise agreement including: breakfast, and accommodation.

**Meal** - main meal, lunch or dinner

#### **Art.I - Foundation of Anubi Project**

Anubi Project, born from a project of Sandro and Donatella and bears the name Anubi in honor of the adored four-legged friend who disappeared following illness. The doctrine of Anubi Project is based on the sharing of immersive experiences in the wonders that marine life offers. It is not for commercial purposes, but rather for a shared travel offer in which each party pays for the expenses generated by the journey.

#### **Art.II - Crew composition of Anubi Project**

In order to ensure the execution of the cruise sharing project, the Anubi Project, requires first of all a suitable vessel for the purpose, which can accommodate both the crew and the Guests. The minimum crew is composed of a captain and a crew member/hostess. In the event of navigation in distressed waters or for other special needs, the crew may be increased. The crew shall be appointed by the shipowner.

#### **Art. III - Navigation areas**

The Anubi Project, with the purpose of immersive cruises and exploration, will move progressively in the seas of the Mediterranean, Tyrrhenian, Adriatic, Aegean, Ionian, Ligurian and then extend towards the Atlantic and Pacific oceans, exploring the Indian Ocean, the North Seas depending on global stability and safe navigation.

#### **Art. IV - Cruises**

The Anubi Project, offers two types of sharing at the cruise:

1. Weekly (extendable) cruise with daily landings - Weekly cruises are shipments in which daily stops are planned and tourist activities, cultural activities, visiting places including fun. To the weekly cruises, will be admitted all the Guests that meet the minimum requirements of health and mobility necessary for the life on board, in case of disability The Anubi Cruise Project will assess specifically the individual case, after consultation between the parties, the safety on board eligibility of the Guest.

For the safe admissibility on board of children under 12 years of age, a personalized consultation will be done in due time, for the definition of the size regarding individual life-saving appliances and the special needs of infants.

In any case, a form of registration to the cruise will be drawn up in advance with the specific needs for each individual Guest.

2. Ocean or long-distance cruises (crossings and long-distance routes) - Oceanic or long-distance cruises are shipments in which there are no daily stop. Their purpose is to transfer the vessel or the continuously practice at sea.

#### **Art.V - Guests / Travelers**

The Guest is the one who is boarded or ready to board. Guests must be provided with identity documents (e.g. identity card, passport, residence permit) valid according to their nationality, for the country or all countries touched by the itinerary. For some destinations, a passport expiration period of at least 6 months from the date of return

may be required. It is also the Guest's responsibility to obtain any residence and transit visas and health certificates that may be required. It is the Guest's responsibility to find out about the travel documents required for boarding. Anubi Cruise Project will be able to deny access on board to the Guest without the required valid travel documents, without acknowledging any refund of the price paid or any compensation for the non-enjoyment of the cruise. For each Guest, after completing the "IO" form, the program of the cruise will be arranged, according to the personal needs to which the Anubi Project will, as far as possible, do everything necessary to satisfy them. In any case the program of the cruise will be adapted according to the needs dictated first by the safety on board.

#### 1. **Minors**

A minor is defined as a person who has not reached the age of majority according to the law in force at the time and place of the cruise; In any case, minors who have not yet reached the age of 16 years will have to be accompanied by a corresponding number of adults prepared for their constant surveillance. The adult is responsible for all actions committed by the minor(s) entrusted to him, both on board and on shore. Minors aged 16 years and up to the age of majority at the time and place of the cruise will require written consent from the parental authority or their representative and at least one responsible adult accompanying them. Responsibility for actions committed by the child(ren) on board as well as on land shall be borne by the guarantor of the child(ren).

**The traveler** is the one who announces himself and participates in ocean cruises or long distance routes without daily stops. It shall participate in the ship's activities with duties assigned to it by the captain. Unless agreed beforehand, it shall pay a fee equal to its daily requirements for supplies, but shall, in return, travel free of charge, in any case the arrangements shall be initialed prior to boarding. Only travelers/Guests with a valid travel pass may be taken on board, subject to assessment by the captain of his/her abilities.

In exceptional cases, by prior agreement, a Guest may participate in an ocean cruise or long-distance route. The captain may, in cases of imperative necessity, involve the Guest in shipboard duties, such as sentinel or food/cooking duties.

The captain shall assess the eligibility on board the traveler after consultation and registration information.

Customs practices are the responsibility of the captain, therefore the Guest or traveler is required to inquire about the quantities of goods or cash subject to customs declaration for the countries touched by the cruise and to declare to the captain the quantities purchased and/or transported by him before boarding the consignment in which the territorial waters between two or more countries will be passed. The captain will decide on what to embark or not, in order to be able to request free pratique (yellow "Q" flag) from the port country.

#### **Art.VI - On-board Regulation**

The following points of the rules of procedure must be complied with in order to ensure the smooth operation of cruises, better co-existence on board, respect for the maritime/coastal environment and the persons on board:

1. **The captain** is the highest authority on board both the main craft as well as on board the tender support craft. It shall be responsible for boarding and drop-off, for vessels, crew, persons taken on board and safety on board. He shall have the right at all times, if he deems it necessary, to vary the intended route and/or to stop the craft in accordance with the weather and safety conditions.

***The decisions of the captain shall be unquestionable.***

2. **Safety on board** - The craft shall be equipped in accordance with the safety standards required by the applicable maritime legislation. This equipment includes individual life-saving appliances (greater than or equal to the maximum capacity of the persons on board), life-raft, fire-fighting appliances installed in cabins, corridors and technical rooms. An annular lifebud installed externally. The locations of all safety equipment shall be set out in the safety plan displayed in the common area. Before boarding the cruise, Guests will be informed about the locations of the safety equipment and the behavior to be taken in emergency situations. The use of or interference with equipment, technical equipment on board, instrumentation, steering system and/or maneuvers on decks is prohibited without the consent of the captain or the crew. In the event of a declared emergency, Guests or travelers must comply strictly with the instructions given by the captain and the crew.

3. **Freshwater** - Freshwater on board is a precious and limited resource, especially during the slipways in the rough. Unnecessary waste should be avoided, therefore the use of taps should be limited to what is strictly necessary and should not be left unnecessarily open. It is also essential to provide short showers limited to the minimum necessary.

4. **Electric current** - The vessel is equipped with direct and alternating electric current. Especially at Anchor, it is limited. In the event of excessive use of electrical power, the crew will be forced to operate the auxiliary generator, resulting in noise and odor caused by exhaust smoke. It is therefore essential to turn off all the switches after use and not to connect devices unnecessarily. The crew will be happy to answer your questions on this matter.

5. **Toilet sanitary services** - The discharge of on-board toilets is undersized compared to domestic toilets, therefore it is forbidden to throw objects, non-biodegradable toilet paper or excessive accumulation of toilet paper in the toilet as it would result in clogging of toilet discharge.

6. **Communication and wireless networks** - The vessel is equipped with a wi-fi and satellite system. These connections are provided for the management of navigation activities and for safety. One of the aims of Anubi Project is to rediscover life and its beauties, without the necessity or limiting to the minimum electronic devices and social media. The network will therefore be made available to Guests, only in mandatory situations, in the absence of mobile phone network coverage of the Guest. The crew must be asked to access it.

7. **Deck services** - It is forbidden to use the linen and towels provided to the cabins outside them. Cabin daily cleaning by the crew is not included, as is the replacement of bedlinen, except in unforeseen situations.

It will take place at the beginning and at the end of each cruise, together with the cleaning and disinfection of cabins, bathrooms and common areas.

Wet entry into common deck spaces or cabins below deck shall be prohibited.

8. **Personal objects** - For the good coexistence, to avoid damage to the boat but especially for the safety on board, it is asked not to leave personal objects in the common spaces and in the passageways. Personal items shall be stowed and secured to prevent damage to the craft structure in wave-generated or navigational situations. The Anubi cruise Project disclaims any liability for damage to the personal property of the Guest due to sudden movements of the vessel.

9. **Footwear on board** - Unless you have previously agreed with the crew or in an emergency situation, please store your footwear in the appropriate stern compartments and move to the boat on barefoot, for your safety and in order to avoid damage to the walkable surfaces. For external decks, shoes specially certified for nautical use and never used on land are allowed.

10. **Pension service** - The Anubi Cruise Project offers a pension service including accommodation and breakfast, included in the cruise agreement. You will be offered the possibility to make meals on board, which will be charged individually according to the cruise agreement. Traditional cuisine based on genuineness and simplicity will be offered. It also includes soft drinks and alcoholic drinks. When booking, we will ask for preferences, intolerances, allergies, as well as special desires of food or drink, to which we will be pleased as far as possible and available, to fulfill. You will also be asked about generally, how many meals you want to eat on board.

Requests outside the costs of the basic offer of the cruise will be charged separately. If you would like to go to the restaurant, we kindly ask you to be advised in time so as not to waste food already on board or in preparation. It is prohibited to use kitchen equipment or serve stored food without the permission of the crew

11. **Smoking - Undercover**, in common spaces and in cabins it is forbidden to smoke. Provision will be made for specially equipped front and rear areas. While respecting the environment, it is forbidden to throw cigarette butts at sea, cigarettes should be turned off with water and thrown in the ashtrays provided.

12. **Transport service on shore or on board** - For landing on land and return on board will be used the support boat tender. The tender may only be used if a crew member is on board. If you wish to go ashore, at any time of the day or evening, except in special situations that would compromise safety, the crew will be happy to accompany you on the ground and come to you on call at any time of the day and night.

13. **Cruise routes and destinations** - it is possible to make any changes from the agreed cruise program, taking into account the meteorological situation, the safety of the vessel and its guests, as well as the expected day of disembarkation in the location indicated in the agreement.

The captain will assess the route. It may be modified at his unquestionable judgment, depending on the weather conditions at sea, should this result in a lack of security for guests, crew or craft or for reasons of force majeure. In the event of any condition that would compromise the safety of the vessel and of the persons taken on board, the captain shall select the most appropriate place to proceed or to be secured.

14. **Damage** - Damage caused during the cruise by a Guest can happen. We kindly ask you to announce the damage promptly, especially from the point of view of safety on board and good education. The Guest will be liable for any damages that Anubi Cruise Project may suffer as a result of the non-performance of the duties imposed on the Guest, listed in this document. In particular, the Guest will be liable for all damages caused to the ship, its furnishings and equipment, damages caused to other Guests and/or to third parties, as well as for all fines, Anubi Cruise for which due to the negligence of the Guest concerned, Anubi faces a penalty by the authorities

15. **Services included in the cruise** - The following services are included in the cruise, unless previously agreed:

- Crew service and cruise operation
- Accommodation
- Fuel
- Instructions (optional) for the operation of a vessel and certification of miles traveled
- Use of on-board play equipment (snorkeling, mattresses, fishing rods, role playing cards, books...)
- Breakfast
- Snacks
- Drinks, non-alcoholic and alcoholic.
- Shore – board – shore transportation service
- Assistance with tourist visits to the port points

NOT included in the cruise

- fees for berthing in ports or marinas
- entry fees in natural parks
- Cleaning and disinfection of cabins
- The laundry service
- consumption by the Guest outside the craft
- medical expenses, excluding first aid on board
- any residence taxes
- the costs of ground activities, excluding those previously agreed, organized by Anubi Cruise Project
- All other activities not covered by the cruise agreement

**Art. VII - Registration, cruise and payment agreement**

In the course of registration, after the approval of the place, date and admissibility on board, the confirmation of reservation will be sent to the main guest. At the time of the booking confirmation, the payment of 50% of the total amount indicated in the cruise agreement will be required and must be deposited within **5 days** from the booking confirmation. It will serve as acceptance of the cruise agreement. In the event of non-payment within the period provided for, the agreement will be canceled definitively. The remaining 50% of the sum must be paid within **30 days** before the scheduled date of boarding. Should this not be the case, the agreement will be canceled and the deposit already paid will be withheld by Anubi Project. Together with the booking confirmation, you will be asked, through a form, all the personal information necessary to organize the cruise. This information must be submitted at least **30 days before** the date of boarding. This form is also valid as guest list, which is obligatory under maritime regulations. The rates for individual cabins or for the booking of the entire boat will be those indicated at the time of the booking confirmation and will not be subject to market changes. Anubi Cruise Project declines any responsibility or claim in the event of non-compilation, incorrect compilation or failure to forward the Guest form.

#### **Article VIII - 'IO' form, personal data release, health status**

The "IO" form, sent at the time of the booking confirmation, is a personal data sheet of the Guest, containing the data necessary for the success of the cruise and for making a service of high quality. The data contained in it will be limited to the exclusive use of the Anubi Cruise Project and will be destroyed at the latest 10 days after the drop-off of the Guest. In addition to the basic data (name, surname, date of birth, nationality, address, telephone and e-mail addresses), food preferences, allergies, wishes, etc., must be indicated on the "IO" form. This data will not be disclosed in any way, unless authorized by the authorities or with the consent of the data subject.

Any basic medical conditions and medications taken by the Guest **must be indicated**.

This is in order to safeguard the safety of the Guest himself, of the others and the generally health on board. The declaration of any illness is also essential to inform the medical radio guard in advance of the Guest's medical condition, in order to organize the rescue and evacuation of the Guest by adopting the correct treatment.

The captain shall assess the fitness for boarding. Guests with medical conditions for which it is not clear whether they are able to boarding shall provide a medical certificate of fitness. Individual cases will be assessed and discussed between the Guest and the captain. In the event of a change in declared health between booking and boarding, in particular if relevant with; motor disability, serious illness, person-to-person communicable diseases, situations not permitting onboard cohabitation with others, serious neurological illness, serious cardio-circulatory illness, the Guest shall inform the captain as soon as possible.

The craft is not equipped to accommodate persons with motor disabilities who require special furnishings in accordance with the rules on the construction of ships, therefore it is not possible to embark them.

#### **Art.IX - Reimbursement**

The reimbursement of all, or part of the sum by Anubi Cruise Project will only take place in the case of:

- Technical failures of the craft which are irreparable and which preclude safe navigation and subsequent cancelation of the cruise. In the event of repairable failures, partial reimbursement will be granted between the parties on the basis of the day or days stopped.
- Serious negligence on the part of the captain or the crew which precludes or has effectively precluded the safety of Guests. In this case, the formal complaint must be lodged with the captain immediately at the event and reported to the Maritime Authorities. Late or unfounded complaints will not be considered for possible reimbursement.

The following cases will not be reimbursed:

- Cancelation or variation of a shipment or shipments caused by endangering factors for the craft and/or persons on board, such as adverse weather conditions, bad Guest behavior, Authority decisions (excluding negligence of the captain), interruption of the cruise and drop-off of the Guest in the cases referred to in Article XI.
- Absence / undue delay
- Route change in case of SAR search and rescue assistance of other vessels in difficulty.

#### **Art. X - Handling of Guests on land**

In case of problems caused to the Guest while on the ground, Anubi Cruise Project remains available to assist the Guest in resolving the dispute, possibly mediating with the local authorities and the family members of the Guest in difficulty. The individual case will be assessed with regard to a possible interruption of the cruise for the Guest in question. But in any case the Anubi Cruise Project will do everything possible to ensure an appropriate solution for all involved parties.

#### **Art.XI - Interruption of the cruise and forced drop-off**

The commander shall immediately stop the cruise and disembark the Guest at the nearest place in the event of:

1. Repeated reprehensible action on board
2. Intentional endangering of other Guests or crew
3. Intentional damage to the craft
4. Possession and/or consumption of drugs on board
5. Possession and/or consumption of illegal substances or medicinal products on board
6. Holding of unauthorized and undeclared weapons on board
7. Undeclared possession of pyrotechnics and/or flammable substances on board
8. Intentional hijacking
9. Repeated disturbance and/or disrespect to other Guests or crew members.
10. Obstruction to any operation in case of emergency
11. Intentional obstruction of the cruise
12. Carriage on board and possession of objects listed in Article XII

For points 2, 8, 10, 12 the case will also be reported to the local authorities at the time of landing.



**Art.XII - List of prohibited objects on board**

- Any drug/illegal drugs, including synthetic drugs and marijuana for therapeutic use
- All weapons, including replicas or imitations and components thereof
- Air or pellet guns or rifles
- Ammunition
- Explosives, including imitation explosives and ordnance.
- Fireworks, rockets, pyrotechnic articles (excluding those forming part of the lifeboat's life-saving appliances or authorized by the captain)
- Weapons for cutting, sharp weapons.
- Lances or underwater rifles.
- Cross bows, crossbow darts and long arrows.
- Weapons which are blunt, stun or neutralizing
- Flammable substances and chemicals (e.g. coal, gasoline, denatured alcohol, paint thinners, etc)
- Any other article, manufactured, adapted or intended to be used as an offensive weapon
- Handcuffs
- Cooking appliances, immersion heaters, indoor heaters, infrared heaters, irons, water heaters, coffee machines with heating/hotplates, etc
- Emergency location transmitters, radios, broadband receivers (scanners), lasers and laser pointers.

**Article XIII - Aid to other vessels**

The maritime code obliges anyone who receives a request to be rescued, provided that they do not put their vessel, its crew and himself in danger. Therefore, a distress call could vary the pre-determined route, giving rise to SAR (Search and Rescue) operations. For this kind of unforeseen situation the captain could involve the Guests eligible to participate in the SAR operations, ordering them the tasks to be followed, in the event of these situations, they do not give right to any refund from Anubi Cruise Project.

**Art. XIV - Boarding / Drop-off**

Boarding usually takes place, except in the case of previous agreements, from 1630 on Saturday. This is to allow the cleaning and restoration of the craft.

Landings are usually made by 0830 on Saturday, unless otherwise agreed.

The boarding and drop-off procedures, except in the event of unforeseen circumstances or safety hazards, shall take place at the places defined in the cruise agreement.

After boarding procedures, the Guest shall be instructed on emergency procedures, the locations of the life-saving appliances, fire-fighting equipment, and all relevant information for the safe operation of the cruise, before sailing.

**This statement is required.**

Before sailing, any changes, details of the cruise, special requests or change to the situation declared in the "IO" form will also be discussed, in order to be able to fill any remaining gaps.

In the event of the unjustified absence of one or more Guests, after the necessary investigations in this respect, the Anubi Cruise Project reserves the right to sail without further delay.

Before the drop-off, cabins and common areas shall be inspected by the crew to ensure that any items that have been forgotten are checked.

Please let us know that you are asked to announce immediately and in any case before landing any damage caused during the cruise

With regard to the validity of personal documents, such as passports, visas, identity cards, etc., it is the individual responsibility to make inquiries with the authorities concerned about the need for travel documents. The Anubi Cruise Project, willingly remains available to gather information, suggestions or advice on this matter.

In order to board, you must have a valid travel document and admitted to the country or countries touched by the cruise. The Anubi Cruise Project recommends that you always carry your personal identity card, even on the ground.

Due to the limited space on board, Guests are required to travel "light", to minimize personal luggage and not to use hard suitcases.

#### **Art. XV - Guests**

If a Guest wishes to take on board a guest from outside the cruise, he/she shall apply to the captain or crew, who will then, after consultation with the other Guests, consider the feasibility of doing so. In any case, a guest may only be taken on board if the vessel is moored in port or at anchor. Under no circumstances may a guest be taken on board during the navigation, except in emergency situations SAR.

#### **Art.XVI - Pets**

In principle no pets shall be allowed on board. This is for reasons of space, motor and physiological needs of the pets during the expeditions or any allergies / phobias of other Guests. In addition, the rescue equipment dedicated to them is not on board.

#### **Art. XVII - Insurance**

The Anubi Cruise Project is covered by insurance for any damage suffered by weather factors, for damage caused to third parties, and for the protection of persons on board. For the structural or economic damage suffered as a result of voluntary, involuntary or negligent actions by Guests, the Anubi Cruise Project reserves the right to claim civil liability insurance for the Guest in question in order to cover the damage suffered. In serious cases, particularly criminal cases, the Anubi Cruise Project automatically st himself as Civil Part. It will claim compensation for the economic damage suffered as a result of the actions of third persons, whether Guests, travelers, guests or persons outside the cruises.

#### **Article XVIII - Final**

The Anubi Cruise Project, in the abbreviated name Anubi Project, shall, under the cruise sharing regime, comply with the conditions agreed in the agreement in compliance with the directives set out in this Statute. It is committed to offering a period of leisure and carefree to the people who participate in the cruises, helping them to escape the negative factors present in the frenzy of the working life and the

daily stress factors. Anubi Cruise Project, also wants to help its Guests rediscover the beauty of life and marine nature, without the need to use electronic devices such as mobile phones, computers, video games, social media, with the aim of helping their guests understand that the electronic tools used daily are an aid and not an indispensable purpose of life.

Everyone wants to bring their own freedoms and habits, they find on board a common point that is "compromise" which increases common respect. Everyone on board must feel and make others feel welcome. Stress will never find space on board, since the holds are already occupied by serenity, cheerfulness, carefulness and good food that await only you!
