- 4. Authors are encouraged to use **Mendeley** or **Endnotes** application for citation and referencing.
- 5. The author cites a minimum of 20 reference sources from reputable international journals.
- 6. Manuscript **must follow Eko-Regional's template of manuscript**. Template for authors can be downloaded on Eko-Regional website.

#### STRUCTURE OF ARTICLE

- 1. Title. Title is written in English and should consist of no more than 12 words.
- 2. Name of Author(s), Institution, and Email. Name of author(s) must not include academic degree. Corresponding author must state his / her email.
- Abstract and Keywords. Abstract is written preferably from 100 to 150 words and needs to be written in English and Bahasa. Abstract should provide summary of article purpose, methods, results, and conclusions. Abstract should also be followed by keywords of 3 to 5 words.
- 4. Introduction. Provides explanation of research background, purpose, and contribution.
- 5. Methods. Provide completely the methods used, data sources, data type, data collection method, and data analysis techniques.
- 6. Results and Discussions. Present results of data analysis, hypothesis testing, answer of research question, as well as findings and its interpretation.
- 7. **Conclusions**. Describe the research **conclusions**, **limitations**, and **suggestions** conducting future research.
- 8. **References**. Authors are encouraged to use reference manager **Mendeley** or **EndNote** for citation and referencing. References used are from the last **10 years** with the proportion of ≥ **80%** for **scientific journals**. The list of references is sorted **alphabetically with no numbering**.




Figure 1. Growth of Foreign Direct Investment in 2008-2017 Source: Statistics Indonesia, 2012
