AN ORDINANCE TO LEVY AND ASSESS A TAX
FOR LEWISTOWN CARNEGIE PUBLIC LIBRARY DISTRICT OF THE
COUNTY OF FULTON, STATE OF ILLINOIS FOR THE
FISCAL YEAR BEGINNING JULY 1, 2023 AND ENDING JUNE 30, 2024

BE IT ORDAINED, that the Lewistown Carnegie Public Library District of the County of Fulton and State of Illinois shall levy a tax of .02% of the value of all taxable property within said District, for building and maintenance purposes, subject to the right of the electors in said District to petition and require an election concerning the imposition of such additional tax, pursuant to 75 ILCS 16/35-5.

BE IT FURTHER ORDAINED, that within fifteen (15) days from the date of adoption of the resolution, it shall be published in a newspaper of general circulation in the Lewistown Carnegie Public Library District.

This Ordinance shall take effect immediately upon its passage.
