## **Civic Engagement Experiences**

As part of the mandated Civics graduation requirement for the state of Illinois, students must complete civic engagement experiences. Some of us do this regularly with our families, clubs, friends or religious groups, but others of us have not had this experience. One of the most powerful things a person can do is step outside of his/her comfort zone and engage with others politically. It teaches us about the greater world and about ourselves.

Here is some background on what the Illinois State Bill requires for high school Civics courses:

The civic engagement experience should include one or more of the following:

- Focus intentionally on civic outcomes and encourages civic commitment where students conduct research and analyze data related to their service;
- Foster increased student knowledge of the community;
- Prepare students for service in the community, including an understanding of the service sites, populations, and their individual responsibilities;
- Engage participants in meaningful and personally-relevant service activities that are available to all students regardless of academic skill or ability;
- Promote understanding of diversity and mutual respect among all participants; and
- Provide youth with a strong voice in planning, implementing, and evaluating service learning experiences with guidance from adults

Some of the criteria we at DHS have come up with for our courses includes the following.

- Students may not receive any credit or pay for these experiences (Exception for election judges).
- Civic engagement required by another class or mandated by the courts cannot count.
- Civic engagement should require interaction with community members, as opposed to simply
  completing or filing paperwork, and if a service activity should also be completed with and
  verified by non-family members.
- We will not approve civic engagement for any organization which does not open its membership
  to the general public, or which discriminates in any way on the basis of ethnicity, race, religion,
  age, gender, sexual orientation, national origin, or disability.
- Your civic engagement experience may not be completed during the school day; we do not approve or encourage you to miss school for this experience.

A list of possible opportunities follows. In general, civic engagement opportunities might include:

- Volunteering for political campaign
  - Any generally recognized political party or independent candidate
- Attending a protest march or rally
- Attending a School Board Meeting
- Working with any state, local, federal or regional governmental agency
- Lobbying (in person, via phone, social media, etc.)
- Attending a court proceeding

**IMPORTANT:** The first activity and its write up must be completed and submitted to turnitin by Friday, December 5. As soon as you decide what experience you are going to attend, *you must fill out this form describing what you plan to do and when.* While you may attend an experience with another student, all written work must be your own!

## **ASSIGNMENT**

For each experience, you must do some work before, during, and after the experience.

**Before:** Why are you choosing this experience? To answer this question fully, you should address the following in your pre-experience writing:

- 1. Why are you interested in this particular experience?
- 2. What are you hoping to achieve through this experience?
- 3. What questions or concerns do you have prior to this experience?

This should be at least 2-3 paragraphs in length.

**During:** What's happening?

- 1. You MUST attend your civic engagement experience in person (no "virtual" experiences). Take pictures of yourself at your experience! You must be in the pictures!! You will submit your pictures with your final write-up.
- 2. Take detailed notes about the experience. Please take detailed notes! Imagine you are taking notes for someone who isn't there. You will submit your notes with your final write-up.

After: What happened?

- 1. Write a detailed description of your experience.
  - a. What kinds of things did you do while you participated? Include specific examples.
  - b. Write about some of the people who were present and what they did (staff, other volunteers, observers, etc.). Use specific details and examples.
- 2. Discuss what you learned about citizenship and civic responsibility as it relates to your experience.
  - a. What issues were addressed?
  - b. How did you make a difference in your community through your work?
- 3. Explain how this experience might relate to issues studied in class, current events or other connection. For example:
  - a. What political or public policy issues did you encounter during your experience? Explain.
  - b. What connections to class curriculum were evident? If none, consider what other connections you can make Explain.
- 4. How did this experience impact you personally? Be specific and thorough in your response.

This should be at least 3-4 paragraphs in length.
