## Police District 3 Update

Presented by: Not available this month but sent notes below Not available: Officer Antonio Pacheco and Community Resource Officer Kate Young

Crime map information:

- Kate Young Provided these notes for our LBCRNO.
  - Trends we are seeing (We focus on "preventable" crimes for the purpose of the meetings)
    - Valuables being left in cars both locked and unlocked
    - Valuables to include actual valuables (cash, electronics, wallets, purses) and perceived valuables (empty bags/purses).
    - Garage door openers both for residential and apt/condo complexes being stolen from cars-the garages are then accessed by the opener and items are being stolen (mainly bicycles).
    - License plates being stolen (front and rear)-typically they are stealing the plate to then put on a stolen car of a similar description. FREE anti-theft license plate screws available at both the Cop Shop (487 S Broadway by Pep-boys: they have varying hours), and the District 3 station (1625 S University Blvd). License plate screws do not work with Volvo, BMW/Mini, or Tesla unfortunately.

- Catalytic Converters
  - Minimal thefts in this area but are still a problem city and state-wide. DPD has been teaming up with Lincoln Tech for engraving events (engrave the last 5 of your VIN and spray with heat-proof paint). Events are limited and are posted on Nextdoor-keep an eye out!
- Bikes being consistently targeted.
  - Register bikes at denvergov.org/police-there is a Register your bicycle link under "Quick links" about halfway down the page.
  - We recover a lot of bikes, if a stolen bike is reported without a serial number it is hard to reconnect that bike with their owner.
  - Also recommended to take a "selfie" with your bike, then flip your bike over and take a picture of the serial number-shows proof of ownership and you have your serial number in the worst-case scenario of it being stolen.
  - Move away from cable locks. They are completely ineffective-most bikes we are seeing stolen are either not locked up or are locked with a cable lock.
- Free anti-theft steering wheel clubs available for people
  with a car in the "top 10 stolen car" list (example older
  subarus/Hondas/Toyotas, also includes multiple years of
  Ford pick up trucks)-email <a href="mailto:kate.young@denvergov.org">kate.young@denvergov.org</a> or

- Homeless outreach-Homeless encampment complaints should be called into 311-They are then routed to the Early Intervention Team and the up and coming Enforcement Team. Any illegal or unsafe activity associated with the camp (disturbances, fights, narcotics, etc) should still be called into either the non-emergency number or 911.
- Monthly Neighborhood Watch Trainings-email CROS for more info
- District 3 CAB meeting next one is slated to be in person unless something changes. Will be on 9/14 at 6pm at the D3 station. Meeting consists of the commander and sector lieutenants giving an in depth update on district specific news and crime trends. Guest speaker for this CAB with be a District Attorney.

## Other topics discussed:

### Representative from Broadway Merchant Association

Presented by: Luke Johnson, BMA President (<u>LPJ@lukeandco.com</u>) 303-859-0491 (owner Luke's Pet Food store)

- Luke took over leadership and has worked to increase presence and branding. Restarted Broadway Merchants Association as a 501(c)
  - o Boundaries focused: Alameda to 6th along Broadway
- What does the Broadway Merchants Association (BMA) do?
  - One of our most important goals is to continue to be a communication vehicle between the businesses on Broadway and city officials/entities.
    - a. This also means we advocate on behalf of businesses (especially when there is an opportunity to voice an opinion)

- b. Broadway has very few national businesses and chains, this means each of our businesses have less power if we are not collective with our voices.
- c. BMA represents over 75 businesses and an estimated gross sales in excess of \$150m annually.
- Our meetings create an opportunity for our Merchants to interface with city officials as well as surrounding RNO's.
- We create and coordinate initiatives that benefit the businesses on Broadway. Historically this has included businesses a few blocks off Broadway as well.
  - a. Some of the initiatives we are working on now include:
    - i. Coordinating the City of Denver's mobile restrooms to be placed on Broadway
    - ii. Coordinating with the City of Denver and Xcel energy to get light pole banners placed on pole up and down Broadway
    - iii. Creating a "toolkit" and resources guide for business owners to understand their options and rights regarding homeless encampments.
    - iv. Actively working through the proper political avenues to solve or aid the homeless encampment problem in Denver.
       This is our biggest concern right now.
    - v. Evaluating the long term goals of the Association which may include converting the Broadway corridor into a Business Improvement District (BID).
- Other projects and initiatives we have worked on in the past:
  - a. Clean sidewalks initiative, 2020. BMA supplied cleaner and deodorizer to businesses up and down the corridor to combat homeless smells and encampment trash. We coordinated with the Local Maintenance District to power wash sidewalks and businesses who were especially hit hard.
  - b. Creating a forum for discussion on the Bike
     Lane implementation. 2018-2020

- c. Annual Broadway Halloween Parade
- d. Actively participating in zoning/rezoning issues on the corridor (always on-going)
- e. Keeping track of liquor license and other permit applications that effect businesses on the corridor. (always on-going)
- f. Advocating on behalf of the interests of businesses during development (Channel 7 building for example).

### Objectives

- Vehicle for communication between merchants and Denver City government
- Advocate for the businesses since all small businesses
- Work with BHNA and LBCRNO

#### Current focuses

- o Get mobile restrooms somewhere along the corridor
- Help with the homeless situation including coordination with other non-profits helping homeless people
- o Banners on light poles
- o Clean sideways initiatives / maintenance district
- o Broadway Halloween parade
- Some discussion around confusion about a BMA meeting August 17th and general desire for both LBCRNO and BMA to work together where we can
- Amanda went over our history and how we wanted to engage and help the residential, transportation and safety along the corridor
