Thank you for commissioning me for your next artwork! These are my terms of service to understand where my art can be used! These terms only work with art that is commissioned from me, Aimee Johnson, aka Luna Lace. Please read these terms before commissioning me for any artwork at all!

- 1. Commercial Use and Crediting** - My art may be used for commercial use for business promotion and for other things such as books and other media. If the artwork is commissioned for this use, I will require credit back to my art names, [Luna Lace Co.](#), [Luna Lace](#), and [SimplyLaLuna](#). **I do not desire extra royalty for the use of my art.** I do want to have my artwork credited back to me so I can still receive recognition for my work. If you want to give me a royalty to my art, please email me at lunvdolly@gmail.com, to discuss further business.
- 2. Payments and Process** - Art that has been commissioned must be paid half of the cost in order to begin work on it. I will provide sketches and *works in progress*, as I work on your art, to prevent current issues with Artificial Intelligence stealing art. When the artwork is finished, a sample with a watermark will be sent and will not be released in full until the payments are complete. Failure to complete a payment will put you on a **blacklist**. All samples and *works in progress* will be posted in Google Drive and have a **year expiration date** before deletion to make room for other commissioners and clients. All images will be sent to an email as well, I will have base files saved and sent as well.
- 3. Rights of the Artist** - Please refrain from uploading any of my work to any Artificial Intelligence program or website. If this happens, I will be filing a DMCA against those who uploaded the file and the site itself. These sites and apps are currently on my blacklist: DALL-E 2, Jasper Art AI, Lensa AI,

Dream by Wombo, NightCafe AI, Stable Diffusion AI, Midjourney, Fotor, Deep Dream Generator, Artbreeder, Runway ML, MyHeritage AI Time Machine, Dawn AI, Reface App. Because of these apps and programs, art will be kept to a minimum release to prevent them from stealing my work. I, the artist, also keep track of what platforms the art is uploaded to, if it is on a site that is not on this list, a DMCA will be filed.

- 4. Finished Artwork and Promotion** - When the artwork is finished, the client will receive a Google Drive link, an Email, and a shoutout on my social platforms. If the client does not want to be mentioned on social platforms, please inform me before I am allowed to post. I will ask the client if they want their work posted online, but I will also keep it behind paywalls on Patreon and Subscribe Star to help boost my clientele. Watermarked art will be used on social platforms to prevent theft while the original will be available on the provided links, Patreon, and Subscribe Star.
