

ASTRA 2024 MARKETPLACE & ACADEMY PARENTAL WAIVER AND CONSENT FORM

I, _____, an attendee at the ASTRA 2024 Marketplace & Academy (“the Conference”) held at the America's Center Convention Complex, June 2-5, 2024, intend to go on the Marketplace exhibit floor (“the exhibit floor”) to visit exhibitors’ booths, and I wish to bring my minor child/children on the show floor with me. As a condition of being authorized to bring my minor child/children on the show floor, I agree to follow the rules of ASTRA and to execute this **PARENTAL WAIVER AND CONSENT** on behalf of myself and my minor child/children. I understand this Agreement is binding upon me, my family and my child/children.

Children under the age of 18 will not be allowed in the Exhibit Hall during installation and dismantling of exhibits.

1. I agree that my minor child/children shall remain with me and be under my personal control at all times while we are on the show floor. This is necessary for their safety, the safety of others on the show floor, and to avoid interference with the business purposes and proper business conduct of the ASTRA Marketplace event.

2. If strollers are necessary they must be kept in the main aisles and are not allowed inside booths for the same reasons as noted above

3. I agree that I and my child/children will not interfere with or disrupt the activities of exhibitors and other Marketplace attendees.

4. I understand that a breach of these rules may result in my being asked to leave the show floor, with or without right of reentry, at the option of ASTRA.

5. I agree to be personally and financially responsible for any loss or damage to the person or property of others on the show floor caused by the activities of my child/children while on the show floor.

6. I am fully aware that possible physical injury might occur to me or to my child/children as a result of our attending the Marketplace on the show floor, and I agree to assume the full risk, including risk which is not specifically foreseeable, of any injuries, including death, damages or loss regardless of severity, which I or my child/children may sustain as a result of participating in any and all activities connected with or associated with their presence on the show floor.

7. In consideration of the right to attend the Marketplace, I hereby waive any and all rights or claims I or my child/children may have as a result of attending the Marketplace against ASTRA, the America's Center Convention Complex, exhibitors on the show floor, and their respective directors, officers, employees, members, staff, and all individuals assisting in conducting activities on the show floor, and hereby release and discharge them from any and all claims resulting from injuries, including death, damages or loss, which may accrue to me, my child/children, my family or my heirs arising out of or in any way connected with our attending the Marketplace.

I further agree to indemnify, defend, and hold harmless ASTRA, the America's Center Convention Complex, exhibitors on the show floor, their respective directors, officers, employees, members, staff, and all individuals assisting in conducting activities on the show floor, from any and all claims resulting from injuries, including death, damages, or loss, which may accrue to me or my child/children, my family or my heirs arising out of or in any way connected with our attending the Marketplace.
