WHEREAS, his leadership has been marked by humor, joy, and generosity, and has consistently embodied the values of stewardship and service central to the Foundation’s mission; and until his passing on September 6, 2025, he will leave a lasting legacy of faithful governance, mission-driven leadership, and deep devotion to the work of the Foundation; and

WHEREAS, the Board wishes to honor Darrell’s service, contributions, and lasting impact through the designation of Emeritus Board Member (Posthumous);

NOW THEREFORE, BE IT RESOLVED, that the Board of Directors and staff of Faith Foundation Northwest do hereby recognize and commend Darrell Lowe for his distinguished and faithful service to the Foundation; and

BE IT FURTHER RESOLVED, that Darrell is hereby named an ***Emeritus Member (Posthumous)*** of the Board of Directors of Faith Foundation Northwest, with all the rights, honors, and privileges associated with this designation; and
