What Is Poland Temporary Residence Card (Karta Pobytu)

Poland issues a Temporary Residence Card to non-EU nationals who plan to live legally in the country for longer than 90 days. This permit allows you to work, study, run a business, or live with your family under full legal protection.

Once approved, your TRC gives you legal status in Poland and visa-free access across the Schengen Zone.

Who Needs a Poland TRC

You need a TRC if you plan to:

- Work in Poland under an employment contract
- Operate or invest in a Polish business
- Study at a Polish school or university
- Reunite with a legally resident spouse or parent

Note: Without the card, you lose the right to remain past the initial visa or visa-free window. Border authorities track overstays closely.

Step-by-Step Process

1. Case Screening and Purpose of Stay Review

We evaluate your case: employment, business, study, or family and choose the correct legal track.

2. Document Preparation

3. Legal Translation and Notarization

Every required document is translated into Polish by certified professionals and legalized where required.

4. Application Submission at Local Immigration Office

We book and attend the appointment with you, presenting your case directly to authorities.

5. Fingerprinting and Biometric Data

Required biometric data is collected during submission. We prep you beforehand and attend the session with you.

6. Case Monitoring

We follow your application status with the Voivodeship Office. You get full updates.

Once approved, we collect the TRC or guide you through personal collection. Final registration steps are handled by us.

a. How long does it take to get the TRC?
