Manuscript writing is in English correctly. The length of the manuscript pages a maximum of 18 pages, A4 paper size, typed in 1.5 spaced, Word 2003 and above. The manuscript is written in Palatino Linotype, Font size 12, top margin 3 cm, bottom 3 cm, right 2.5 cm, and left 3 cm. The sentence in the beginning of each paragraph follows the text boundaries, so it does not indented to the right. The introduction contains discussed problem or topic based on previous studies' results that are relevant and up to date with existing theories. After the theories are explained, the writer raises a gap at the end of the description. Based on the gap, a novelty will appear from the article. Theories from this background must originate from a minimum of 8 articles from old to the most recent one. For example an article entitled "Beliefs of junior high school teachers on learning process on mathematical problem solving", initially the author describes studies that examine beliefs ranging from understanding to the form of teacher beliefs in learning mathematics (8 articles). Due to the limitation of article discussing mathematical beliefs in learning about problem solving, the present article discusses teacher beliefs in learning about mathematical problem solving.




Figure 1. Picture resource wikipedia.com
