(Savannah) Georgia Department of Labor suspends in-person unemployment filing requirements In response to the recent development of COVID-19, the Georgia Department of Labor (GDOL) is temporarily suspending in-person requirements for services provided by the agency, the department announced Monday, March 16.

In accordance with Gov. Brian Kemp's recommendation, the GDOL is providing online access to unemployment services, partial claim access for employers, and resources for other reemployment assistance. Without having to visit a local career center, resources can be found on the agency's homepage at gdol.ga.gov.

If a claimant does not have access to the internet, the GDOL is providing assistance for filing a claim by phone by contacting their local career center.

To file a claim via phone, claimants will need to expect lengthy wait times due to the time it takes to properly process the filing of a claim.
