# **Going Through the Customs**

When a traveller crossed the border he goes through the customs. Every country has its own customs regulations, according to which some articles (items) are liable to duty and some are duty-free. A list of articles, which are not allowed to be brought in or taken out of a country, is called a prohibited articles list. An official paper, which gives permission to take prohibited items, is called an import or export license.

If a traveller has an item, which comes under a prohibited articles list, he must declare it. It means that he names the item, states its value and other data.

The declaration is made either orally or in a written form. As a rule personal things are duty-free.

Sometimes a passenger's luggage is carefully gone through to prevent smuggling. Only after one's luggage is carefully cleared by the customs (gone through the customs) one can say that his journey is going to an end (or beginning).
