#### the tattoo mentorship program

From a very young age, artist Taryn Elise had a goal: to never work a day in her life... well, to never dislike working a day in her life. Having dedicated most of her adolescence and schooling to this goal, she spent many years pursuing the artistic career she always wanted. After years of seeking creative jobs, freelance opportunities, volunteer activities, and ultimately anything she could do creatively, she was accepted to The Pratt Institute of Brooklyn, NY.

After several years assuming that a quality degree would put her on the path to success, it became clear that college was not the right fit for her. Feeling very lost, she found herself gravitating to some of the more practical areas of art. Art history and museum studies had been appealing; even teaching was an interest... Finally, one day, everything changed. Having always been intrigued by the tattoo industry and community, she had been slowly collecting tattoos at any opportunity. Somehow, she had never considered it professionally. Long story short, she went to get a tattoo and left with an apprenticeship (and the tattoo)!

It was like the whole world fell into place... And as she says, tattooing found her.

After what ended up being a very short and incomplete apprenticeship, Taryn found herself in several transient opportunities; different tattoo shops, traveling to various tattoo conventions... Taryn sought every opportunity to hone her skills and build her clientele. Yet, never having truly received the apprenticeship that every aspiring tattooist should have, her self-taught journey, while exciting and rewarding, was long and challenging. Perspectively, this was also over fifteen years ago, and the tattoo industry was not what it is today. Tattooing, as it should be, was a coveted practice, and a difficult industry to gain footing in - especially for a woman.

In 2018, years of dedication and experience finally paid off. She opened her first brick & mortar establishment, a tattoo inclusive art collective with best friend and custom clothing designer, Jackii Ramis, in Rockaway Beach, NY: The Studio Phantasmagoria. While successful, the Covid Pandemic of 2020 posed many new challenges and obstacles, and Taryn sought new opportunities. Flash forward to 2023 - Taryn is now an award-winning industry veteran, and the proud owner of her third tattoo establishment, Obscura, in her hometown of Long Beach, NY. Obscura is the studio of Taryn's dreams, and she works alongside the team of her dreams as well: her body piercer and wife, Brittany Block, five year graduated apprentice Amanda Leigh, and current apprentice Lilly Marinelli.

#### Now that you know the past, you can understand the present...

Hi! My name is Taryn Elise, and I am the proud owner of Tattoos by Taryn Elise Inc. and Obscura - Art, Tattoo + Body Mod. Studio. I have dedicated my life to building my craft, my business, and my future. As mentioned, I always had an interest in teaching. I always knew that it would become a piece of my journey. When I took Amanda as my first serious apprentice in 2018, it became even clearer. I wanted to give her the apprenticeship that I never had; I wanted her to learn the art of tattooing in a positive, encouraging, open-minded environment. And that is just what I did. Amanda is now a highly skilled and accomplished tattooer, a feat she achieved in a fraction of the time it took me. Proud is not even the word! The joy I have received watching her learn and excel, and to teach her everything I know, compares to nothing. Adding my newest apprentice, Lilly, to the team made those feelings even

Apprenticeships come in all shapes and sizes, some better than others... varying shops, personalities, and expectations for both mentor and apprentice. Amanda's interest in the industry had been met with many similar experiences as my own so many years earlier: limited opportunities, bad attitudes, egocentric entitled personalities, and ultimately, extreme difficulty. It is discouraging how difficult it can be to break into the tattoo industry, like so many creative industries. Thankfully, things are much different now than they were years ago, but many archaic constructs do still exist, and opportunities are still limited. In some ways things are better, in some ways they are worse. What I know is this: if you want to learn, even to try, opportunities should be available in a non-judgmental, safe, friendly, informative, inclusive and professional environment.

And with this in mind, the Tattoo Mentorship Program was born.

#### the tattoo mentorship program

Does my story, or Amanda's, sound familiar to you? Have you been trying to learn how to tattoo for what feels like forever? Shops have turned you down, online programs with no hands on experience, books and youtube videos, online forums and empty promises? Well then, this is your golden opportunity. Welcome to The Tattoo Mentorship Program. A two part, five week (sixteen day) intensive program to get you the start you need and deserve.

While much of the industry, particularly those who have been around for a long time, frown upon 'tattoo schools' and 'paid apprenticeships', it would be wrong to ignore the direction of today's tattoo world. Establishments and courses are popping up everywhere, ranging in cost, length, and overall quality. As a tattooist who had quite the unique journey, I feel as if it's not only my desire, but my responsibility to share my knowledge. I have had a growing desire to create an ideal learning environment for as many willing and interested students as I can. Wanting to learn a trade and receive proper education for that trade is as old a practice as any - why should tattooing be different?

While in a perfect world I would offer every attendee the opportunity to do a 'full length' apprenticeship, it just simply wouldn't be realistic. It would be impossible to teach you everything within just five weeks, but it was just that thought that brought me to founding The Tattoo Mentorship Program. I want to teach everyone! I truly believe that I have created a wonderful, all inclusive, thorough program... Having designed a curriculum that will provide any willing student with the necessary opportunities to gain a well rounded intensive introduction to the tattoo industry. I also found myself lucky enough to have the perfect space to offer such a program that is spacious, comfortable, and inviting.

It is important to note that The TMP is not a school. The Tattoo Mentorship Program is a hyper focused, specialized, mentored course. The program will start attendees off with a classroom-like experience: an all encompassing breakdown including everything from proper sterile procedure and safety skills, various tattoo equipment and supplies, art theory and drawing workshops, portfolio development, tattoo history and styles, industry and studio do's and don'ts, social media management and even photography skills to better help promote their work. This will include a curated series of interactive workshops, industry based study sessions or seminars, and daily homework assignments to help reinforce and retain each class day.

Operating within a six month window, the first part of the program is a three week (nine day) prerequisite course. This portion of The TMP lays the foundation needed to become a licensed tattooer by our local Nassau County Department of Health (NCDOH). Attendees will take the Health Departments Bloodborne Pathogens exam and obtain OSHA BBP certification, a necessary requirement to physically tattoo individuals and complete the course. This leads directly into part two of the program, a two week (six day) hands-on tattoo apprenticeship, hosted by me within Obscura's studio. During part two you will have the physical experience of tattooing willing clients! You will leave the TMP with a portfolio of artwork and real completed tattoos on actual clients, beautifully photographed and ready to promote! Students will tattoo one-on-one with clients for full days, and have two separate 'walk-in days' at Obscura. I find it a vital experience for every tattooer to work with clients on a spontaneous basis, similar to that of a 'walk-in' tattoo shop. The 'walk-in days' will provide an opportunity to gain that experience. Students will even have the ability to make a profit from their work during the 'walk-in days'.

As if that wasn't enough... Once attendees have completed the full five week (15 day) program they will have six (6) months priority access to my extended Tattoo Mentorship Alumni Program! Obscura's door will always be open! If you're looking for post-program consulting, industry advice, portfolio development, or even a guest spot appearance at the studio, these options will be available to you! Think you might want to start your own studio? Trying to start doing conventions and taking your tattoos on the road? We can help! Maybe you'll have interest in honing your skills in a specified style or technique. We will offer a number of high focus workshops covering topics such as; cover-ups, portraits, custom lettering, geometric/ornamental and so much more. I look to provide a continuing education for all of your tattoo needs, creating a community for the new generation of tattooers and providing a clear cut, informative, and exciting path for those who are simply looking to do what I wanted to... never "work" a day in your life!

We look forward to sharing this experience with you and helping you find your path to the rich world that is the art of tattooing.
