In 2009, Alameda County School Health Services Coalition (SHS) and Alameda County Behavioral Health (BHCS) launched the School-Based Behavioral Health Initiative. The mission of this initiative is to strengthen and expand school-based behavioral health practice, finance, evaluation, and policy in Alameda County. SHS and BHCS work together to convene the partnership. Additional partners include Alameda County School Districts, Community Service Providers, Alameda County School-Based Health Centers, and University of California San Francisco Institute for Health Policy Studies.

The goals of the School-Based Behavioral Health initiative are to:
