Homework

On the ERM <u>implementers topics</u> wiki page there is a request to enhance the Supplementary Properties in Agreements. Agreement Supplementary Properties use the same underlying approach as the license Terms, so we can consider enhancements to the Supplementary Properties / Terms together (and if they need to work differently, we need to highlight where they should diverge).

Potential enhancements for the properties/terms include:

- 1. Ability to have multi-value pick lists for a single property/term
- 2. Ability to assign multiple values (with associated notes) to a property/term
- 3. The ability to use the same property/term multiple times on a single agreement/license
- 4. Support for property/term types for recording dates
- 5. Enhanced editor functions similar to the Notes Helper app (specifically hyperlinking)

Please consider and respond to the question below:

Does the ability to use the same property multiple times (number 3 above) differ from the ability to assign multiple values to a single property (number 2 above)? If so, what is the difference?
```

Jack (UMass): I think it depends on license terms versus supp. properties. An ILL term wouldn't need to be repeated if I could choose Fax Only & United States Only, but we currently have a "Resource URL" Supp Prop which I would prefer to repeat multiple times for the main URL, alt-URL for content on a previous platform, etc. than use the value field and then one of the notes fields. It depends on how the Supp prop. is configured and for what purpose it was created.

Felix (ZBW): For *license terms* it would be better to have the ability to assign multiple values to one license term. From a UI perspective I would prefer

That was seconded by two of my colleagues from the license department. It is considered easier and faster to record multiple values on one attribute. Assigning labels in Jira works similar. We don't have a use case for Agreements supp. properties where we use a reference value at the moment. When we want to store a URL on an agreement we use the "Supplementary documents" section. I agree that this would be cumbersome in cases like Jack describes where you want to have a lot of URLs recorded and make them searchable with the supp. properties query builder. For us it is sufficient to have them stored without any additional functions:

Emma (Cornell): I can't think of why we would need both, and I would prefer #2 (or #1). #3 it seems like we can essentially do that already if we give a term a new Name like authorizeduser and authorizeduser2. What I would prefer is more like a checkbox where I can use the authorized user term and then select staff and faculty and students for one, and staff / faculty / students / alumni for another, etc.
Where there is a request for "enhanced editor functions" (number 5 above), which fields (related to properties/terms) need to support these enhanced editor functions?
Jack (UMass): Same example as above, we're recording resource URLs in a supp. prop so it would be nice to be able to hyperlink them. Alternatively, since supp. properties drive filters there are some things we'd want a value for (like Authentication Method=Proxy/IP/etc.) but might still want the flexibility of the notes helper app to have ordered lists, etc.
Are there other fields in Agreements or Licenses that would also benefit from such enhanced editor functions?
Jack (UMass): I don't want to say all of thembut we're all using Agreements differently so it might end up being all of them. I can imagine wanting bullets or an ordered list in the description as opposed to a note. Right now UMass would really like them for Supp Properties because that's how

we're recording specific information that needs to be more structured than a note.

Felix (ZBW): We have no acute need but when those enhanced editor functions are introduced we'd think they could help in all the "description" fields: Agreements & Licenses general description at the top, Agreement line and period description.

Do you have additional requirements for properties/terms beyond the five listed above? If so, what are they?

Which would be your top two additional requirements for properties/terms based on the list above and any further requirements added in response to the previous question?

Jack (UMass): #1 and #3 (with 5 coming in extremely close - we're okay with the workaround of copy paste to a browser for hyperlinks for the short term if some other issues were addressed)

Jenna (Smith/Five Colleges): +1 to Jack's prioritization, including 5 coming in a very close 3rd.

Would you be happy to see the same enhancements for both agreement supplementary properties and license terms, or do you see the requirements diverging? If you see the need for divergence, please explain how you believe they should diverge.

Jack (UMass): I think support for all this in agreements would meet a need while making things in licenses more open for additional methods of recording data. The one which is super important for both is the multi-value pick lists, but editor functions may not be as important in licenses for example. Unless total new development happens in agreements to replace supp. properties I'd prefer that these things function the same way if they're the same asset type.

 - Agreement search Idea Purchase Order Line number in search and find all the agreements that have agreement lines linked to that Purchase Order line
 - Sara: More like a very direct known item search the POL is often really specific key over time packages names or collections name are changing POL/PO number is "hook" and very crucial for moving between difference system and different types of documents
 - Jessica (chat): I agree with Sarah. Being able to search agreements by PO number would be hugely helpful
 - Martina S.: You can search by POL number in orders app and there you should have the link to your agreement line
 - Link from within agreements
 - At the bottom of the POL details view there is the section/accordion Linked agreement lines. Click on the name in the table view then it takes me to the agreement
 - At the moment search by POL you can in the orders app and link through to the related agreement
 - Sara: If I am in agreements and want to dump my data, will that POL number be there?
 - No, not the human readable number, but the UUID reference for the POL the link to the UUID is stored
 - POL detailed view linked agreements only show up when you link is established
 - If we look at the agreement line and edit that, add a POL line I get the search for Order lines, provided by orders showing the search options that are provided by orders app
