Ms. Balas's Policy for Retakes and Revisions

Rationale:

At BHS, we educate with a goal of lasting understanding and skill mastery. We acknowledge that "Nobody knows ahead of time how long it will take anyone to learn anything." (Dr. Tae, TEDx presenter). We strive to meet the needs of all students to and to help students develop long-term understanding with the knowledge that content covered throughout the course will be assessed multiple times throughout the course. That being said, as teachers, we want to encourage students to take ownership of their education and develop the skills necessary to improve future performance *the first time* as well as the opportunity to recover and learn from mistakes. Recovering in full from a failure teaches more than being labeled for failure. To this effect, the following guidelines and procedures will be implemented at the teacher's discretion:

1. Tests may be retaken IF:

- **a.** The student requests a retake from the teacher. Teachers may set a threshold below which retakes will be required.
- **b.** Students develop a plan for revision (see revision page), re-learning, and reassessment which includes actions, dates, and deadlines. This plan must be approved by the teacher and signed by the student, teacher, and parent/guardian.
- c. The student schedules a time to review content gaps with the teacher and attends this meeting.
- **d.** The student makes detailed corrections to the original assessment.
- e. The retake-test will NOT be the same as the original test (it may vary in question design, length, and format) but will address the same topics, content standards, and skills.

2. Essays/writing assignments may be revised in accordance with the following requirements:

- **a.** Students develop a plan for revision (see revision page), which includes actions, dates, and deadlines. This plan must be approved by the teacher and signed by the student and teacher.
- **b.** Students must handwrite directly onto the original essay what revisions they will make for the revised copy. This includes more than just correcting grammatical mistakes and typos.
- c. The student schedules a time to review content gaps with the teacher and attends this meeting.
- **d.** The entire writing process *(original, revisions, outline (if applicable), and rubric)* must be submitted by the agreed upon deadline. The deadline will be determined by the student and teacher.
- e. If the teacher finds more than 4 major grammatical errors (including capitalization, spelling/homonym errors, awkward word order etc.) on the original copy, the student is REQUIRED to revise.
