The abstract must effectively summarise the essence of the research by including four essential components: the purpose, which explains the research problem, objective, and the originality of the study; the methodology, which briefly outlines the approach or techniques used; the findings, which highlight the key empirical results; and the originality or value, which states the practical or theoretical implications of the study.

Authors then review recent and relevant literature, preferably citing academic works published within the last ten years that directly relate to the article's subject matter. Through this review, authors identify existing research gaps, unresolved inconsistencies, or academic debates that justify the study. Authors subsequently articulate the research problem, define the objectives, explain the contextual background, and specify the unit of analysis used in the study. To enhance the clarity and flow of the manuscript, authors conclude the introduction with a concise overview of the article's overall structure. Throughout the writing, authors must apply formal academic British English, as required for publication in the Proceedings of Lemhannas RI.

2. Literature Review

This section must be written using **Arial font size 12** and **presented in formal academic British English**. Authors are expected to deliver a comprehensive and well-structured discussion encompassing both theoretical and empirical studies that support the research. The literature review must reflect a logical and critical progression of academic understanding that is relevant to the topic of the article and aligns **with the scope of the Jakarta Geopolitical Forum**.

Theoretical Studies

Authors begin by providing an in-depth analysis of the theoretical foundations that inform the research. This includes explaining the key concepts, analytical frameworks, or theoretical models employed to address the research questions. Authors must identify the Grand Theory as the principal foundation and clarify how it integrates with other supporting theories to build a coherent conceptual framework. The theoretical basis should correspond with either qualitative or quantitative methodological approaches, depending on the nature of the research.

Empirical Studies

Following the theoretical explanation, authors continue by reviewing previous empirical studies that are relevant to the research topic. This review should highlight important findings, methodological approaches, and unresolved gaps in the existing literature. In qualitative research, the emphasis should be on understanding socio-cultural or political contexts, while quantitative research should prioritise statistical data, variable relationships, and numerical interpretations. Furthermore, authors are required to develop the research hypothesis in this section, demonstrating its connection to both the theoretical arguments and the empirical evidence cited.

All tables and figures within the literature review must be numbered sequentially and clearly referenced in the narrative. Each element must support the discussion and be accompanied by its source.




Figure 1. Risk Mapping Framework Source: Author (2025)

3. Methods

This section, written in **Arial font size 12** and **formal academic British English**, must describe in detail how the research was conducted to demonstrate its methodological rigour. Authors should explain the research approach, procedures undertaken, instruments or tools used, and the techniques applied for data collection and analysis. It is essential to include the research design, characteristics of the population or sample, and any materials that supported the study. For qualitative inquiries, including case-based investigations or action-oriented studies, authors are expected to describe the

researcher's involvement, profile of the participants, sources of information, and the methods used to gather and interpret the data. The narrative should also identify the research setting, duration, and the steps taken to ensure the credibility of the findings. All descriptions must be presented in well-structured paragraphs, without the use of bullet points or numbering, to maintain consistency with the format of the Proceedings of Lemhannas RI.

4. Results and Discussion

Authors must present findings clearly and concisely using Arial font size 12. Each result should include sufficient detail to support conclusions, and visual elements like tables or figures must not duplicate information from the text. Every table or figure requires a brief explanatory paragraph to aid reader comprehension. Authors must report the outcomes of analyses without describing the calculation processes. Tables and figures should be centred, numbered sequentially, titled appropriately, and cited in the narrative. Where relevant, tables may use two-column formatting to improve clarity.

In the discussion, authors should respond directly to the research objectives by interpreting the results using established theories and comparing them with previous studies. The explanation must highlight how findings were obtained, identify patterns or inconsistencies, and demonstrate their contribution to the advancement of knowledge. All arguments must rely on empirical reasoning and be supported by credible references from journals indexed in Scopus, Web of Science, Sinta, DOAJ, ProQuest, Dimensions, EBSCO, Copernicus, or Garuda Dikti.

5. Conclusion

Authors are required to present the conclusion in two structured paragraphs using **Arial font size 12**. The first paragraph must summarise the key research findings, aligning them directly with the objectives and research questions stated earlier in the article. If more than one conclusion is drawn, these should be presented as numbered items within the paragraph rather than in a bulleted list. The second paragraph should discuss the implications of the research findings, offering practical recommendations or directions for future studies, including potential applications in policy, academic research, or national development.

Acknowledgments

Authors must briefly acknowledge any individual, institution, or funding agency that contributed to the development or publication of the article but does not meet the criteria for authorship. The acknowledgments must be written in **Arial font, size 8,** and placed after the conclusion section. For example: "We would like to express our sincere gratitude to the XXXX of Indonesia for

providing funding through the 20XX Research Grant. We also extend our appreciation to the Lembaga Ketahanan Nasional Republik Indonesia, Jakarta, for their invaluable assistance during the various stages of this article's development."

References

The references must follow the Vancouver style, which uses numerical in-text citations enclosed in square brackets and arranges the reference list in the order of appearance in the manuscript. Authors must ensure that a minimum of 80% of the references originate from primary literature, including peer-reviewed national and international journal articles. To uphold the relevance and academic quality of the manuscript, sources published within the last ten years are strongly recommended. Authors should also refrain from including an excessive number of self-citations. The use of citation management tools including Mendeley, Zotero, or EndNote is highly recommended to ensure consistency in formatting and adherence to the required referencing style. The similarity index of the entire manuscript must not exceed 25%, as measured by Turnitin, iThenticate, or other recognised plagiarism detection tools of similar standard. All references cited must be listed in the bibliography, and uncited references must not be included. Authors are strongly encouraged to refer to Jurnal Lemhannas RI and other reputable journals focusing on national resilience, which are accessible online.
