Kuminga has a 15% trade bonus in his contract also.

How a trade bonus works: There are 174 days in the NBA season. Kuminga will earn \$129,310.34 per day. If Kuminga is traded on Jan. 15, he would have \$11,379,310.34 left on his contract. The trade bonus would be \$1.7 million (15% of \$11.37 million)

Seth Curry

Notes: Curry signed a one-year non-guaranteed contract. The contract contains an Exhibit 9 and protects Golden State if Curry is injured in training camp. They would owe him \$15K. Because this is a "summer contract" his salary does not count against the apron. Curry would start to count against the cap if he is not waived prior to 5pm on Oct. 18. If he is on the roster past that date, Golden State would need to waive either Gui Santos or Trayce Jackson-Davis. They are currently \$2 million below the second apron.

PHILADELPHIA 76ERS

Quentin Grimes

Notes: Grimes signed a one-year \$8.7 million Qualifying Offer. The offer was tendered to Grimes on June 29 and was set to expire on Oct. 1. Friday August 29 was the last date a team could waive and then stretch their salary for the 2025-26 season. The Mavericks used the provision when Olivier-Max Prosper was waived.

Before the waiver, Dallas was \$1.6 million below the second apron and had agreed to sign Dante Exum to a contract. Because they were hard capped, the Mavericks were forced to either trade Prosper or waiver and stretch his salary.

Here is the formula on the waive and stretch:

Step 1: Salary remaining (\$3,007,080) divided by 3 (1 year left on their contract multiplied by 2 plus 1)

Step 2: \$1,002,360 applied to the 2025-26, 2026-27 and 2027-28 season

Step 3: The team option in 2026-27 does not apply because the salary is non-guaranteed
