Allocation of Points – LEAD will be calculated as a percentage of cost increase as compared to the lowest cost proposal received. Each job title will be considered individually. For example, Bidder A submits a cost of \$30.00, and Bidder B submits a cost of \$32.00, and Bidder C submits a cost of \$34.00; Bidder A would receive 100% because Bidder A was the lowest. Bidder B would receive 94% (\$30/\$32) and Bidder C would receive 88% (\$30/\$34). The total points allocated will be determined by taking an average of the percentages.
